# AIA CITATION FOR EXCELLENCE IN COMMUNITY ARCHITECTURE

To reinforce and expand the "War on Community Ugliness" and the architectural profession's prestige in urban planning by awarding citations to those projects of civic development or redevelopment which successfully realize the objective of creating vital environments for the core of American cities. Proposals must be nominated by chapters to Director of the region; shall be screened by the Commission on Architectural Design; and shall be awarded by the AIA Board. Only projects which recognize the necessity for separation of human activities and the need for overall traffic planning to serve the project and its surroundings should be considered. No award of this type will be made to a single building. Hugh Stubbins, FAIA, has said: "The day has passed when any single building, no matter how fine it is, can be admired by itself. More important are urban groupings, and urban surroundings, and the urban responsibilities that these portend."

If members know of projects in this category that should be nominated contact the Chapter Office.
