Time Commitment of our Commissioner

Regular Monthly Meetings

## 36 hours/year

3 hrs per month x 12 months = 36 hours/year + travel time

#### Preparation for Monthly Meeting

- President 10 hrs (prep agenda, check email for items)
- Secretary 10 hrs (prepare minutes)
- Treasurer 5 10 hrs (include travel to get bank statement)
- Correspondence 5 10 hrs (includes travel to office, respond to calls, etc.)
- Computer Tech 5 -10 hrs (update website, deal with problems)
- PR 10 hrs (issue press release of VCCW meeting)
- Greeting Card 5 hrs (get cards, keep Birthday list)

#### Prep Time for all members

- Read minutes 1 hr mo
- Recommend agenda items 1 hr mo
- · Read papers I hr day
- Listen to BofS wkly 5 hrs wk
- Attend other organizations' meetings representing VCCW
- · Research, Study, Prepare reports

## Preparation Time for Other Meetings

- Annual ethics mtg/Brown act 2 hrs/year
- Attend committee meeting(s) time as needed
  - o Prepare
  - o Research
  - o Follow up
  - o Develop recommendation(s)
  - o Prepare reports for VCCW

### Team Building meetings

 Members may meet monthly having tea with a different commissioner to build understanding – agenda: background, interests, business, family, goals within VCCW

### Meeting with District Supervisor

Meet at least one time annually; may meet more often as required or as needed; (Estimated time: Prep 10 hrs, mtg time 30 min.)

- · Prepare presentation
- Report on status, progress, projects you are working on for VCCW and future plans
- Present VCCW recommendations and findings and explain, discuss, get input
- Prepare follow-up report for VCCW
