III. Public Comment

#### III. Public Comment, continued

Jeannette Scovill, President of the Tri-Valley Environmental Agency and President of the California Vegetarian Association was present to announce Earth Day 1991 on Sunday, April 21st from 11 a.m. to 5 p.m. at Cal Lutheran University in Thousand Oaks.

Maria Luisa Jimenez, Health Educator II with Clinicas del Camino Real Inc., which are bi-lingual clinics in Ventura County for the lower income population. Her aim is to be an Outreach of AIDS Education to the Hispanic Community.

IV. M/S/C Thomas, McVerry approved the minutes of the January 12, 1991 meeting.

## V. <u>Fiscal Report:</u>

M/S/C Breyman, McVerry approve that the Commission Staff Aide contact the Ventura County Auditor's Office to ascertain if the Commission for Women Trust Account is an interest bearing account. If not, ascertain what steps should be followed to place it in such status.

Subsidiary Ledger for the current month presented and placed on file in the office.

#### VI. Project Reports:

A. The Women's Coalition for Equity's monthly meeting took place 7:30 p.m., February 13, 1991 at Santa Barbara Savings and Loan in Camarillo at which time selection for the 1991 Women's History Project Awards was determined. Commissioners Breyman, Long, and Thomas were present.

Supervisor Erickson Kildee announced that the Ventura County Board of Supervisors will present a resolution designating the month of March, 1991, as "Women's History Month". This presentation will be set for 9 a.m., Tuesday, March 5, 1991 in the Hall of Administration/Board Room.

B. Stacey Mac Donald and Kathy Long will represent the VCCFW at the State Networking Conference, March 19, 20, 21, 1991 in Sacramento. An update report will be presented at the April CFW meeting.

- C. Commissioners Montgomery, Breyman, Mac Donald, Lawrason, and Thomas will work with Committee Chair Kathy Long to initiate the Local Appointments Coalition Meeting on February 28, 1991 from 7-9p.m. at the Ventura County Government Center to launch the Statewide Outreach Project. Supervisor Erickson Kildee will present local comments. All interested citizens are invited to attend.
- D. Health for Women and Children Committee Update: Committee members Chavez, Flock, Lewis, McVerry, and Thomas met January 29, 1991 at the El Concilio Office in Oxnard. The main issues being addressed are:
  - 1. The lack of health care to patients (primarily females and children) on Medi-Cal and families with no health care insurance.
  - 2. Some Satellite Health Care Centers are beginning to cut hours of treatment.

Committee members Thomas and McVerry attended the Ventura County Health Care Forum. February 5, 1991, from 7-9 p.m. at Ottavio's Banquet Center in Camarillo. State Representative Mr. Ringrose advised that no additional County funds are available at this time. The aim should be on searching out ways of accomplishing more with existing funds as well as identifying new funding resources. We also face the problem of availability along with accessibility to Medi-Cal health care in Ventura County.

- E. Women's Resource Center Committee Meeting Update:
  The committee met on January 24, 1991, 5 p.m. at the Acapulco
  Restaurant in Ventura. They discussed a share space with a
  pre-existing agency to begin a non profit legal clinic to become
  available to women in Ventura County. The next meeting will be
  February 26, 1991 at 5 p.m. at the Acapulco Restaurant in
  Ventura.
- F. The Commissioner Orientation Meeting is on the agenda for the Commission meeting on April 13, 1991 at Camarillo Airport. All Commissioners are asked to attend.

- G. District Outreach Meetings Community Outreach Meetings are tentatively scheduled for May 1991 at which time the respective Commissioners and their appointing Supervisors will discuss history of commission and current goals.
- H. Commission for Women Newsletter
  The newsletter will contain a group picture of all
  commissioners, a map of Ventura County specifying Districts and
  Supervisors, committees main issues, etc. The newsletter is
  tentatively scheduled for distribution in May 1991.
  Commissioners have requested a written estimate including prices
  of the "finished" newsletter along with necessary copies for
  mailing to be available at the March 1991 meeting.

M/S/C Lawrason, Thomas approve the \$75.00 fee for the renewal of the Commission's Bulk Mailing Permit.

- I. Family Law Forum The commission is seeking co-sponsorship for the 1991 Family Law Forum. A copy of the agenda of the 1990 forum will be handed out at the March 9, 1991 meeting.
- J. Survival Skills Day
  This is an annual event to be held in a public arena where
  vendor space is provided to share with the community. The
  special services available are along the lines of education,
  employment, etc. The commission sent a letter in November 1990
  to the Ventura County Professional Women's Network asking for
  their co-sponsorship at the 1991 Survival Skills Day. The
  commission is now working on establishing a committee for this
  event. Further action has been tabled until the March 9, 1991
  meeting.
- K. Network for Housing This report is scheduled for next month due to the excused absent of Commissioner Karen Flock.
- L. Commissioner Beverlee Mc Grath volunteered to temporarily monitor the East County Battered Women's Shelter until Supervisor Howard appoints additional commissioners to District 4.
