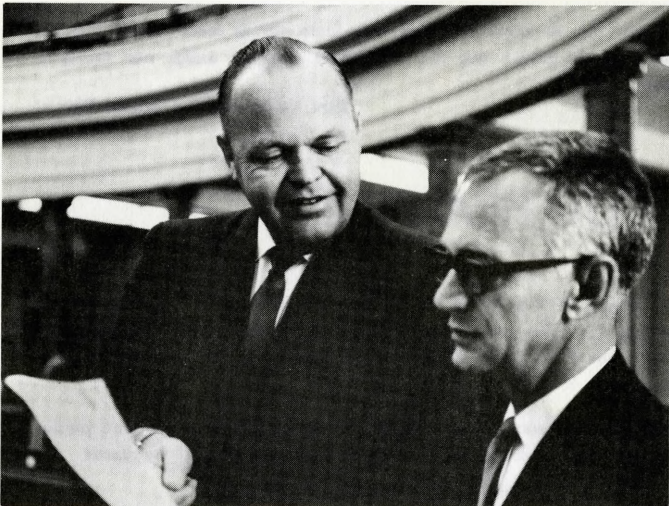
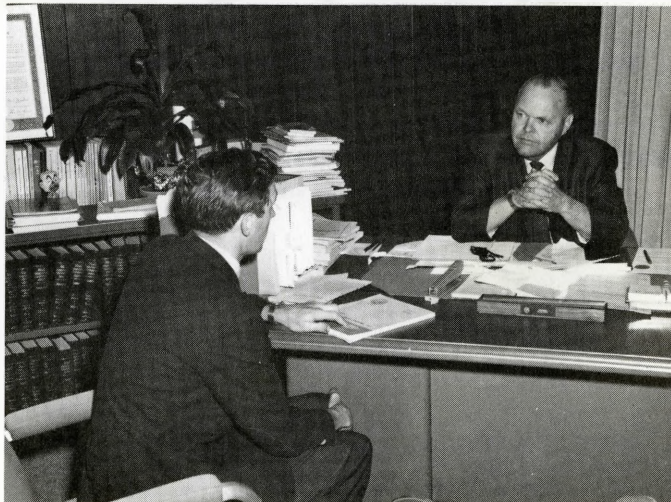




A new asset to Assemblyman Ken MacDonald is his wife, Leslie. Married recently after ten years as a widower, the MacDonalds are joint parents of six children.
