I have your inquiry relative to the territory embraced in the San Luis Obispo Elementary School District outside of the San Luis Obispo City limits. Our district extends toward two general directions, one toward Edna and the other toward Morro Bay. Going out about one mile on the South highway and then following a line due east for three miles, then north two miles and then west two miles back to the city limits would include a large part of the Orcutt Precinct. The territory on the other side includes a large part of Chorro Precinct and extends about three miles on the Cambria highway or about half way to the Hope School. This would include the territory around the California Polytechnic School and Stenner Creek.

Our district practically ends at the city limits on the North highway and the Laguna road and extends only a short dis-'tance out North Broad St.
