

determination date for purposes other than education at state-supported institutions of higher education. This exception applies only for the minimum time required for the student to obtain a California residence and maintain that residence for a year.

5. Certain credentialed, full-time employees of community college districts.
6. Full-time State University and Colleges employees and their children and spouses. This exception applies only for the minimum time required for the student to obtain California residence and maintain that residence for a year.
7. Certain exchange students.
8. Children of deceased public law enforcement or fire suppression employees, who were California residents, and who were killed in the course of law enforcement or fire suppression duties.
9. A person in continuous full-time attendance at an institution who had resident classification on the effective date of Statutes 1972, Chapter 1100 (AB 666) shall not lose such classification as a result of adoption of the uniform student residency law on which this catalog statement is based, until the attainment of the degree for which currently enrolled. (*Education Code* Section 22862)

It is anticipated at the time this is written that the new residence law will become effective in early March, 1973.

Students classified incorrectly as residents or incorrectly granted an exception from nonresident tuition are subject to reclassification as nonresidents and payment of nonresident tuition in arrears. Resident students who become nonresidents, and nonresident students qualifying for exceptions whose basis for so qualifying changes, must immediately notify the Office of Admissions and Records. Applications for a change in classification with respect to a previous term are not accepted.

The student is cautioned that this summation of rules regarding residency determination is by no means a complete explanation of their meaning. He should also note that changes may have been made in the rate of nonresident tuition, in the statutes, and in the regulations between the time this catalog is published and the relevant residence determination date.

## ENTRANCE EXAMINATIONS

All entering undergraduate students with fewer than sixty (60) units of credit accepted by CSUF are required to submit scores from the College Entrance Examination Board *Scholastic Aptitude Test* (SAT) or the American College Testing Program battery (ACT). The only exceptions to this requirement are foreign students from non-English speaking countries. Students transferring to CSUF who have more than sixty (60) units accepted by the university and who have scores on either of these tests should report them to the Admissions Office.

The Educational Testing Service and the American College Testing Program have established testing centers throughout the country where students may take these tests. Information about the tests and registration materials may be obtained from local high schools, colleges, and the Test Office at CSUF. Registration fees are as follows: SAT, \$6.50; ACT, \$6.50.

In order to allow time for the university to receive the test scores, students should arrange to take the test at least two months before enrolling. See *State Admission Procedures* and *Eligibility Index*.

**English Proficiency Test for Foreign Students:** The university requires that students whose native language is not English take the *Test of English as a Foreign Language (TOEFL)*, administered by the Educational Testing Service at testing centers throughout the world. An exception may be made for transfer students from American colleges and whose grades demonstrate full competency in English. TOEFL is an objective examination designed to indicate whether the foreign student's comprehension of and ability to use the English language is adequate for university work. Information on testing dates and cities where the test is given may be obtained by writing to Test of English as a Foreign Language, Educational Testing Service, Princeton, New Jersey 08540, USA. Students should arrange to take the test at least six months before enrolling in order to allow time for receipt and evaluation of test scores. Information and application materials are also available in the university Testing Center, in the Administration Building.

**Speech Test:** A speech proficiency test is required of transfer students who are candidates for teaching credentials. Students who fall below the proficiency level required of teachers will be expected to take *Communicative Disorders 76, Problems in Oral Expression*. See *School of Education—Admission to Credential Programs*.
