

## Aging plumbing puts LV in some hot water

Fourfold increase in water damage claims will trigger a rise in monthly fees unless homeowners take preventive measures.

Master policy claims show alarming cost increases as plumbing ages in Leisure Village. Slab leaks and other water damaging defects are now almost four times more than they were in 1996. This will result in an increase in monthly fees to the homeowners.

Most of the copper piping and valves in and beneath our homes have now exceeded their 20-year life rating, and replacing or repairing the damaged area is only a stopgap procedure.

Some of our homeowners, to avoid the trauma of sometimes finding themselves wading in hot or cold water and facing the resulting water damages, have bitten the bullet and had their units copper repiped overhead.

Copper repiping generally includes replacing everything

from the service entry to both hot and cold water-using appliances. Fees for such without upgrades (mixing valves and recirculating pumps) can run from \$1,500 to \$3,000 depending upon numbers of appliances and plumbing configuration.

Our administration placed in the Village Voice a few months ago an excellent article titled, "Let's Take Responsibility." It informed homeowners of steps to take to avoid water damaging equipment failures, along with the associated costs in our homes. It could also save some of the family heirlooms you have promised your children.

The foregoing article also had an offer of \$30 plus parts to inspect and repair all defective angle stops, shutoff valves and flex lines. Only an estimated 50 owners took advantage of this. What a shame!


## In defense of ILV

## An interview with Carolyn Pratt



I won this suit, but then Chair Pratt decided to appeal the judgment in Superior Court. My attorney's fee for defending this action came to \$1,500. I leave it to the reader to speculate how much attorney Lingl was paid from association funds. Lingl's argument, in effect, was: As this was a private community, with a freely elected board, the board could impose any regulation they wished provided it did not contravene the CC&Rs. The judge concurred with this argument and overturned the lower court's decision.

saying, "I have accused the board members of insulting behavior, am I not guilty of the same behavior toward them? Indeed I am; the difference is, in my case, it was intentional."

'm an author-journalist and take my oath seriously. Wanting to do something positive for the Village, I prepared a handbook about Leisure Village, describing board meetings, responsibilities of the association and homeowners, assessments, how to handle disasters, etc.

I offered the handbook for association use, free of charge. But the current board (minus Mr. Griswold) couldn't decide whether to approve it. Six weeks passed and I withdrew my offer. After that, Chair Pratt spent hundreds of dollars having Mr. Lingl write me twopage letters claiming ownership of my handbook. The handbook was not a works for hire; I wasn't paid to create it; the undertaking was not an assignment of mine, and it was not incidental to my position as a director. To stop the harassment, I had it copyrighted.

I sued Chair Pratt as an agent of Leisure Village. Although she was served with the complaint, she had the general manager sit with her for over three hours before the case was even heard, and then he spoke for her. Association counsel prepared a legal brief that the judge didn't even look at — all of this for a claim of

The judge ruled that ownership of the handbook was mine, but because I'd asked for board input, I couldn't recover for the board's defacement of it. Why waste thousands for a claim of \$126 and refuse free use of a valuable asset? Why announce this small claims case but hide dozens of lawsuits that cost homeowners thousands of dollars? Ask your board.

## Rules on disabled-parking placards

In order to ensure that all drivers are in compliance with the Vehicle Code. including handicapped drivers, these rules were issued and are meant protect the rights of the handicapped driver:

- You are the only person who can use the parking placard for parking or for service station use
- It is illegal to lend your placard to another person.
- It is illegal to use someone else's placard.
- · It is illegal to possess or display a counterfeit placard.
- It is illegal to provide false information to obtain a placard.

- It is illegal to alter a placard or a placard identification
- It is illegal to drive with the placard hanging from your rear-view mirror. Do not disregard the warning on your placard: "Remove from mirror before driving."

Placard abuse can result in the cancellation and revocation of the placard and loss of privileges it provides, and violators can be prosecuted to the full extent of the law. The fines are high to ensure compliance with thbe rules. Penalties range from \$70 to \$250 to \$1,000 depending on how many citations have been issued.

programs. As the Village ages and prices increase, it is a struggle to hold maintenance fees and ensure the property values and the type of place to spend retirement.

Another program the Board will be concerned with is the long-standing liberal practice by the Association of paying claims that should be the responsibility of the homeowner. With the fiscal year not

at an end, there is \$81,662.23 paid out in claims. The board has established an ad hoc executive committee to study the insurance liability and the need, if necessary, to change CC&Rs. Director Carol Sweeney will head this committee.

Another committee to study requests of some homeowners to investigate outside property management costs and levels of service needed in the Leisure Village type of environment will be chaired by Ed Hawthorne.

A pet project has been
