- B. Brochure: Commissioners discussed modifications to be made to the brochure. Commissioner Lawrence will incorporate them and email the revised brochure.
- C. 501(3)(c): Commissioner Lawrence has spoken with Community Partners and explained to the other Commissioners how Community Partners goes about selecting, each month, a project to fund. The Commissioners agreed that the first project that should be selected for support is the Siblings of Teen Parents Program of the County's Adolescent Family Life Program, which was dropped ten months ago because of the county budget cuts. It was agreed that Commissioner Lawrence would contact Nikki Steele to define and discuss the feasibility of the project. Next steps would be to submit those findings to the Commissioners, then County Legal, then Supervisors, then Community Partners. It was agreed that we need to actively recruit people for 'Friends of the Commission'.
- D. Possibility of including a man on the Commission: After discussion, Commissioner Lawrence made a motion and Commissioner Hollister seconded, to make sure there is a clear understanding that gender is not an issue when appointing a new commissioner.

- F. Women's History Month (March 2005): Computer discs from Commissioner Love. Commissioner Hollister will make a copy and then return them to Commissioner McAllister. Looking for tools to aide in the awareness of women in history. Distribution to libraries looks like best avenue.
