- III. The Minutes of September 20 were corrected to change the name of the Child Development Resources Advisory board to the Child Resource and Referral Center Advisory Board.
- IV. Financial Report Martha White As of September 15, with 18% of the fiscal year elapsed, 70% of Level I funds and 3% of Level 2 funds were expended.

- B. Housing Karen Flock
 Commissioner Flock reported on the talk given by Ed Nelson
 of Many Mansions regarding Section 8 funds available for low
 income families.
 - M/S/P Ginny Connell/Lauren Anderson
 To commend the Many Mansions program as a local
 network which is responding to concrete housing needs
 of very low income families in Thousand Oaks and to
 advocate for the formation of similar organizations in
 all cities of Ventura County.

Commissioner Flock reported on the efforts of Networking for Housing in Ventura County to secure funding for the development of 250 new low-income housing units.

- M/S/P To support the proposal of Networking for Housing in Ventura County to target \$250,000 in State Coastal County Offshore Energy Assistance Program funds for low income housing.
- M/S/P Flock, Connell: that the Commission for Women join the Network for Housing and that Karen Flock be the Commission's representative.
- C. Counseling
 Domestic Violence Services Monitoring Commissioner Lauren
 Anderson will no longer serve as a member of the Board of
 Directors for the Coalition Against Household Violence. She
 will continue representing the Commission in the monitoring
 of services and will meet on November 6 with Irma Mejia,
 PSSA and Carole Doty, Executive Director, CAHV to review the
 shelter and program.

Lillian Goldman will meet with Irma Mejia on November 4 to review the Interface shelter and program.

D. Divorced Women/Female Heads of Households Arleen Rosenfield

Commissioner Rosenfield reported on her participation at the Senate hearings on "The Economic Impact of Divorce" sponsored on October 16 in Los Angeles by the Senate Judiciary Committee and the Senate Taskforce on Family Equity. Ms. Rosenfield was one of 20 speakers and spoke on spousal support and no-fault divorce.

Ms. Rosenfield also reported that Fred Rosenmond, an attorney in Oxnard, chair of the Ventura County Bar Free Legal Clinic, conducts free sessions on Monday nights for low income people on the process of divorce. Appointments are necessary and may be made by calling the Ventura County Bar Association. Mr. Rosenmond has indicated a willingness to consider adding clinic sessions on the child support enforcement process. The Divorced Women's Task Force will develop a proposal for such sessions to present to the free legal clinic and the Bar Association.

E. Child Care

Commissioner Hubbell reviewed the events which took place during Child Care Week. She indicated that a large part of its success was due to the participation of Commission members. The CEO's breakfast was successful and is to be followed by a workshop on October 29. Commissioner Warrington reported on the "Day In The Park". Commissioner Hubbell commended Commissioner Marlene Alexander for her work on the statement which she prepared for other commissioners to read at City Council meetings regarding their proclamations for Child Care Week.

IX. Committees

A. Communications

Commissioner Ryder will schedule a committee meeting to develop a distribution plan for the commission brochure.

B. Legislative Analysis - Arleen Rosenfield
The Governor signed SB 1071 (Lockyer) which guarantees the
participation of both spouses in the management and control
of community property, and SB 1751 (Hart) regarding
mandatory child support deductions. SB 1529 (Hart)
regarding child care tax credits was vetoed.

X. Unfinished Business

A. The letters of thanks to GTE and their special recognition in the banquet program was determined to be sufficient.

B. By Laws committee

M/S/P, Engel, Ryder: to establish a bylaws review committee to look over the bylaws and clarify as necessary.

Committee members are: Dot Engel, Chair, Martha White, Sandy Ryder, Karen Flock. The committee will report at the November 15 meeting.

Virginia Aguirre of the Blanchard Community Library, reviewed Project Literacy U.S., the California Literacy Program and the F.L.A.I.R. Project. She informed the Commission of the programs the Literacy Programs are conducting in the County and their positive impact.

Miriam Fraser of the Laubach Literacy Volunteers also spoke to the Commission about the tutoring services available in the county and training programs available for individuals wishing to become volunteers in the program.
