# Little Gators go big time

When the Prophet David wasn't sacking-out in some pasture chording his guitar and blowing psalms, he walked along the Jordan gathering pebbles with which to flatten behemoths like Goliath.

Passes may replace pebbles in tomorrow afternoon's Camellia Bowl, and in this case David's name is Bob Toledo, the SF State quarterback whose 45 TD passes bring the Gators into the arena of Sacramento's Hughes Stadium. They face-off with the Philistine of small-college football San Diego State, ranked No. 1 nationally and winners of 25 of their last 26 games.

The Aztecs, 28-7 victors over Montana State in last year's bowl, are busily gluing together their lineup for the 2:05 kickoff. The NCAA eligibility committee scissored six San Diego starters from the game.

While SF State lost starting fullback John Cummins and defensive tackle Joe Hebel, the Aztecs are without alternate quarterback Thom Williams, two defensive backs and three linemen.

San Diego coach Don Coryell, who calls SF State's Joe Koontz, Ed Larios and Dennis Highland the finest re-

ceivers his team has faced, admits "he'll have to try a variety of defensive moves to stop them."

"In fact," Coryell said, "we may even have to use (All American flanker) Haven Moses on defense."

The Aztecs will probably doubleteam Gator receiver Joe Koontz something they haven't done all year.

"But we can't double-team every-one," Coryell said.

Already 10,000 tickets have been sold by the Bowl Association, not including those sent out to several agencies. The game, which will be played

in Hughes Stadium (21,300) on the Sacramento City College campus, broke attendance records last year when 15,000 attended.

The field has no drainage system, and is a muddy 100 yards.

"In last year's mud we were fortunate to have Don Horn (Green Bay Packers) as our starting quarterback," Coryell said, "we just set him in the shotgun and he threw all day."

Horn completed eight of his passes to Aztec flanker Tom Nettles, who is back this year. But, if either team has a Horn-like thrower this year, it's SF State

The same action should be taken against faculty members involved.

We back the silent vigil in support of Summerskill and against violence which is scheduled for noon today in front of the Commons.

In the general uproar on campus, most students have forgotten that SF State plays in the Camellia Bowl at Sacramento tomorrow. We salute the championship football team and wish them the best of luck against San Diego.

# Trustees move to fire Summerskill

Sacramento politicians and State College trustees have reacted quickly and angrily to the events which brought the campus to a standstill on Wednesday.

The trustees have scheduled an emergency meeting in Los Angeles Saturday to take up the possible removal of John Summerskill as President of SF State.

Assembly Speaker Jesse M. Unruh who said he was inclined to believe that Summerskill ought to be fired, also ordered the Assembly Education Committee to make a full investigation of the "purposeless anarchy" which racked the campus Wednesday.

Summerskill is being severely criticized for not calling in police to deal with the demonstrators who broke into the Administration Building, disrupted classes, set fire and looted the Bookstore, pillaged the Commons and roughed up newsmen and anyone who attempted to come to their aid.

Governor Ronald Reagan, who is at Yale University, has

The Executive Committee of the SF State Academic Senate has planned an emergency faculty meeting at 3 p.m. today in the Main Auditorium to discuss the events of Wednesday as well as pending Trustee action against President Summerskill.

The Executive Committee requests that every faculty member attend.

The meeting will be broadcast to the campus.

## Seven injured Wednesday

A total of seven students were treated at the Health Center Wednesday for what Dr. Eugene Bossi called "minor injuries" as a result of beatings.

Dr. Bossi, the physician who treated the students, said most were injured in fights in front of the Bookstore.

#### NO NAMES

Names and addresses of the seven students could not be disclosed.

Damage to the Bookstore and Commons appeared to be minimal. Both places resumed normal operation yesterday.

The two broken windows in the Bookstore were replaced by wooden boards, one bearing the words "Soul Brother."

#### NO COMMENT

Rudy Nothenberg, director of the Foundation which runs the Bookstore and Commons, would not comment on the extent of property damage until inventory was taken.

Both the Commons and Bookstore were closed a f t e r being disrupted by Wednesday's demonstration and sporadic mob violence.

# MAPS has teach-in

The Movement Against Political Suspensions (MAPS) is making an attempt to continue to involve students and faculty members in a dialogue on the underlying causes and reasons for Wednesday's demonstration.

Greg deGiere, a member of MAPS and staff writer for Open Process said they (MAPS) plan to continue the tactic of "education" somewhat after the manner of that used by groups of blacks on Wednesday.

"We will go into several classes and ask the instructor if we can take 10 or 15 minutes to explain the issues as we see them and ask that the class take up the discussion," deGiere said.

"We don't want to completely disrupt classes for disruption's sake—we want to continue the dialogue started on Wednesday. We hope to have the whole campus covered in this manner," he said.

"The demonstrators showed the administration here and the people of California that students cannot be suspended without due process," deGiere said.

He also stated that Wednesday's happenings were successful in getting students involved

"There were probably many students who were alienated by Wednesday's actions, but that's OK," he said.

"They're thinking now. Before they could conveniently isolate themselves from the situation, but now they're wrapped up in it.

"There was little violence yesterday, but now people know what violence is; they know what black is," deGiere said. Joy Magasus, in one of the few prepared speeches, defined the aims of MAPS.

"All we're asking for is freedom of the press and the right to judge our own," Miss Magasus said

Miss Magasus, and numerous other speakers defended the demonstrations which saw the destruction in the Administration Building and the Bookstore, fights between students and non-students alike, and general confusion.

The general tone of the pro-demonstration group was one of acceptance of violence as a necessary evil. An evil created and enforced by society.

"I hate to see us wrecking our own Administration Building, but some glass has to be broken in this society," a student said.

The schism in student opinion was evidenced by the crowd reaction to Jefferson Poland's statement that he didn't feel vandalism bothered many students. Poland was temporarily drowned out in a flurry of jeers and shouts from the crowd.

While the majority of the speakers supported the actions of MAPS a few raised the voice of moderation.

One student, senior Joe Twyman, said "I'm one of the silent majority—except after yesterday. I'm in favor of any type of demonstration as long as it doesn't stop the rights of others."

A Negro student said the classes were interrupted to keep people from getting hurt, and to explain the positions of the BSU and MAPS. He went on to say Negroes were "tired of having other people tell them what to do" and he added "the time for talk is over."

## BSU disclaim Leg demands

The AS legislature called a press conference yesterday and demanded that the Black Students Union (BSU) "give indication that the activities of Wednesday are disavowed."

Leg speaker Pat Kimbley read the statement that continued, "If the BSU does not give the campus reassurance that they can make such a disavowal, then we demand the expulsion of the BSU and the leaders responsible for Wednesday's activities."

The student group, which included f in ance committee chairman, Steve Diaz, treasurer Bill Peters, and rules committee chairman, Kay Tsenin, said that a legitimate educational group would not try to close down the campus.

The conference took place at the Lake Merced Boat Lodge, about a mile from the heart of the campus. Diaz said he felt "at least 90 percent" of the student body supports the Leg, although he said the SDS estimated that only 60 percent of the crowd Wednesday was hostile to the demonstrations.

# Redwoods fight for survival

The redwood lumber industry is one of the largest concerns in Northern California. They own over one million acres of timber with an estimated twenty-five trillion board feet of lumber on this

In leaflets distributed by the lumber companies, and pamphlets circulated by the industries spokesman, American Forest Industries, Inc., the lumber interests describe the care they exercise in presrvng all thse "board feet" of

According to the industry, is the mainstay of the community. It hires the most people, pays the most taxes, and helps the most to educate the

It also generously opens up ts lands to the hunter, camper, and recreationist. It has helped save the superlative redwoods for posterity, and is scientifically managing the others to provide redwood products for America.

Senate bill S.2515, a proposal for a redwood national park, would affect only 32,992 acres (3.3%) of privately owned, yet it is this three percent which the industry claims will destroy the redwood industry, and therefore the economy of the redwood region.

A closer scrutiny of some of the industries claims shows that many are unsound and some are completely falla-

The industry claims that it has opened up 365,000 acres of its tree farms to public recre-

This "opening up" is, however, at the discretion of the companies, and repeatedly recreationists have been turned back from these areas when attempting to use them.

This reporter was refused entrance to both the tall trees area on Redwood Creek, and the Little Lost Man Creek area, both areas which would be included in the proposed park, during Thanksgiving for reasons unknown.

The industry also claims that the truly outstanding redwoods have already been

This is purely a matter of opinion. Since only three percent of an original 2 million acres have been set aside in state parks, and since the tallest trees in the world and many groves of redwoods are outside existing parks, it is obvious that the truly "outstanding" redwoods have not been saved.

The industry also stated that it is the mainstay of the present — and future — economy of the redwood region.

The industry fails to say that some forest economists predict a 40 percent decline in the redwood products business in this region, 20 percent due to declining log availability, and 20 percent due to automation.

It also fails to mention that the redwood region's unemployment rate is twice the national average, employment is seasonal and uncertain, and welfare in Humbolt County

averages among the highest in the state.

The redwood industry does not seem to be supporting a very sound economy. In fact a national park would probably be an economic shot in the arm for this area.

According to the senate committee on Interior and Insular Affairs stated in its report to the senate on the proposed national park "any initial adverse impact of the creation of the park on the local economy will be tempor-

Why then, are the lumber companies fighting the redwood park proposal so adamantly when it only encompasses 3 percent of their land for which they will receive adequate recompense from the government?

According to Kramer Adams, conservation chairman of the California Redwood Association (a business representative of the seven largest lumber manufacturers in the redwoods area) "the land is our bankroll and the trees are our interest."

"The land can produce new timber forever, which will give us a sustained yield (of lumber)," said Adams. "Timber must be figured in volume, not acres, and this area produces about forty percent of our lumber, by volume.'

Adams said that the lumber companies had "voluntarily declared a moratorium on logging in S.2515."

This moratorium, however, was recently violated by the Georgia Pacific lumber company when they logged a quarter of a mile within the proposed parks boundaries.

This is evidence of the frantic logging going on around the proposals boundaries. According to the Sierra Club conservation director, Mike McCloskey, the loggers are "cutting directly a long the proposed parks borders."

'One area in particular, the Emerald Mile, a three mile stretch of superlative redwood groves above the tall trees on Redwood Creek," says Mc-"is being heavily logged."

## Student in Muni accident in critical need of blood



# Plays almost

Two plays currently among A.C.T.'s repertoire almost ascend to superb quality. Almost, but not quite.

Still, "Long Day's Journey Into Night" and "Endgame" deserve to be seen, the former because it is a fine specimen of the burning passion which drove O'Neill to write a twentieth century masterpiece, the latter because it is a milestone in contemporary drama.

Eugene O'Neill's play is alive with the torment of a son dying of consumption but even more consumed by the strife which has shattered the roots of his family. The drug-addicted mother accuses everyone of policing her while the older brother drowns his personal disappointments in alcohol.

The play is good; it grips and holds fast the audience during its three-and-a-halfhour long probe of character. The genius of the work is that the focus could be on any one of the four major characters. each one is so thoroughly developed.

One has a real sense of the crushing tragedy when she explains the stupidity of her husband's leaving her to a cheap hotel doctor who gives her morphine to ease the pain after the birth of her second child. It is on her shoulders that the play's towering emotion must rest. And they are strong shoulders.

David Grimm is merely lethargic as the consumptive son. His sorely limited expression is either shouting or mur-

William Patterson portrays Hamm, aged man in a wheel-chair, and he is excellent, appropriately complaining, though one would wish that his voice were more monotonous at times and that his make-up were more grotesque. Dion Chesse turns in a nice bit as Hamm's father Nag, and Michael Lerner is the pain-consumed servant, quite possibly an extenuation of Hamm's alter ego.

Tovatt's direction in part exemplifies this pushing to the limits of endurance with his somewhat psychedelic music before and during the dimming of the houselights. But other limits, the limits of inaction, could have been more strongly pushed.

"I was told by campus security cops that I would be arrested later in the day," the bearded John Gerassi said, "and I expect to be suspended from my teaching duties by

Gerassi, an instructor of international relations, was shaking as he described how he and a student had climbed through a window to get into the administration building He was followed by several hundred people who poured into the building through a

shattered glass door. The demonstrators marched along hallways and ripped fire extinguishers and office signs from their moorings. Cement floor ashtrays were kicked over and sand crackled under the feet of the insurgents.

They owned the administration building for nearly two hours before they left. They promised they would return if their demands were not met.

When asked if he thought the demonstrators had won a victory in causing the administration building to be shut down Gerassi said, "In the short

run, no . . but in the long run, yes." A reporter from the campus radio station KRTG was taping

an interview outside of President John Summerskill's office when he was set upon by a young Negro. "He tore my tape recorder from me and smashed it on the floor," the reporter said, "then he grabbed me by the lapels

and forced me against the wall and said 'don't report this'. John Levin, a leader from the Movement Against Political Suspensions (MAPS), addressed a rally in the hallway of the beseiged Administration Building.

Levin, who is also active in the Students for a Democratic Society (SDS), announced to the demonstrators that delegations of supporters had come from Stanford, UC Berkeley, San Jose State, College of Marin, and Merritt College.

"We should use this place as a command post, a focal point, a place of power," Levin said, "and if police come on campus

we should be prepared to defend ourselves.' The police were not called to the campus.

After several clashes involving Black students and newsmen had occurred around The Bookstore and Commons areas, students began leaving the campus, some showing obvious fear.

"It's terrible down there," a red-haired girl screamed as she ran toward 19th Avenue to catch a streetcar.

I saw newsmen being beaten in front of the Bookstore at a Negro smashed the door with a chair," the girl said as she clutched the trembling arm of her male companion.

"When I heard gunshots, I decided to get the hell off campus," he said.

For SF State, which has worked on its offensive patterns all week, Rich Kimble will start in place of Kevin Sheehy tonight, while Ken Robinson moves in at forward for Tom

"The loss of Bill Locke (CCSF) has really hurt us," head coach Paul Rundell said. "Not only is he a fine ball-handler and shooter, but he's a very smart ballplayer."

TWISTED ANKLE

Locke has now begun working-out "lightly" with the team after badly twisting in ankle in pre-season practices. "Bill will be in the lineup after the Christmas vacation," Rundell said, "his ankle will be as good then as it's ever going to be."

Tonight the Gators, led by 6'7" center Mike Paulle, must stop Cal Poly's Mike LaRoche, an All-CCAA forward who hit for 37 points against Azusa Pacific.

LaRoche, who averaged 23 points per game last year, leads a team which, Rundell says "loves to go on the fast break."

In the second-half of last Friday night's match with Santa Clara, the Gators were stampeded in a Bronco fast-break.

The Cal Poly Mustangs, who have three of last year's starters back, turn to 6'7" Arnold Slone, a transfer from Merritt College for rebounding strength.

Tomorrow night at Occidental of LA, SF State faces a practically veteran team led by 6'5" center Norris Smith who totaled 26 points against Loyola of LA last weekend. Joining Smith in the post are forwards Don Riddell, 6'6", and John Easthope, 6'1".

Gator defensive coach Allen Abraham undoubtedly gained a bit of holiday cheer last week upon learning that San Diego will be without the services of their star passing quarterback Thom Williams.

Williams was declared ineligible for Bowl competition along with three other Aztecs, tackle Mike Hickey, defensive back Nate Wright and defensive tackle Fred Dryer.

The Aztecs had previously lost their top

TOLEDO



Penny MacDonald of Fresno State will reign as Camellia Bowl queen and 25 marching bands will perform at halftime.



# Summerskill's job is on the line

asked the trustees and the UC regents to take "immediate action" to preserve law and order on campuses.

Reagan wants the trustees and regents to establish guidelines which would give local police more jurisdiction over university and college facilities. He said when campus police can't prevent or control "criminal activity of any sort, local police should be immediately called in."

Unruh also put the heat on State College Chancellor Glenn Dumke for not giving more "personal attention" to campus disorders.

"Anyone who can't enforce discipline may have to go," Unruh said. He did not say whether or not this included the chancellor.

Unruh said he believed there was a leftist "conspiracy going on statewide and perhaps nationwide" to make campuses sanctuaries for those who are advocating violence.

In a press conference yesterday, Assemblyman Leo J. Ryan of South San Francisco said he was asking the trustees and the UC regents to "change their policies to prevent a small minority from creating chaos and anarchy on college campuses."

Ryan said Summerskill "must take full responsibility" for the events on Wednesday.

"The reaction in Sacramento is so strong, and the legislators are so angry," Ryan said, "that it has no parallel in the five years I've been in Sacramento . . . this will be reflected on a bi-partisan basis when we meet again."

Assemblyman Carl Britschgi of Redwood City sent a telegram to Dumke suggesting Summerskill be "immediately replaced with an interim president so that a further uprising will never occur at this state college."

San Francisco's two senators, Republican Milton Marks and Democrat George Moscone both asked the trustees to initiate an immediate investigation.

Trustees' chairman Donald Hart vowed yesterday that all identified students and faculty members involved in the Wednesday's violence would be given swift punishment. He blamed outside agitators for causing recent unrest at the state colleges.

# Pan-African celebration
