### Petition Submitted For Recall Of Board Member

An unprecedented act, a petition for the recall of the president of the Board of Directors of L.V., has riveted the attention of villagers. No names were affixed to the recall petition, and the subject, Dick Griswold, was given no opportunity to answer charges except during an open Board of Directors meeting.

A special meeting has been scheduled for February 6, 1997, for the sole purpose of voting on the recall of Griswold and electing a new Board member if recall passes. Homeowners have received proxy ballots in the mail which they may use if attending the meeting is impossible.

The petition appears to have been written by amateurs, and more than one lawyer has considered it invalid. Mr. Griswold, however, has provided answers to the four allegations, as reprinted below.

1. Allegation: Acts without authority of Board. Response: This is a vague and meaningless allegation. It is an opinion unsubstantiated by any facts and

### The Ombudsman Panel

There are times when villagers might need to talk to someone who will listen and advise or suggest how to solve a problem. The Ombudsman Panel has been a long standing group that was appointed by the Board of Directors in L.V. to intercede when people have misunderstandings, or have a problem interpreting the Rules and Regulations.

These people do not claim the powers of King Solomon, but they meet people confidentially and offer their accumulated wisdom. If more than one person is involved, both parties must agree to appear in an infor-

mal setting and talk through the situation.

Robert Karlin, V.38, L.V. resident since 1979, is the current chairman of the panel. He was a member of the panel several years ago, and is now serving a second term. In his working career his field was public relations as a representative of the United Auto Workers Union in Detroit, an assistant to Walter Reuther. Later, he did organizational work and writing for union publications in California. He served on the LV Board of Directors two years and was liaison to the Architecture and Landscape Committee.

Al Bennett, V.25, served as president of the Board of Directors (1990-91) and was chairman of the Buildings and Grounds Committee. In private life, he was a food chemist, working with the Great Atlantic and Pacific Food

Company in their manufacturing division.

Vern Kiep, V.44, has been a resident since 1983. He is Village Coordinator for the ESO in his Village 44. As president of a printing company, he took part in all factors of business life: labor negotiations, purchasing, customer contacts.

First let me point out that this ballot is more than just about a recall of one Director. It is about how we optomer contacts.

Len Levy, V.17, has lived in L.V. since 1986. His background is in Law. He was regional manager of a law book publishing company, Bancroft - Whitney Publishers, San Francisco. and when he moved to Los Angeles, he was Sales Manager in Southern California. In L.V., he was on the Buildings and Grounds Committee for 1½ years, and serves in Camarillo on Grey Law for Ventura County.

All of these men are "people-persons". They relate easily to villagers, and can keep confidences. They give their recommendations to the Board when the Board is involved, but their decisions are not binding. They respond quickly when requested, and arbitrate problems

fairly.

One wonders if the current tension in L.V. could have been avoided early-on if the parties involved had asked the Ombudsmen to offer a resolution that would calm the issues and allow our Village to resume its peaceful character.

#### **On Recall Ballot**

The required 5% of Unit Owners have signed a petition drafted by a small group of homeowners to recall Director Griswold, and a Recall Ballot has been mailed to us to vote on this matter in person or by proxy on February 6, 1997

This is a very serious matter without precedent in Leisure Village — one that will affect us in the years to come — and we better think very hard, and carefully consider all the factors, before we vote.

First let me point out that about a recall of one Director. It is about how we operate after we elect Directors, how we entrust them to serve in our behalf, how we treat them while they are serving, and as a result what effect this has to encourage qualified homeowners to run for the Board. And so my comments are not about Dick Griswold, but about what this recall ballot means to us, to our interests, and to our future.

Similarly, my comments are not about those who signed the original petition. I do not question their motives or feelings or inten-

tions. Some may have done so without knowing all the pros and cons.

My comments are about four very basic reasons why we should vote NO on this recall ballot.

1. Passage of this Ballot to recall a Director will have a profoundly negative and lasting effect on our village. At the very least it will disrupt our relatively calm, harmonious day-to-day life. Most likely, it will bring about divisiveness, establish a dangerous precedent, politicize our Boards and render them much less effective.

Anger, confrontation, vengeful action or vigilante justice are rarely effective means of achieving satisfactory outcomes. Appropriate ways to resolve differences or disagreements, or to bring about desired changes, are through communication, negotiation, compromise, or elections at the designated times.

2. "It takes three to tango." No single Director has the power to act on any matter, however insignificant. It takes a majority of at least three. If you believe that an improper action was taken by the Board then you must ask for a recall of at least three Board Members!

3. Passage of the ballot to recall a Director will discourage qualified people from running for the Board. Responsible homeowners will not want to be placed in such a vulnerable position, to be subjected to intimidation and threats. The office of Board Director will become politicized, to be filled only by members of a vocal activist group.

4. Passage of this Ballot will greatly damage the Leisure Village reputation in our community, and will be a most harmful way to

greet our new General Manager about to be hired. Assuredly, the impact on our staff and on our operations will be detrimental and costly.

In summary then:

1. Approval of the Recall Ballot will inflame our community and will degrade our life as we know it.

2. The recall ballot is a vengeful action based on the faulty pretense that one Director can be blamed for undesirable Board actions, whereas "it takes three to

tango."

3. Approval of the recall ballot will effectively turn the village over to a one-sided group of politicized activists; many qualified homeowners will not want to run for the Board facing potential activist recalls.

4. Approval of the recall ballot will have an adverse effect on our standing in the community, on our operations, on our staff, and on our new General Manager.

I therefore strongly urge you to VOTE NO on this Recall Ballot.

## Interfaith Thanksgiving Service Was Well Attended By Gene Hawkins, Coordinator


Approximately 300 villagers and guests turned out for the 21st Interfaith Thanksgiving worship held November 27 in the AR.



method has always been to bring every issue to the Board for decision.

2. Allegation: Violates CC&R's, Art.II, Section 2.7 (Maintains business for profit in L.V. residence.) Response: CC&R's Section 2.7 does not refer to work customarily done in many homes, such as income taxes, real estate sales, handymen and businesses where there is no regular foot or vehicular traffic. Years ago a previous Board ruling allowed me to conduct a business in my home and this has not been revoked. Therefore, no violation of the CC&R's has occurred. Additionally, our vitamin business is organized for mail order sales. Orders are received by mail at a P.O.Box, made up and taken to UPS for delivery. Many businesses are conducted in homes in Leisure Village. Are we to pursue and persecute each one, especially where there is neither traffic, nor strangers entering into the village and there are no solicitations or advertising?

3. Allegation: Accused Woman's Club Trading Post with false statements. Response: I did ask the Women's Club's Trading Post to keep a written, verifiable record of all sales. I truth is never defamatory.

asked the Trading Post to provide a paper trail, that can be audited, from the time the money is collected until it is deposited into the Women's Club bank account. Yes, it is true that I have asked the Women's Club to operate in conformance with rule 9.26. None of these requests can be considered false accusations. In fact, the requests are the recommendations of the auditor and attorney for LVA. Moreover, these same requirements apply to all Leisure Village clubs, groups and activities.

This work was done on company time by four Resident Services employees. To charge that statements I made in regard to this brazen and unapproved behavior is "harassment of a board member" is unbelievable. The board member should have been reprimanded and should have repaid LV for the services of these four men at their usual rate of pay. The

Fence Grafitti Shows **Need of Repairs** By Lois Atz

Homeowners bordering on Leisure Village Drive and Mountain View Drive have found out what those white painted marks on their fences mean. These marks identify fence boards containing termites, dry rot or are otherwise unsound, which must be replaced (or the procedure started). by December 31, 1996 at homeowner expense.

Such owners have been sent letters by the Board outlining the procedure. First, get an architecture permit (\$10 fee) at the Association office and get a copy of Architecture Specification 130.

Repairs may be done 1) work in January to find by the homeowner, 2) request Resident Services to do the work, or 3) hire an outside licensed contractor. Repairs will be inspected by the Village.

### GTE Wants To Bring Cable TV To Leisure Village By Bob Atz

On November 13 two representatives from GTE presented a proposal to bring cable television to Leisure Village. Details of the project were given at a meeting conducted by the TADS committee, a sub-committee of the Purchase Research Committee. Dick Griswold, LVA Board president, and Hunter Cohen, LVA Board vice-president were also present.

During the presentation GTE explained that they are now installing a fiberoptic cable system in Thousand Oaks and Newbury Park. They plan to extend this service into Camarillo in about six months and they propose to install such a system to Leisure Village.

The new system would supplant the existing coaxial cable and would require new connections to be made to each residence. The currently-used wiring would be left in place and simply disconnected. The monthly cost for their basic service would be \$9.00 per month per dwelling. This price is guaranteed for 10 years, subject to a 2% per year price escalation. Our present cost for basic TV is approximately \$4.50 per month, which is included in our homeowner's monthly assessment.

The new system would provide 64 channels of television compared to the 22 channels we presently receiver to cable ready television sets. Those sets that are not cable-ready will require a converter box.

GTE estimates the cost to install their system in L.V. at approximately \$1.6 million. There would be no cost to the Village other than the basic \$9.00 per month service fee plus \$2.95 for the converter box, if needed. This price would include in-

## Observations Regarding Board Of Directors By Lois Atz

The Open Board Meeting of December 2 attracted about 350 villagers, creating a scramble for chairs and copies of the agenda.

Main interest was in the recall election efforts. Points raised by homeowners were whether the election is legal, for several reasons:

Results of the September election reportedly were not filed with the Ventura County Recorder until December. Therefore cumulative voting was still legally in effect when the recall petition was submitted on November 11. Under cumulative voting, recall of a single Board member is not possible.

stallation of two TV connections for those having more than one set. If additional TV connections are wanted they would cost \$15.45 each, if installed at the time the project is started.

As presently planned, the proposed system would not deliver AMC, CSPAN-2 or FM stations to our homes.

Because of the many ramifications of this project the LVA Board of Directors will not make any decisions about installing this system until more studies have been completed. Stay tuned.

Sworn affidavits should have been filed with the petition to prove the charges. As filed, the initiative petition is anonymous and unsubstantiated.



#### **Buildings** and **Grounds Committee** By Charles Babcock

The purpose and mission of the Buildings and Grounds Committee Committee is to monitor the condition and maintenance practices of L. V. homes and common properties. Some of the responsibilities include the external inspection of properties for compliance with the Rules and Regulations.

One of the specifics is to verify that the trees and plants are on the approved plant list and are maintained in an esthetic form and condition. Individual members or a team are assigned by the Committee to inspect Villages and report back on discrepancies or violations and a recommended course of action.

If action becomes necessary the Association Office will send a letter to the home owner requesting compliance, with the home owner given a specified time period to complete the necessary adjustments.

At this time of year rain gutters need to be cleaned out to prevent backing of water into ceilings. Repairs of this nature at the present time have costs being absorbed by the Association which in turn means your friends and neighbors are paying for the damage which has been caused by your negligence. In the future damages incurred due to negligence and failure to properly maintain

### A Pique At Village Politics: Let's Get Legal

**By Barbara Simons** 

Do I have a legal background? Many people have asked me that question. My answer is, yes. I attended an accredited law school for two years and found I really didn't like the "advocacy" system. Every time I wrote a law exam I had the strongest urge to get the parties to compromise, which is not what law professors want to read. At that time I wasn't sure whether I disliked the law itself or just law school. I decided I wanted to work in the law field before I attended another year of law school. This would determine whether I liked the practice of law or not. If I found I did and it was just law school I disliked I would go back and finish my last year.

I enrolled in a year's course at UCLA and became an ABA approved Legal Assistant and went into the field of Corporate/ Real Estate law. I worked for two high powered corporate law firms (which means if you didn't go to Harvard law school don't look for a job with them). I specialized in real estate. funded massive commercial developments for our massive corporate client. I was assigned the tasks of "riding herd" on the developers, the title officers and the brokers, to be sure all papers, forms, permits, inspections and recordings were correct before I called for our client's millions to go on the wire.

real estate started to slow thrown such charges out of

and finally became bored. In the end I decided I preferred children to lawyers and went back to my former career of teaching, which I did in 1983, retiring in 1992.

Law school had given me the ability to do legal research and that's why I went up to the County's law library. I wanted to familiarize myself with law applicable to the current situation in Leisure Village.

Here is what I learned: **Board Secretary Nick Fiore** is outside the law when he refuses to let Dick Griswold see and copy the petitions. The law is very clear on this. It states that any board member (director) has an absolute right to see and to copy any and all records, documents, books, files etc., having to do with the corporation (that's what we are in the eyes of California law).

What has LVA attorney Mr. Lingl done on this issue? Is he in favor of one of our directors breaking the law? Has he failed to advise him of his position? Has he asked Nick to present the petitions forthwith? (That's legalese for immediately, if not sooner.)

Additionally, the petitions are invalid for several reasons. Because the charges made by the maker(s) of the petition are mere conclusionary statements, stating no facts on which they based their conclusion they are what the courts call "insufficient". There are But the go-go days of court cases that have

down and I had less to do court. I would gladly cite that case law to Mr.Lingl, since he is a specialist in the field of law dealing with Common Interest Developments, but I thought he would know this.

> Another reason the recall petition is invalid is that the sponsors have failed to file affidavits or statements sworn to under penalty of perjury that the charges they made they know, of their own knowledge, to be true. Has Mr. Lingl asked for such oaths?

> The petitions are also invalid for a third and more complicated reason. Remember last June when we voted out cumulative voting? That necessitated a change in our governing documents. Any change to CC&R's, Bylaws,etc., has no force and effect until it is recorded in the County Recorder's office and the amended documents are sent out to every member (homeowner). That has not been done. The petition was presented while the voting changes were not recorded. Therefore, the petition was filed under cumulative voting. It was hardly diligent for Mr. Lingl's office not to have recorded the changed documents promptly.

However, those are the conditions that were in effect then (and I'm pretty sure a judge would be reluctant to apply the new rules of "straight voting" retroactively to a period when it was not in effect).

Under the law of this

ing is in effect, the petition must recall the entire board. not just one member. Of course the filing and recording amendment to the governing documents should have taken place last June, but it didn't. The facts are that the board was elected under cumulative voting and the petition was filed under cumulative voting. That was the rule in effect in our only recorded governing documents at the time.

A technical error, you say? It is just such technical errors that cause cases to be thrown out of court. Judges stick to the codes of Civil Procedure and court rules like glue. They even go to judicial school to learn it and have it drummed into their heads. This "technical error" is an absolute failure to comply with a clear lawno recording—no effect. So why has Mr. Ling! failed to inform the board that they

state, when cumulative vot- will all be subject to recall under cumulative voting rules if this petition goes forward?

> If the petitioners want to recall Mr. Griswold only, they will have to wait until the documents are recorded and mailed out. Then they will have to get new signatures all over again. This time folks, only homeowners can sign. I have learned that the Board members who reviewed the signatures went through more than 200 names to find somewhat more than 100 true owners. Even then, a judge could rule that board members elected by cumulative voting can only be recalled by cumulative voting. Where does Mr. Lingl stand on this issue, I wonder?

James Lingl, LVA attornev. declined a request for an interview with the editors of Inside Leisure Village, stating he can only discuss the recall with the Board.

Califonia Senior Legislature

The California State Senior Legislature met in Sacramento recently to discuss senior issues and to select the top 10 prioritized proposals on which to concentrate during 1997.

In previous years, Leisure Village has had a homeowner on this body. Joe Gavnes V.16 served for 9 years, and Joe Ellenbogen V.16 for 3 years. However, this year no one from the Village ran for the Senior Legislature. The representative now is Bob Warnagieris from Ven-

The information which follows is his summary of the issues, taken from Eugenie G. Wheeler's column in the STAR.

1. SP 42A: Income Taxes: Senior Tax Credit. Would suspend the inflation factor on the senior tax credit for five years to provide a majority of funding for long-term care pilot programs, and to fund the California Senior Legislature

2. AP 64: Nursing Home Employees. Would require health-care facilities to hire health-care workers who can communicate in the same language as the majority of the patients in the facility, and require training In English medical phrases.

4. AP 23: Fraud. Would increase the penalties for fraud against older adults to a level commensurate with


