

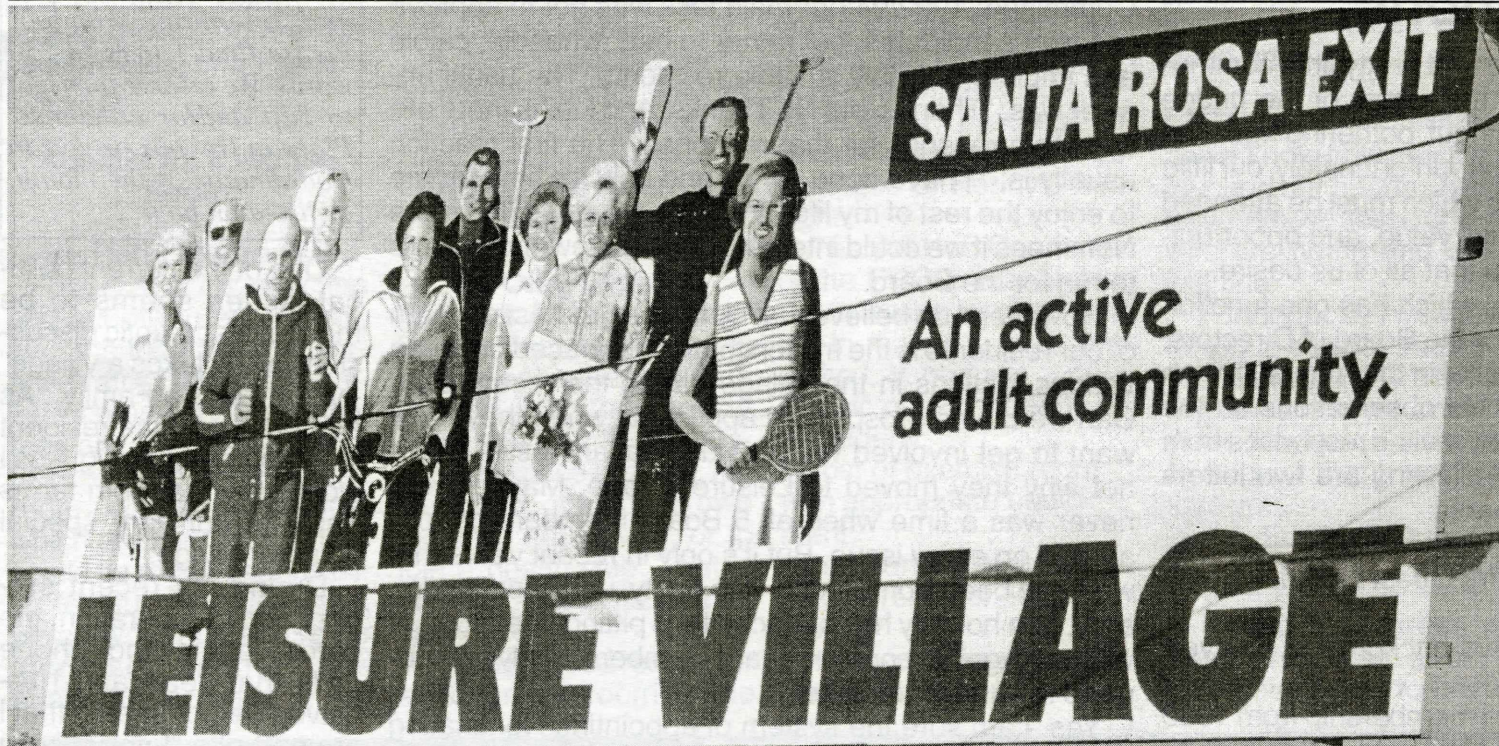

Twenty three years ago, in September 1973, Vivian and Martin Andresen signed up for the purchase of their new home at the sales office of Leisure Technology.

They had been watching the construction of what was to become Leisure Village. They bought at the same time as Nell Boyd did. The third couple to sign on was E.B. and Mildred Oberg.

When the word "pioneers" is used, did Leisure Tech mean the first 100 who bought their houses or was it the first 100 who moved in? Since the latter is more in the true sense of "pioneers" those listed here are the remaining survivors of that group.

Village 11 was the first village to be occupied and many residents still remain: Vivian Andresen, Helen Ayanian, Nick and Piff DeSimone, Al Podewills, Vi Kasner, Paul Eberle, Christie East, Mildred Oberg, and Helen Nichols.

Village 9 was next to fill up. Still living there today are Oran and Marge Robinson, Marion Tavano, Rosemary Sweigart and Joe and Charlotte Romero.

### Second Opinions About Nominations

Most residents of our private and pretty little community like to sit back and enjoy the roses, or the bridge games, or the golf course without bothering with the politics of running the Association. Unfortunately, our little community has lots of business which must be attended to in order to maintain its beauty, value, and opportunities for pleasure and relaxation that all of us desire.

The Nominating Committee, which has one function only, to nominate candidates for the Board of Directors, was the subject of a guest editorial in the August edition of ILV. Alan Rosin presented his observations on the conduct of the committee, and ILV invited responses from other residents on the topic. Following are two letters received in reply to Alan's remarks:

I read with interest Alan Rosin's Guest Editorial: Nominations.

Despite Mr. Rosin's extensive background, I nevertheless disagree with his proposals.

My credentials include Board membership from 1989-1991, serving as president in the last year. Subsequently, I also served on the Nominating Committee for 3 years.

First of all, it must be understood that Leisure Village Association is a corporation and not a civil entity like a village, town, or city. Like all homeowner associations, it operates under the laws of the State of California pertaining to such associations. LVA functions in accordance with CC&R's, Bylaws, and Rules and Regulations. The Bylaws of LVA, in Article VI, Sec. I, cover the "Nomination and Election of Directors."

It states that "any member may be nominated by a petition signed by not less than two percent (2%) of the voting power of the Association." Mr. Rosin uses the recent election of Board directors where one candidate was nominated "By petition" to illustrate a good reason to change current nominating procedures. I say just the opposite. The petition route to nomination is open to any resident who feels the Nominating Committee was wrong in rejecting an application or who wishes to by-pass the Nominating committee completely.

Tinkering with the Nominating Committee opens up a can of worms that L.V. would regret. Remember when the Board, after an election, doubled the size of the committee? That caused such a furor and vituperation against the Board that I hope will never occur again. Succeeding boards reduced the size of the committee to its previous level.

My final reason to leave the committee alone is this: personnel matters in all types of organizations are conducted on a confidential basis, and should be. Nobody would welcome derogatory information, proven or not proven, exposed to the general public. It is tough enough to get candidates to come forward without a further reason not to do so.

Commenting on Alan Rosin's thought provoking and interesting Guest Editorial: "Nominations" - his points are well taken, but one sentence in particular caused me to reply, namely:

"There should be consideration to nominating at least DOUBLE the number of LVA Board vacancies." Very true, but how can we nominate them if they don't apply for the position?

In the three years that I served on the Nominating Committee; 1992/94 our main task was not to approve or reject candidates, but rather to beg, wheedle, cajole and implore possibly suitable residents. The usual answer was; "Thanks, but No Thanks" and I think there are two main reasons for that response. The first reaction usually is: "I have done my bit and now it's time for me to enjoy the rest of my life." Perhaps we could find more Nominees if we could interest younger, newer residents to run for the Board.

However, I do believe that by far the greatest concern of our residents is the friction that has surfaced between various factions in the Village during the recent past. Can we blame prospective applicants when they don't want to get involved with this unpleasantness? That's not why they moved to Leisure Village. Maybe there never was a time when all 5 Board members happily agreed on every issue. But it's only in recent years that we have been bombarded with nasty, unsigned letters, and open hostility has surfaced thus pitting one group of villagers against another, Board members visibly antagonistic towards each other.

Yes, I am sure the system of appointing Nominating Committees could be improved, but how about all 3500 of us actively trying to improve our attitude towards a friendlier "Live and let live" approach? Our home in Leisure village is our biggest single asset, and for most of us it's the last independent home we will own. So couldn't we PLEASE strive to make it the pleasant, agreeable largely friction-free "Utopia" that we envisioned when we moved here?

Maybe then, when the Nominating Committee member asks: "Will you run for the Board?" a sufficient number of residents will say "Yes" to bring about Mr. Rosin's quest for nominating double the number of LVA Board vacancies.

## Debate

The L.V.A. Board of Directors has assigned to the Purchase Research Committee the task of determining the feasibility, cost, location, and other factors in establishing an exercise room in L.V. The subject has raised much interest, and both negative and positive opinions about the project. Following are two such articles, one Pro and one Con.

### Against An Exercise Room

The cost of construction and supplying equipment, also the increase in insurance rates, and the resulting increase in our monthly fees are strong deterrents to providing an exercise room. In case of injuries, which are inevitable, there would be more responsibility for our Security force, which would be cause for increased salaries and again, an increase in our

monthly fee.

L.V. already has exercise classes in addition to all its many other amenities. If these are not adequate for some residents, they should try local workout gyms which are close by.

As far as signing waivers for release of injury responsibility, I don't think waivers are binding.

Is it really necessary or prudent for us to assume these risks? I think not.

### An Exercise Room Of Our Own

Medical research has proved that the elderly need exercise. Not everyone has space at home, the discipline, or funds to own exercise equipment, or to join a health club. That is why L.V. needs its own facility.

Another good reason for an exercise room is the

need to update L.V.'s image in order to make it more attractive to new and younger residents. There is no other way to sustain our property values.

About ten years ago, Ken Wilson developed a plan for an exercise room which was desirable to a significant number of villagers. The proposal, at first favored by the Board, was tabled after a change in Board membership. A decade later, medical research has verified the advantages of Kenny's foresight.

The Ad Hoc Committee of the PRC is researching the following issues, keeping in mind the limitations of the L.V. budget:

- \* Basic physical needs of the elderly,
- \* Cost of exercise room with appropriate equipment,
- \* Comparison of purchase versus rental of equipment,
- \* Need for a full-time or part-time trainer,

- \* Experience of other condo communities,
- \* Village liability insurance, including the fine print,
- \* Amount of space needed, and location.

From the health needs to the financial considerations and property values, the success of this project depends upon realistic evaluation and solution of the listed problems.

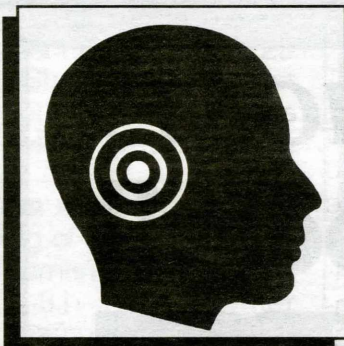

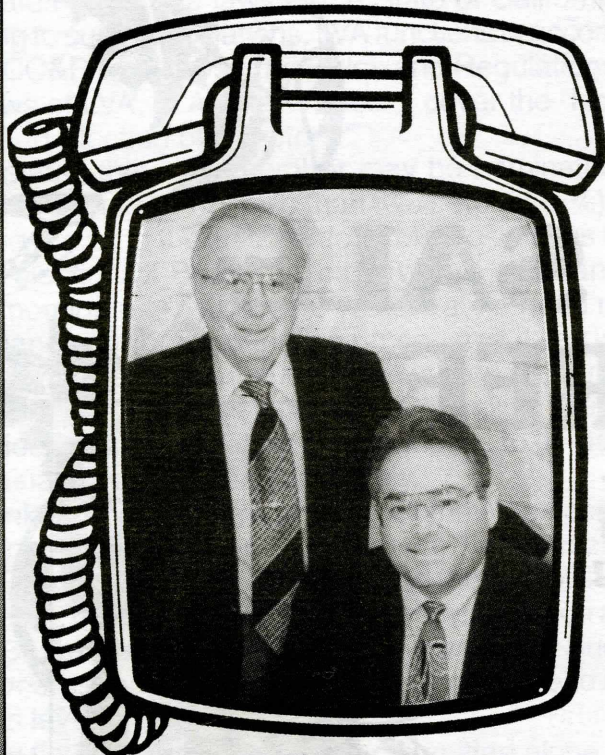

 After Village 9, Village 6 began to be occupied where Walt and Nancy Whitaker, Ed and Helen Fitzer, Larry and Bernice Jenkins, Norman and Dorothy Daniels, and Parthenia (Cavins) Peacock are still in residence.

Village 8 has originals Ruth Resnick, and the former Ethel Plummer, who is now Mrs. Paul Haynick. The Haynicks have since moved to Village 20.

Leisure Tech's "100th Move-in Award" was given to Tom and Bea O'Brien of Village 7. Villagers still remember how Tom fought against Leisure Tech to ensure that the villagers received the rights to which they were entitled. Later Karl Joehnck would join him as another strong advocate.

Some of the pioneers are still very involved. The Romeros continue to dance, but in the early years Joe taught auto mechanics here. Nick DeSimone was active as a distributor of the "Voice of the Village" for six years. His wife, Piff, has also been prominent over the last 23 years. She was also the first president of the Women's Club, which started early in 1974.

Nicks recalls the official opening of the Golf Course and Tournament on Sunday, March 31, 1974. Former PGA champion Jerry Barber conducted a golf clinic and later played in the tourna-

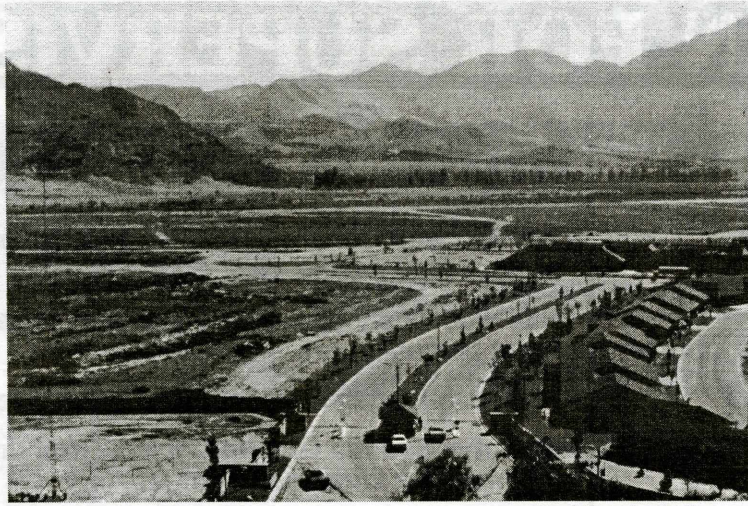

 ment. Nick recalls he was second on the tee following the PGA champ. The recreation department sold golf balls (\$.60-\$1.05) and golf hats for \$3.00 to \$4.25.  
 In the early days there would be 10-15 barbecues yearly. Nick DeSimone and Walt Whitaker were usually found at the coals. There were many luaus too. The first anniversary was celebrated with a luau of two pit roasted pigs, Hawaiian hors d'oeuvres and rum punch. During dinner, Hawaiian music was played and 25 Samoan dancers did native dancing and performed a spectacular fire dance as the grand finale. Birthday cake was cut and all sang Happy Birthday followed by dance music from Frank Umbro's orchestra. One villager summed it up, "There are luaus and luaus, but this was a lulu!"  
 The next afternoon, Myron Floren, Lawrence Welk's accordionist, entertained with two S.R.O. performances for 800 villagers, guests, and future residents.  
 Current residents may be interested in some of the long-gone activities, as: A radio transmitter that would open the residents' gate arm and could be bought for

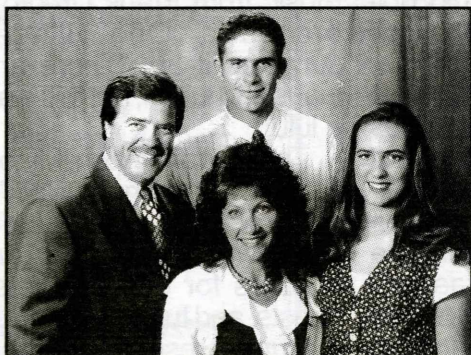

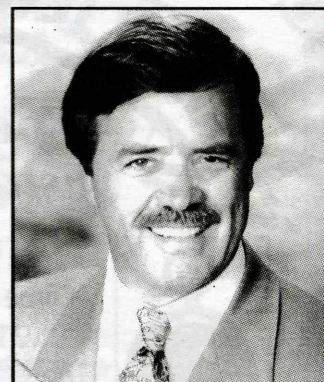

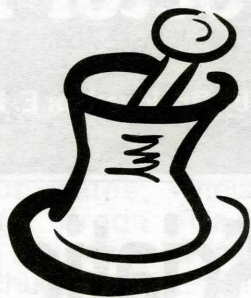

## Sciatic Pain

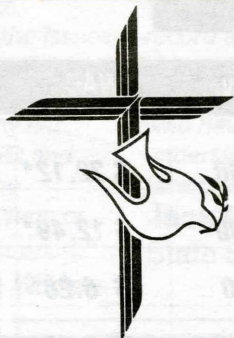

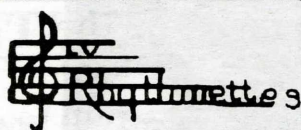


## SOLO CLUB

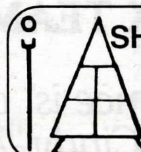

## A Pique At Politics: My Demographics Or Yours?

A funny thing happened on the way to the development of an exercise room. I've been hearing all kinds of statements/rumors that are so diametrically opposed to each other. I wonder if we are all living and experiencing the same world.

I kept hearing statements like, "I (or my friend or my neighbor) polled everybody in my social circle/ bridge club/ neighbors/ paddle tennis club (choose one) and anywhere from 0-100% are in favor of an exercise room." So I decided to take my own poll.

The group I polled were

100% pro- exercise room. I realized that the group had certain demographic characteristics in common: they were all married couples, almost all under the age of 72 and they had all moved into the Village within the last 4 years. In many of the other "so-called" polls I had heard about, the subjects were all long-time residents. Could that have made the difference?

But after some research it appears that demographics may *not* be the reason why people are "pro" and others "anti" on this issue.

Using County Recorder records showing the last time title to the property had

transferred, I surveyed 5 Villages at random, and from these figures found that the number of transferred titles was large. I counted all buyers and renters (from 1985-1995) as new faces. Names were also checked against the listings in the 1995 Village telephone book. The turnover rate for each unit within the 5 Villages varied from a low of 6% to a high of 73%.

I surveyed my own Village and found that 28 units out of 51 had been sold or leased. That is 55% of the homes in this Village.

Does that mean that 55% would approve of the

installation of an exercise room and original owners would not? Not likely. One of the original owners is our roof-mate and he is definitely in favor of it.

I received many calls after the August issue of ILV came out. All were favorable. However, I will especially remember my last two callers. One caller said, "I've been living in this village 18 years, and I've been waiting for an exercise room for 18 years!"

The last caller was a prospective buyer. He had picked up a copy of ILV in the Recreation Center, as he walked through with a real-estate broker. After reading my column he called to ask what I could tell him about Leisure Village Ocean Hills, since he

read in my column that we have friends living there. One of his questions was, "They *do* have an exercise room in Ocean Hills, don't they?"

That question triggered a flash of insight: we are not contemplating installing this exercise room because I want it or even that a majority of the owners want it. The Board is planning this room as a sales incentive to prevent the depreciation of the values of our Village, and hopefully to maintain and increase its attraction to new and future retirees. It's called being "with it" and not *passe*.

It is the Board's fiduciary duty to do exactly that, which is why we elected them.
