

Goldwasser, Lorraine are elected

In the Annual Election on June 24, about 56 percent of the Village's eligible voters (1,186 of the slightly more than 2,100 eligible) cast ballots, mostly absentee, to decide which of three formal candidates and one write-in they wanted to run this \$8 million-plus Association for the next year.

In the main contests for the two open seats on the Village Board, voters gave Marge Lorraine the most votes, 849. A relatively recent Village arrival, Harold Goldwasser, received the next highest total, 818.

Arthur Katz's sometimes hectic, last-minute write-in candidacy received 622 votes to incumbent Clair Huffman's 520 votes as both men lost their bids.

Former Board Member and President Caroline Pratt was among a handful of residents waiting patiently in the Assembly Room as the vote count stretched past 3 p.m. The delay apparently caused by auditors slowed down counting results for the three ballot issues and the write-in results.

Pratt, who has seen her share of elections over the past 22 years, said she was impressed by Katz's total, calling it, "a very good showing for a write-in candidate.

After their election was certified, the new Board elected current Board Member Robert Ellis as President, Marge Lorraine as Vice President and Dick Griswold as Treasurer, all by three to two votes.

Incumbent Secretary Mike Shapiro, who had been nominated for President and then Vice President by the new member,



hat can Homeowners do when Board members lie or exaggerate at Open or Working Board Meetings? The way things stand right now, if a Board member plays loose with the truth, the next chance to challenge his remarks and present the truth is at the following Open Board Meeting. By that time, the damage could be done. Let me give you some examples.

Earlier this year, Mike Shapiro, at an Open Board Meeting, suggested that our accountant, our outside auditors, and the company that reviewed the Association reserves could be likened to Enron, the company held in disrepute because of its accounting processes. His comments were made at an Open Board Meeting, putting the Association in jeopardy for lawsuits since he slandered each person or group and none of it was based on fact. At the following Board meeting, Pat Busch, Dick Griswold and others discredited his remarks. But the damage was already done.

I had hoped that Mike had learned that he could not impugn anyone's integrity or honesty or char-

acter just because it happened to suit him. I was wrong.

At the June 7 Board meeting, Mike was at it again. There was a discussion about the Worker's Comp insurance policy. Mike stated that there had been three full days of discussion and it was only at the end of the third day that someone asked Art Katz if he would receive a commis-

sion if the Board had accepted the Workers Comp policy he had presented, suggesting that Art was intentionally keeping the information from the Board. Mike was either Iving or imagining what happened. The following is what really happened.

The Board and Art Katz met for approximately 1.5 hours on three days — not the way Mike stated it.

Art brought in the proposal with a cover sheet from the insurance company, clearly stating his commission - and this was on the first day at the beginning of the meeting. So you see, there were not three full days of discussion, and it was not at the end of the

third day that a board member asked Art about his commission, but on the first day when Art Katz presented the amount of his commission to them. But stating the facts would not have given Mike the opportunity to suggest that Art was dishonest in his dealings with the Board.

You might ask why this is a problem. Well, we were in the midst of an election. Mike's remarks, which went unchallenged, were rebroadcast on Friday, June 11, with no opportunity to expose the lies. And the Village Voice carried his remarks and was printed the following week before the formal election. Lies on the part of the Board members can carry a heavy penalty for those whom they lie about.

Another example occurred at the June meeting regarding the censoring of Jack Prosen's "President's Remarks" in the May issue of the Village Voice. You will remember that the front page of the Village Voice where the President's Message normally is printed was blank. Three Board members - Dick Griswold, Mike Shapiro, and Clair Huffman, who was running for re-election — called an illegal Executive Board meeting and voted to censor Jack's message and prevent

it from being printed in the Village Voice. What is printed in the Village Voice is appropriate discussion for a Working Board Meeting, not in executive session. The Association attorney stated that the meeting was illegal and that Board members did not have the right to censor Jack's remarks.

At the end of the meeting, when Board members make their final remarks and cannot be challenged, Dick Griswold stated that he had been on and off the board for seven years and that presidents routinely distributed their remarks to the other Board members and Board members routinely edited the remarks. Well, I served with Dick for almost two years and that never happened the year that I was president nor the THREE years Caroline Pratt was president. As Jack Prosen pointed out, it never happened during his year as president, and prior presidents called to state that it had never happened with

The truth is that at least for the last five years, no president has submitted remarks for editing. They might chose to inform their colleagues of what they plan to write, but the President's Remarks are just that those of the President.

Which brings me back to my first point. What can we do when Board members lie, distort or exaggerate in their closing remarks, and Homeowners have no opportunity for rebuttal if they are being slandered or maligned?

We as Homeowners need to explore a remedy so that misinformation, lies and distortions stated by Board members are clarified in the same issue of the Village Voice as it is printed, as well as rebutted in the rebroadcast of the Open Board Meeting.

Laws govern Boards

In the June 13 issue of the real estate section of the Los Angeles Times, a letterwriter complains of the pushy way an outside management firm deals with her Association's Board of Directors. The Times' advice begins with words of wisdom that should be part of the thinking of every Association Homeowner in Leisure Village.

The Times said, "(Association) Boards do what Homeowners allow them to do."

To know what Boards are allowed to do, every Homeowner should be aware that there are laws governing Associations like ours. Everything done by our Board is governed both by our own by-laws (a copy of which came with your closing documents and a permanent copy is always at the Administration Building for any Homeowner's perusal) and a number of state and federal laws, from the state Corporations Code to the federal Internal Revenue Code.

Every year, nearly 100 separate bills are introduced in the California Assembly that involve the conduct and management of Homeowner's Associations.

But, central to the every-day operation of all Associations is the Davis-Stirling Act, which covers everything from budgets to the election officers to how meetings are run.

Considering the controversy that has erupted over accusations of the Board censoring outgoing President Jack Prosen from publishing his customary President's Page of the June issue of the Village Voice (note Carol Sweeney Zimmet's letter on Page 2), it might be helpful for all of us to have a clear idea of just what our Board can and cannot do in its meetings.

Section 1363.05 of the California Civil Code is known as the "Common Interest Development Open Meeting Act." The Act's sub-paragraph (b) states, "Any member of the association may attend meetings of the board of directors of the association, except when the board adjourns to executive session to consider litigation, matters relating to the formation of contracts with third parties, member discipline, personnel matters, or to meet with a member, upon the member's request, regarding the member's payment of

On August 15, we will screen "Robin Hood," starring Errol Flynn, Olivia de Havilland, Basil Rathbone and Claude Rains, plus lots of other good actors, like Eugene Pallette playing Friar Tuck. We last saw him playing a Friar also in "Mark of Žorro." A few notes:

James Cagney originally was slated to play Robin, but he left Warner Bros. studio before the picture could begin.

The golden horse ridden by Merle Oberon was none other than Trigger, the horse later made famous by Roy Rogers. Its name was not Trigger vet, but Golden Cloud. He was renamed by Smiley Burnett in Roy's first movie, "Under Western Stars," when Burnett told Roy that the horse was sure "quick on the trigger!"

"Robin Hood" was directed by Michael Curtiz, also famous for "Casablanca." He was one of the few directors capable of handling the mercurial Flynn. The other major director was Raoul Walsh, a one-eyed, foulmouthed genius who could bend Flynn to his will. Flynn was usually much



more interested in disappearing into his dressing room behind locked doors for a script conference with an extra than he was in appearing on time for his scenes. Walsh and Curtiz were able to at least keep the productions on schedule, and consequently were paired with Flynn.



Goldwasser, was re-elected Secretary, unopposed, while Goldwasser was elected, also unopposed, to be Assistant Secretary and Treasurer.

After the working meeting, this reporter asked if the three to two split which occurred in the first of the new board's voting was a harbinger of things to come. Frequently, the old board would split three-to-two, with Shapiro and Huffman on the losing sides

Though General Manager Watkins and Board Member Shapiro snapped, "That is an inappropriate question,' it did cast a shadow of the immediate past on the first of what will be many votes to come.

Griswold was quick to offer assurances that, in his opinion, "These are strongminded people and they won't be thinking alike.'

Ellis said he hoped that, "The board will work together for the good of the Village."

Goldwasser, a retired retail store manager whose major campaign issue beyond the universal issues of solving the growing landscaping and street maintenance problems -was to increase the hours that

grandchildren can have access to the pool area, graciously thanked voters and said that he "would do whatever needs to be done to satisfy your needs."

Lorraine, a former Special Education Assistant and an active Association member here and on the board at her previous residence, echoed Goldwasser's sentiment, saying she would "do my best on behalf of Leisure Village.

Losing Board Member Clair Huffman was disappointed that the voters had rejected him. Echoing Richard Nixon's bitter observation nearly half a century ago, after losing the California governor's race, Huffman said, "At least Leisure Village won't have Clair Huffman to kick around anymore.'

Then he took a swipe at General Manager Randy Watkins, charging that "He (Watkins) makes 98 percent of the decisions anyway."

Huffman, whose loss probably can be attributed in part to the write-in campaign, was especially critical of the events that led up to Katz's candidacy, saying, "The answer to the issue was given by the General Manager." He was referring to the legal opinions regarding Katz's ultimate qualifica-

A mission or two you'll really enjoy

From the 1770s to the early 1800s, Franciscan padres came overland from the Mexico area and erected 21 missions, three pueblos (towns), and four presidios (forts) to attempt to convert Indians and exercise control over the area which included much of lower coastal California.

In 1822, when Mexico gained independence from Spain, the area became part of Mexico until 1848, when Mexico ceded the territory to the United States.

For an appreciation of this history, take an on-thespot look at some of these magnificent missions. Several are nearby. Although a few are in Los Angeles and San Diego counties, we suggest the following four from Santa Barbara and Ventura counties for their convenient access and attractiveness.

· Mission Santa Barbara, established in 1786 and known as "Queen of the Missions," is located in central Santa Barbara on Mission Street off Highway 101. An hour's drive gets you there!

• La Purisima Mission and State Historic Park is located three miles north of Lompoe on Highway 246 and an hour north of Santa Barbara. Lompoc is noted as the city in the Valley of Flowers.

· Mission Santa Ines, founded 1804, is at 1760 Mission Drive in Solvang, the "Danish Capital of California," and is about 30 miles from Santa Barbara via the Lake Cachuma pass, Highway 154. To get to Solvang via this route, you'll pass by the Chumash

Casino. You can also stay on Highway 101 to Buellton or, if you visited La Purisima in Lompoc, simply continue on Highway 246 to Buellton.

• The fourth recommendation is almost in our back yard: Mission San Buenaventura, founded in 1782, at 225 East Main in Ventura. It isn't far from City Hall and the Museum of History and Art.

Many Californians try to visit all 21 missions stretching from the San Diego area to Sonoma north of the Bay

Gardens of the World, which is free and is located across Thousand Oaks Boulevard from City Hall and the Civic Arts Plaza, has an attractive garden house with wall murals of California Missions to whet appetites for a large bite of history!

Which childhood pastime turns out to be good for your heart and your head? Ping-Pong, of course.

"I rediscovered the game of Ping-Pong five years ago on a cruise ship," said Susan Brownmiller.

She goes on to tell of her experience playing the game on that cruise ship. She enjoyed it so much, she took lessons and joined an amateurs league.

Dr. Steven Horowitz made precisely the same point about the sport's aerobic benefits for aging hearts, minds and bodies.

"More exciting than a treadmill!" he exclaimed.

I'm on Medicare, and I'm not elderly.

But you wouldn't know it by the way the media portrays older people. They characterize us as frail, old and bent. I'm not like that, and most of the people I know aren't. And even if we were, that doesn't mean that we are over the hill, that we have stopped doing things, or that we need to be taken care of. In fact, many of us are at the pinnacle of our lives, and our view of the future is fresh, vibrant and exciting.

One woman got a tattoo at the age of 70 in order to declare her independence. Others are starting new businesses. Many are becoming proficient on the computer. And what is ironic is that the research doesn't support the media perception of older people that is played out in the media.

· Due to antibiotics and vaccines, the average life span during the 20th century increased from 47 to 76

· One hundred years ago, the average American could expect to live to age 47. Today life expectancy in the United States has skyrocketed to age 77, and the average retiree spends almost 20 years in retirement. (Dychtwald).

• The 55-plus age group (Baby Boomers) has become the fastest-growing segment, with almost 60 million people.

• Franklin D. Roosevelt established the Social Security Act partly to "prevent a poverty-ridden old age." In the past half century, our age group has gone from being the poorest segment of society to being the richest through a combination of saving, investing, pension programs and the windfall profits from rising home costs.

· This doesn't hold true for Baby Boomers, those who are approaching retirement now. Many Baby Boomers won't be able to afford traditional retirement, even if they wanted to. A full 40 percent have less than \$10,000 in personal savings.

• In 2002, the National Council on the Aging published "American Perceptions of Aging in the 21st Century." The study projected on the myths and realities of aging and focused on ages 65 to 74 and those 75 and older. The

match the media portrayal


of aging. :'
In "Who Moved My Cheese," author Spencer Johnson, M.D., points out that we pretty much get stuck in our everyday life. Moreover, if something happens to disrupt our way of life, we don't adapt too quickly. In fact, we keep expecting things to be the same as they were.

That helps to explain why the media's perception of how older people are doesn't really reflect on how we really are. We are dealing with other people's expectations of what a person over 65 is like, not how we are. And since they were stuck, they kept going back to their old stereotypical perceptions. Moreover, if we keep responding in the old way, we, too, would be stuck.

Middy Dychtwald has written a new book titled, " Cycles: How We Will Live, Work and Buy." It is really targeted to the marketing community, but it has a lot to say to us.

She points out that "older women are still invisible to most marketers. Yet this population is 'low-hanging fruit,' eagerly looking for opportunities to buy products that help them look

Our place in the sun

Until the sun goes down, there's no need for a watch in Leisure Village, thanks to Marty Ettinger, a Village resident since 1985, and Ron Stave of the Woodshop Committee. They're responsible for guaranteeing an up-to-the-minute, as modern as you can find, foursectioned sundial by the swimming pool.


The story actually began in 1989, after Marty read A.E. Waugh's book, "Sun Dials, Theory & Construction." He and Clary Morgan, since deceased, built and installed an exotic sundial that survived 14 years of exposure to sun, wind and rain. just enough exposure to convince Marty it was time for a facelift, which is what brought him to Ron.

Because of Marty, we know that sundials can be small enough to hold in one's hand or as big as a building. The only moving parts they need are the Sun and the Earth. They are noiseless and nonpolluting, require no maintenance and are guaranteed for life, if the elements are not too harsh.

The key to a sundial is its gnomon, the part that casts the shadow on a plate marked with the hours of the day. As the Earth rotates, the Sun appears to rise in the east, moves in an are across the sky and sets in the west. That movement casts the gnomon's shadow onto the plate.

Because the Earth's journey around the Sun is elliptical, rather than a perfect circle, its speed, relative to the Sun, varies. This variance makes sun dials appear to "run" either fast or slow. A graph at the front of the sundial's assembly illustrates astronomical calculations of these differ-

The Earth completes its 360-degree journey around the Sun every 24 hours. This translates into 15-

degrees movement for every hour, which explains the line set-up on the dial plate

When the Sun is at its highest point in the arc, between rising and setting, it is at noon, which is where we got the expression, "high noon.'

At high noon, the Sun is directly south of us. Pacific Standard Time (PST) is at 120-degrees west longitude.

However, since Camarillo is located at 130-degrees west longitude, and the Sun appears to be moving east to west at the rate of 4 minutes for each one degree of longitude, a sundial here will read 4 minutes before actual high noon.

This variance is built into the Leisure Village sundial with the gnomon set at an angle equal to the latitude of its location above the Equator, which is 34degrees north for Camarillo.

Some years ago, a high school student figured out a way to use a homemade sundial to find his directions. It is a trick so good that the Air Force included it in its Survival Manual. All it requires is some sunlight, a sharp, narrow stick and a couple of pebbles.

Put the stick, your gnomon, in the ground. Mark the tip of its shadow with a pebble or anything, another stick if need be. An hour later, mark the tip's shadow again. The line between the two markers is true eastwest. Then, another line through that line will give you true north-south.

Sometime in the near future, Marty Ettinger plans to share more information in a talk and demonstration on the ancient subject of sundials.

A money-saving story: Now there's a change

Most of the stories about the Village's future warn of ever-increasing costs which translate into ever-increasing assessments. From the farthest street to the nearest tree or bush, we are told to be prepared to spend more and more, often just to keep up with immediate demands, to say nothing of unexpected surprises that may lurk around this or that corner of tomorrow to bite us in the budget.

This is a story about how the Village may soon begin saving money that all too often just goes down the drain.

It involves one of our costliest and increasingly threatened resources: water.

Each year, on average, the Village uses 208,217,000 gallons of water, most of it for landscaping. All of it is potable, or fit for human consump-

We spend \$540,000 a year on water. Of that, 26 percent, or \$142,464, goes to the Camrosa Water District to deliver safe and reliable water day in, day out, whether through faucet, spigot, showerhead, sprinkler, lawn hose, decorative fountain, or even a


fire hydrant, to ensure we get the quality and quantity of water we want.

Of the remaining \$397,500 bill, 71 percent, or \$282,200, pays for water for direct landscaping use. I say direct because all across the Village, with very few exceptions, every home sports at least one garden hose and two outside spigots. There is no way to figure out how much of the remaining 29 percent, or \$115,300, of that drinkingquality water is siphoned off for what might be called 'personal" landscaping.

It is not uncommon to see garden hoses, often 75 or 100 feet long, stretched from a residence to a tree or a spot of turf the homeowner treats as though it is his or her private property. In this way, residential drinking water is being used on the common area that is also being watered by the Village's landscaping sys-

Regardless of the uses any of us find each day for water other than to drink, cook or bathe, it is costly and wasteful to pour drinking-quality water on everything that grows or gets dirty.

We're in the lion's den

Leisure Village is under relentless attack. The enemy is as fearsome as a lion's tooth. In fact, the beast is a lion's tooth, more correctly, the "dente-delion," French for dandelion, so named because of the shape of its leaf.

Those who see the dandelion as nothing more than an unsightly, prolific nuisance should take heed. As this writer recently learned, the dandelion is one formidable opponent.

My run-in with the bothersome plant reached a peak at the Association Board meeting in May, when I lugged three massive, 36-inch-tall dandelion plants up to the speaker's podium just to show what was going on in Village 9 while the landscaping crews were otherwise occupied.

Since then, I have learned a great deal about our landscaping and about the weed that many prize for its young leaves in salads, others actually ferment to make wine and beer, and the others who say it has many other uses, not the least of which is as an herb which is seen to have curative powers.

For the rest of us, the dandelion is just a bother-some landscaping problem.

Let's start with the plant itself. Thanks to the Web site of the University of California-Davis, we learn that while the plant's root is usually between 6 inches to 18 inches, it can go down as much as 10 to 15 feet and grows just about anywhere, even if you lop off the top. Just leave an inch or so of root, and you'll still have dandelions.

And once a dandelion decides it has found a home, you'll play hell trying to get rid of it.

Its little seeds, those parachute-like wisps that float around in the late spring, are actually hundreds of seeds cleverly disguised as the stuff of which fairy tales are made. And if that doesn't work, lawnmowers, blowers, the bottoms of your shoes, whatever it takes — the dandelion knows how to get its seed

around

Oh, and it loves turf and irrigated landscape. Did somebody say Leisure Village?

When I offered my weeds to the Board as proof of somebody falling down on the weeding, General Manager Randy Watkins said he would have then-Landscape Supervisor Carl Waite, who has since resigned, contact me. He did.

That's when I learned that our meager troop of gardeners is no match for the well-entrenched, battlehardened dandelion army that has taken up residence with us.

The weeding and shrubtrimming crews reach each Village on a three-month cycle, a schedule dictated by resources (crew, equipment, budget, etc.) and the Board. It is understandable that weeds, especially dandelions, seem to linger so much longer than one would ordinarily expect in a development of this quality.

Since hand removal or spot treatment with the herbicide glyphosate of single dandelion plants will "save time and money in the long run" (UC-Davis Web site), and most other methods are 50-50 at best for controlling them, you have some idea of what we are up against.

These little beasties clearly cannot be controlled by ignoring them for three months at a time, nor by merely cutting them off at the ground line. The kind of battle that must be done to bring the dandelion population under control, or to cut it off, requires more money and manpower than it appears likely the Board could or would ever allocate to the task.

So, what to do?

Perhaps we might all seriously consider carrying a large screwdriver or similar tool along when we walk our lovely grounds. Let's take the battle directly to the enemy. Because, you see, it appears that we, singly and collectively, are the last line of defense in this never-ending struggle against "the tooth of the lion."

Enhancing the value of your home

The Architectural Committee is asking for your cooperation to insure consistency regarding the color, panel and window style of newly purchased garage doors. This picture illustrates the problem.

The garage door on the right was put in first. Unfortunately, the owner to the left did not get a door to match his roofmate. In addition, there is no Architectural Permit which is required — on file. As a result the non-compliant owner has agreed to have the plastic window inserts changed in order to match his roofmate and to


improve the front of his home.

Your garage door is the largest single architectural element in the front of your home. When your door is combined with your roofmate, the garage doors become the dominant feature to the front of the building. This is the reason why it is so important that the garage doors match and also that the style be compatible to our Southwestern Ranch Architecture in Leisure Village.

If your roofmate has already replaced the garage door, please match your doors as closely as possible. If the neighbor doesn't have the name of the manufacturer or dealer's name, the LV Administrative office maintains a file on each residence, and a copy of the Architectural Permit for their address may be in the file with this information.

If you are first to do the garage door replacement, please talk to your roofmate or neighbors about style and plans. The advantage of ordering together is a better price and a better-looking building. Include with your Architectural Permit four copies of the picture of the style chosen.

Window retrofits also require an Architectural Permit. The color of the frames shall be almond or like color, tan, beige but not

pure white or black. The color is to blend with the stucco color.

Front entry doors may be painted L.V. colors or be a finished wood type with or without window - just supply a picture. No pure white or black doors are allowed

as this would not be compatible with our exterior color scheme. Screen door colors must also be compatible with the front door or the color of the house trim. An Architectural Permit is required, along with a catalog picture.



tion as a legal resident of the Village.

"But the issue was never submitted to the Board of Directors," Huffman concluded.

Outgoing Board President Jack Prosen, who did not seek re-election, insisted that the matter was, "pure legal, non issue," that was not a problem that had to be resolved by the Board.

"The only time we had anything to say," Prosen noted, "was through the Nominating Committee. And the moment his (Katz's) eligibility was seriously challenged, the Committee removed his name from the ballot."

Prosen was also quick to defend Watkins.

"Randy probably knows more about Leisure Village than anybody else. He answers every question when he is asked. And," Prosen put heavy emphasis on this point, "he gives us facts, not opinions."

As for his own future,

Prosen says that even though he plans to relax more, "I am not finished, not by a long shot.'

The former financial adviser says he is determined to find financing solutions now so as to pay for immediate work on critical projects, such as landscaping and street maintenance.

Prosen said, "I still have a lot of work to do."

While the turnout was impressive compared with increasingly disappointing voter turnouts in the general population nationwide, the number of eligible voters casting ballots likely caused the defeat of two ballot issues that both carried the popular vote.

Two-thirds of all the Village's eligible voters were needed to vote yes to change the CC&Rs regarding dividing fences on rear patios. The popular vote was overwhelmingly in favor of the change that had been recommended by the Architecture Committee but was short of the required two-thirds needed.

A large majority of those voting also favored changing

the Association by-laws to allow the establishment of a gifting committee. But, to change by-laws, the required number of votes had to be a majority of all the Village's eligible voters. In this case, the 912 yes votes (216 voted no) were about 150 short of the formula required for passage.

In both cases, other legal means to achieve the objectives are still available should the Board of Directors choose to pursue them.

The remaining ballot question — whether or not to expand the Recreation Center Annex — which needed only a simple majority of the votes cast, passed easily.

In spite of what he told me, I cried for a week, but not having any choice, I listened to him and went to my appointment to meet the doctor and discuss the

To my surprise, when this young man — tall and imposing — came into the room and introduced himself, I thought it was a mistake and I had misunderstood. How could this young man, who looked to be just out of school, know so much about eye surgery and glaucoma? When did he get his experience? However, when he sat down opposite me and started to talk in his kind and gentle voice, somehow I felt better and my fears disappeared.

After he examined me thoroughly, he told me what could happen but not to be afraid because he was going to try his best to make the operation successful.

Encouraged by his kind attitude, I went to the hospital on the appointed day with dry eyes and confidence in this wonderful young man. Needless to say, the operation was a success, and everything went smoothly. Though he prescribed glasses, I don't wear them because I'm more comfortable without any glasses and wear only the dark ones when I go out in the sun.

About three to four months after the operation, by mistake on a windy day I went out for my daily walk without my dark glasses and something blew into my eye and it started to get red and painful. In a panie, I rushed

to the phone and called the doctor's office, but it being a Saturday, the office was closed. I left the message with the answering operator, and she said she would get back to me as soon as she told the doctor. A few minutes later she called back and told me that the doctor would meet me at his office in an hour. When I got there, he was waiting for me with one of his nurses that he had called in to assist him.

I didn't expect him to open his office on his day off — a Saturday — and was sure he would send me to Emergency because I was a total stranger, no relative or close friend. But to him, I was his patient, and he felt responsible for my health, and he took care of me and the infection.

How can I forget this wonderful, dedicated young gentleman who, after so many years, treats me with the same kindness, respect and friendship that he always has ever since I met him?

assessments."

The law very clearly protects each association member's right to speak at any

meeting of the Association, except when the board meets in executive session.

But, to emphasize, the law strictly defines what the Board can do in its executive sessions. It may consider only those matters that involve: (1) litigation; (2) third party contracts; (3) member discipline; (4) personnel matters; and (5) an Association member's request regarding assessments.

Next month, I will review the law regarding reserve studies and funding.

More and more, across our increasingly drought-plagued nation, communities are being forced to confront a critical question: Do we need and can we afford to use drinking- quality water for everything we do, from washing our cars to hosing down our patios and driveways?

According to Board Member Bob Ellis, who also chairs the Ad Hoc Water Committee, "There is a partial solution to this absurd waste of such a valuable resource. It's reclaimed or recycled water. If all goes according to plans, later this summer Leisure Village will become one of the leading communities to get the benefits and the economic savings that come from using that water."

Possibly as early as August, working closely with the Camrosa District, the pumps and sprinklers that provide the water for the 18.5 acres of the front nine holes of the golf course will be switched over to be irrigated by reclaimed water.

What does that mean to

Here's where the economics come into play. Reclaimed water will cost approximately \$200 per acre foot, compared to the \$622 per acre foot (326,000 gallons) we now pay to sprinkle drinking-quality water on the area. It now costs slightly more than \$24,000 a year to water the front nine. The cost of reclaimed water will be \$7,700 a year, a net savings of more than \$16,000 a year.

Present planning envisions the day when all of the Village's landscape water will be reclaimed or recycled. Assuming costs remain relatively unchanged, it is possible that the overall savings could approach \$190,000 a year.

Camrosa gets the water we will use from the City of Thousand Oaks' multimillion-dollar water treatment plant in Hill Canyon, not far from Leisure Village. Meeting tough federal requirements for water quality, the plant processes some 10 to 14 million gallons of wastewater a day. Stripped of its solid matter and contaminants, the reclaimed water is then sent into the Conejo Creek that runs along the eastern edge of Leisure Village.

Just south of the Village, on the other side of Highway 101, about 10 million gallons of that water is diverted and sent to holding ponds down by the California State University-Channel Islands campus. There, as needed, Camrosa's giant pumps send it back along distribution lines to reclaimed water users which, today, are mostly agricultural but do include new communities like the upscale, gated community of Camelot, about three miles northeast on Santa Rosa Road.

In fact, the Camrosa Water District now requires all new communities it serves to install double plumbing systems, one for potable water inside the residence and the purple piped plumbing that carries reclaimed water for non-residential uses.

Those concerned about the quality of this reclaimed water need only look at any point along the Conejo Creek, from Hill Canyon to the Pacific Ocean, where thriving plant and wildlife are now being nourished by the same reclaimed water.
