Public Comment - Shirley Jewett, publisher of Ventura County Woman Magazine, discussed the availability of a \$114,000 grant in the city of Simi Valley and requested any information on potential grant writers to help prepare a proposal for a women's center.

- Financial Report Commissioner Flock As of January 1, 1988, with 54% of the fiscal year elapsed, 31% of level 1000 funds (salaries and employee benefits) and 34% of level 2000 funds (services and supplies) have been expended.
- VI. Correspondence Report - Commissioner Witting A copy of the complete correspondence report is available in the Commission office.

In response to an invitation from the State Commission on the Status of Women to participate in the March 1 Women's History Celebration program and display, the Commission voted to work with representatives of the Ventura County Historical Society to submit a picture and information about Candelaria Valenzuela, last of the Sespe Chumash, as our contribution to that program.

VII. Staff Report - Martha Baskerville Commission Secretary, Linda Henry, hired as an extra-help county employee, is now a permanent employee.

VIII. Friends of the Commission

The Commission feels the current procedure for requesting funds from the Friends is not satisfactory.

There was a discussion on the roles of the Commission and of the Friends.

M/S/P, Albert/Engel: to set up a committee to look into the process for setting up and using a trust fund within the County in the name of the Commission for Women. The committee will report at the February meeting.

M/S/P, Hubbell/Harris: that co-chairs are directed to draft a position statement to present to the Friends re: funding procedures and a freer mechanism for access to funds. The position will be presented to the Friends at their Feb. 16 meeting with the goal of reaching a mutually satisfactory resolution of this situation. The position will be communicated to Commissioners prior to the Friends meeting.

### IX. Task Force Reports

#### A. Education

 "Salute To Women" - Commissioners discussed the results of the banquet evaluation meeting on Jan. 14. A full report of that evaluation meeting was distributed and is available in the Commission office.

Commissioners decided to suggest to the Friends that the 1988 awards banquet be held in the western end of the county.

3. Women in Agriculture - Karen Flock
The members of the Women in Agriculture committee
finalized a mission statement for their committee.
They have agreed to support a conference being organized
by the Clinicas del Camino Real, "Conference de la Salud
Para La Mujer y La Familia", a conference on health issues
for women and families.

The third annual Women in Agriculture Forum is tentatively scheduled for Oct. 22.

M/S/P, Flock/Estrada: to send a letter to the Chairman of the Board of Riverbend Farms, owner of Rancho Sespe, to allow families currently living at Rancho Sespe to remain until new replacement housing is completed.

B. Child Care

M/S/P, Hubbell/Warrington: to allow free copies of the KISS brochure and the Proceedings of the Employers' Symposium on Child Care to individuals whose school projects are related to employer-assisted child care.

Commissioner Engel reported on activities by several organizations in the county to address the issue of employer assisted child care, including the County personnel office, Ventura Parks & Recreation Commission, Ventura Boys' & Girls' Club, and the County Superintendent of Schools office.

- C. Family Law Task Force Susan Witting
  A report was presented on final plans for the Family Law Forum scheduled for Feb. 6. at the Thousand Oaks Library. The Commission had requested up to \$500 be available from the Friends for the forum. The Friends approved up to \$200. The presentations will be videotaped.
- D. Housing Task Force Karen Flock The members of this task force will take an extended tour on Feb. 25 of Housing Authority and other affordable housing projects in the county. The Housing Authority has now taken over ownership of the Meiners Oaks low-income housing project. It has 34 units.
