# What is Liquefied Natural Gas (LNG) and why is it coming to Ventura County's Coast?

LNG is natural gas that has been super-cooled until it becomes a liquid, so huge quantities will fit in a tanker. If there was an explosion on an LNG tanker, it could have the power of a small nuclear weapon. **This is why LNG tankers and terminals are considered a prime target for terrorist attacks.**

## **LNG is an outdated energy source that is being promoted to benefit big corporations at the expense of our communities and our environment.**

Big oil companies and their allies in both Washington and Sacramento don't want you to know this, but we have better, safer, cleaner ways to meet our energy needs.

- Homeland Security has named LNG tankers and terminals as high-risk terrorist targets. An untested Liquefied Natural Gas terminal has been proposed to be constructed close to vital shipping lanes as well as the Channel Islands National Marine Sanctuary.
- The risk from Liquefied Natural Gas doesn't stop at our coast. There are proposals to run high-pressure gas pipelines under Ventura County's communities and near multiple school sites. These new pipelines could lower local property values and threaten our children.
- There is no credible evidence that California needs Liquefied Natural Gas! California's Energy Commission has predicted that California will have adequate natural gas supplies for the next ten years without importing any LNG.
- LNG is just another polluting foreign fossil fuel that leads to global warming, rising ocean levels and increased air pollution.
- Money should instead be invested in solar power and other safe, clean and renewable sources of energy to protect our communities and future generations.
