PRESIDENT'S REPORT: Lee announced that Maria Cruz is the new Friends treasurer. Lee presented and distributed copies of Commission for Women priorities as determined from information gathered by Needs Assessment (a copy is attached to the minutes). - SALUTE TO WOMEN BANQUET: Lee reported that the Commission approved the two-tiered price concept with tickets being sold at \$50 and \$25. Following a survey of Commissioners, Candy reported that the names of Maureen Stapleton and Tyne Daley were recommended by the Review Committee as speaker candidates for the banquet. Margarita will contact Maureen Stapleton and request an answer within one week. Maria moved and Bonnie seconded that \$500 be budgeted for an honorarium for the banquet speaker. Motion passed.

Margarita will contact Maureen Stapleton and Tyne Daley and report the results to Lee. If neither speaker candidate accepts, Lee will call an emergency meeting to consider other choices.
