





In the November issue of Village Voice, President Sweeney requested homeowners to submit complimentary articles that reflect some of the good reasons for living in Leisure Village. As one of the people who have written several articles critical of the Board, I believe it behooves me to acquiesce to this request.

There are many areas where I can honestly say how great it is to be living here. We have many caring and concerned neighbors. The facilities available to us are second to none. The security department, under Jim Moore, is now superb (I must compliment the previous board for having the intelligence to promote him to that position). The grounds, under the supervision of Carl Waite, are looking lovely. And our thanks should certainly go to all the committee members who put in so much time and effort to help make this Village such a desirable place to live.

Regrettably, apart from Director Huffman, who is the only current Board member who has lived up to his pre-election promise of openness and honesty, none of the other board members share in the accolades for most of the above. I could list many incidents where the Board is guilty of dubious practices and lack of candor, but I will limit my comments to just two areas.

In the recent vote on the change in the CC&Rs, the Board extended the time limit twice to ensure that a

quorum was reached. They even went door to door asking people to vote, while in the meantime, the general manager was obviously making a daily tally until they had established that enough people had voted yes, whereupon they promptly shut-up shop and rushed the change to the Ventura County office to have it recorded.

The other incident I would like to relate concerns an article by Jack Prozen, also in the November issue of Village Voice. He stated that the Village had \$88,000 in claims last year and this was the reason our insurance premiums went up by 353 percent. He is either woefully misguided or considers that all the homeowners are naive to believe that. Apparently not too many homeowners are aware of the real reason for this monumental increase, namely, the out-of-court settlement of lawsuits totaling more than \$350,000 that were the result of incompetence on the part of our general manager. This is a prime example of deception and a cover-up on the part of the current and the previous board.

In closing, I would make a direct comment to Ms. Sweeney. In your article, you asked Sandy Okum to

publish any positive comments submitted to him by homeowners in any future editions. Knowing Sandy to be a man of the highest principles and totally honest, I am certain he will do as you request. May I, therefore, suggest that the board members emulate his honesty and be truthful and forthcoming in their future dealings with all the homeowners?

I asked our General Manager, Randy Watkins, for guidance as to that part of my residence for which I would now be responsible and, therefore, need to insure. He very promptly and courteously answered my question as to items listed below of which I was in doubt. Perhaps there were others that I should have questioned, but I think those of which I did ask were sufficient for me to seek information as to cost so that I might competently adjust my HO-6 policy.

The following, at least, are the responsibility of the homeowner:

- 1) Interior and exterior electrical wiring.
- 2) All built-in cabinets and counters, including sinks, tile and marble, etc.
- 3) Exterior and interior

doors, including garage doors, screens, windows, and window frames.

4) Heating and air conditioning units and ducts.

5) Plumbing fixtures, hardware, all bathroom facilities, etc., such as shower, bath, toilet installations.

6) Interior plumbing.

7) Interior ceilings.

8) The attic, other than the upper structural components (roof).

9) The interior of the exterior wall from the unfinished interior surface.

10) Patio enclosures, except for the structural components which the association covers.

11) All appliances, floors and floor coverings and wall coverings.

12) Fencing/block walls and red staked exterior planting

13) In the event that the association shall determine that damage to the structure is the result of negligence in whole or in part of the Homeowner, the Homeowner shall be responsible for a proportionate amount of the loss not paid by the association's insurance policy up to a maximum of \$25,000.

Really, it appears that the Homeowner is responsible for the entire residence except for the structural components — and, if Rule 20-11 is adopted, the bare interior non-bearing interior

walls — and may be responsible for structure components if their damage is due to the negligence of the Homeowner. I would assume that the slab is part of the structure.

I am not very conversant with residential building costs today. If any of the readers of this can give me some suggestion as to the cost of replacing all of a La Jolla unit except for the structural components but including a potential responsibility for \$25,000, I would appreciate their advice. Without that aid, I must assume that I will need an absolute minimum of \$100,000 coverage.

I have been informed by AARP/Hartford Underwriters Insurance Co. that a very

basic HO-6 policy covering \$100,000 dwelling, \$15,000 minimum personal property, \$6,000 loss of use and \$100,000 liability would cost approximately \$515 a year. With my higher personal property, loss of use, and liability, I, of course, have more personal property, loss of use and liability coverage than that, and my policy is now in excess of \$1,000, and I am almost certain that my \$100,000 building coverage is inadequate.

And remember to get coverage for a replacement residence while fire damages are being repaired, plus legal liability for damage to your neighbor's resident for any fire starting in your residence.

I served on the Executive Ad Hoc Committee on Insurance, and was quite verbal about the wisdom of repiping before our homes are damaged by a leak. I "bought a price" when I contracted with Pacific Coast Copper Repipe Inc. — they were cheaper. They did the work on March 7 of 2002.

One Sunday last August, I walked barefoot into my enclosed patio, which is carpeted, and it squished. Since the squish was near the outer wall, I assumed that something had gone wrong with the irrigation system. Early Monday, Judy Young came over and had the irrigation system checked; it was not leaking. Judy called Bob Swazye, who checked the outside of

the house and found the leak in the wall. My new pipes had sprung a leak and ruined my carpet.

I called Pacific, and they had someone who was working in the Village come over, find and fix the leak within about four hours of my call. They also agreed to pay for the new carpet, told me to order it, have it installed and send them the bill. I did not charge them for painting over the newly made hole in the wall.

I sent them the bills for my new carpet on Oct. 7. By late December, I had yet to receive reimbursement. I have heard more renditions of "the check is in the mail" than I knew existed. At one point it slipped out that the man who led the crew that worked on my house was no

longer with the company. Since the bosses couldn't take the money due to me out of his hide, they are obviously not willing to pay it themselves, in spite of a commitment and the fact that their work is supposedly guaranteed for 10 years. I plan to take them to Small Claims Court.

My reason for sharing this with the Village is: 1) I'm angry, and 2) I question how quickly my leak would have been fixed if Pacific didn't have people working in the Village. Some day they are going to finish their work here. I wonder how responsive they will be in sending workers to address a problem in Camarillo when they have to be dispatched from Anaheim?

Emergency drill is now being planned

Within a few weeks, all Villagers will be asked to put a flag out in front of the house as a signal that "all is well" at that address. This is an emergency drill system designed to let our 44 Village coordinators quickly review their respective villages in search of those who might need help in a real emergency.

"Like a fire drill, we need to constantly practice the safest method for us to provide necessary services in a disaster situation. If each Village Coordinator had to ring 75 door bells and wait for replies, it would take about an hour to cover their territories," remarked ESO Co-Chairman Art Thomson.

In addition to the flag count, a special emphasis will be placed upon the need for every Villager to know how to quickly tape-up and seal-off a room in the house as a safe location in case of a toxic spill up on Highway 101 or out on Santa Rosa. In the "Hazmat" (hazardous material) world, this is known as creating a "Shelter in Place," and it usually involves taping the bedroom window

and bathroom window, all edges of the bedroom door, and covering all existing heat and air vents in that area and turning off any air-circulating devices which might pump fumes into the sealed room. This leaves the resident with an area that provides shelter, running water, phone, and other facilities until such time as it is safe to leave the sealed area.

This is a village of volunteers. About 100 volunteers will take part in this emergency safety exercise, and all residents are encouraged to "put out their flags" and to also add a short strip of duct tape to that flag to show that they really do understand how to prepare a "shelter in place" in case of a surprise toxic spill. Instruction pamphlets are available in the Leisure Village Rec Center.

Last June, there was a small toxic spill up the hill on Highway 101, at the weigh station. Fortunately, Hazmat rapidly dispatched several teams and was able to download the toxic material into another tanker truck without harm to anyone.






