Background:

Various government bodies and public organizations offer recognition to others for various reasons. The VCCW Chair offered a resolution for VCCW, proclaiming an organization's excellence, prior to a vote being taken. The VCCW asked that a policy and perhaps procedures be developed and drafted for discussion for the September regular meeting.

Research

Resolution:

Wikipedia: "A firm decision to do or not to do something. A formal expression of opinion or intention agreed on by a legislative body, committee, or other formal meeting, typically after taking a vote." "A resolution is a written motion adopted by a deliberative body. The substance of the resolution can be anything that can normally be proposed as a motion. For long or important motions, though, it is often better to have them written out so that discussion is easier or so that it can be distributed outside of the body after its adoption. An alternate term for a resolution is a resolve."

Robert's Rules of Order, "Motions Submitted in Writing: Resolutions. And speaks of the use of a preamble using 'Whereas and Resolved'" page 100-102.

Presentations:

Presentations or awards, perhaps for excellence, may recognize contributions that exemplify outstanding effort that might stress practical, documented work that demonstrates leadership and promotes the empowerment and education of Ventura County Women.

Proclamations: "An official declaration", a "formal announcement" Wikipedia: "In English law, a proclamation is a formal announcement ('royal proclamation'), made under the great seal, of some matter which the King in Council or Queen in Council desires to make known to his or her subjects..." A Presidential Proclamation is a statement issued by a President on a matter of public policy....generally defined as, 'The act of causing some state matters to be published or made generally known....Generally there are two types,..."ceremonial," which designate special observances or celebrate national holidays, and 'substantive,' which usually relates to the conduct of foreign affairs and other sworn executive duties." Examples of famous proclamations are "George Washington's Proclamation of Neutrality in 1793 and Lincoln's Emancipation Proclamation in 1863." Other more recent proclamations were President Richard Nixon pardon (1974), pardon of Vietnam War draft evaders (1977), clemency of Lewis "Scooter" Libby's prison sentence (2007), Bush's proclamation to honor veterans of World War II, and Reagan's proclaiming "Save Your Vision Week."

Commendations

Wikipedia: An award for some meritorious service. There are military commendations and federal government civilian awards. NASA is one department that accepts nominations for commendations. Their website offers Recognition Tools which include suggestions for writing a winning nomination, making good award selections, etc. This could perhaps provide a guideline for VCCW to develop policies and procedures in which it might offer commendations to its own members. "NASA employees are dedicated to doing a good job – and our leadership communication role is to make sure they know what that good work is."

<u>Policy</u>: It should be the policy of VCCW that "Presentations, Proclamations, Commendations and Resolutions" must follow Robert's Rules of Order. The procedures to follow must still be developed. An Ad Hoc Committee may be appointed for this purpose. This committee may also answer who is VCCW to recognize and is VCCW to only recognize and honor women, and women's organizations or accomplishments of others that impact women and families?

Documentation for Appointments of Commissioners

The meeting was very positive with information shared by all. The County has opened a Satellite office in Thousand Oaks on Hillcrest Avenue at Under One Roof where CalFresh, MediCal, and CalWORKS services are offered. The County has conducted 9 successful focus groups, "The Voice of Employees" in which Ms. Kroth took part. She felt having a "captured" or committed participants would be an important factor to the group's success. Ms. Kroth volunteered to send us a list of public meeting places that VCCW might consider for its Focus Group meetings. She felt that the definition of a "public place" was one paid for with public funds and open to the public. Recycled materials were mentioned by both parties as a possible source for VCCW to obtain such items as binders. Some requests were outside of Ms. Kroth's jurisdiction but she gave suggestions for our further research.

In addition to serving as the VCCW liaison, Ms. Kroth also partners with other organizations including Foster Parents, and Coalition for Gang Violence Prevention. Internally her tasks include recruiting volunteers to review applications/proposals seeking grants for youth, reviewing Spanish Language documents, and assisting groups in accessing County services such as the Mixteco population.



Bylaws: Section 5.1 Executive Committee

- A. The Executive Committee shall be composed of five (5)-members, preferably one representative from each Supervisorial District.
- B. The three (3) Commissioners from each Supervisorial District shall meet in June, prior to the annual July meeting, to select their representative to the Executive Committee. If there is no one able to serve as the representative, a commissioner from another district may be chosen to serve on the Executive Committee.
- C. The Executive Committee shall consist of a chairperson, a vice-chairperson, a treasurer, a recording secretary and a corresponding secretary.
- D. All officers shall be elected from among the Executive Committee members by a majority vote of all Commissioners present at the July meeting and shall serve a term of one year.
- E. Should the Chair be unable to fulfill her term, for any reason, the position will be filled by the Vice Chair for the remainder of the term of office.
- F. Should any other vacancies occur on the Executive Committee, one of the remaining Commissioners from the district in which the vacancy occurred can be nominated to fulfill the term of office. The position must be confirmed by a majority vote of Commissioners present at the meeting in which the nomination was made.
