Villagers Hear **Measure H Debate**

On Friday, October 31st, in the Assembly Room, the Issues Forum Current presented a review of the November ballot propositions and a debate on Measure H. Chaired by Harry Becker, the meeting opened at 7:30 to an audience of about 300 villagers.

Becker first introduced Janet Beamer, from the League of Women Voters. She has been the Secretary-Tresurer of the Ventura County Association of Water Agencies and is also a member of the Ventura Environmental Council.

Mrs. Beamer briefly explained the state propositions and noted the five which the League had formed a consensus to support. (They do not make recommendations in opposition.) The League recommended passage of (1) Parks and Beaches, (2) Lake Tahoe, (4) Property Tax Limit, (8) Water Resources, and (10) Non-Smoking Areas. Of these, only (1) and (8) passed. Of the six propositions without League support, four passed.

Becker then introduced Bill Frank, Division Engineer of the Ventura County Flood Control District, favoring Measure H, and self-described rancherengineer, Don McIsaac, opponent.

Frank spoke first, using a chart to show flood district funding scources and a map depicting the county districts. He stated that only property taxes, approximately 5 per cent of the total district's funding, plus unpredictable state aid could be used for maintenance. The balance of the funds is required by law to be used only for facilties and construction. He stated that cleanout of the Conejo Creek would cost a half to one million dollars. For comparison, he said that this year \$660,000 of tax revenue had been spent for maintenance.

Don McIsaac spoke next. He was outstpoken against various county projects seemingly undertaken in order to qualify for Federal matching funds. He

claimed that county creeks presented no problems until the district started working on them. He argued that the measure was really an openend tax increase, the public not being shown Ordinance SE26 which the measure would activate. This ordinance prescribed the formula which established the fee rate. It was based on technical assumptions which could be changed without a vote. He admitted that if the measure defined specific flood control problems with estimates of their costs, he might support it.

Frank's rebuttal claimed the ordinance was simply legalese and that many hearings had been held with scant public attendance.

McIsaac's summary reemphasized his preference for specific projects and costs rather than the blank check he called the measure.

Frank's brief summary stated that the measure was the result of a year's study and believed to be a reasonable method of financing maintenance work.

Becker opened the meeting for questions. Some of the questions were:

Q. Will Conejo Creek be cleaned out?

A. It is on the list but there is no definite date.

Q. Does the measure permit yearly increase in the fees?

A. Yes, but there is some limitation on the increase.

Q. What is the effect of the recent fire?

A. A three to five fold increase in run-off generally, but the effect on Conejo Creek has not yet been evaluated.

Q. Isn't the ordinance virtually identical to one recently passed in L.A. County?

A. Yes, except that in Ventura County large land owners received a better break

Q. Is the \$7 fee too much? Why oppose such a small amount?

A. McIsaac considered it illegitimate and he opposed it on principle.

The meeting was adjourned after two hours of interesting, informative and sometimes heated discussion.

Year of the Coast

"The California coastal zone is a distinct and valuable natural resource of vital and enduring interest to all the people and exists as a delicately balanced ecosystem." (California Coastal Act of 1976).

Interest in preservation of the coast took the form of action in California in 1965 when citizens in the San Francisco Bay area realized that developers were filling in the bay to build recreational, commercial and housing facilities and formed the San Francisco Bay Conservation and Development Commission.

The tide of interest swelled. In 1972, the Coastal Initiative (Prop. 20) passed as the result of effort on the part of many citizens throughout the state. A State Coastal Commission and six Regional Commissions were set up as a temporary measure to grant interim permits and formulate policies. In the same year Congress passed the

Coastal Zone Management Act providing participating states with funding to develop comprehensive programs to protect and manage coastal areas.

In 1976, the legislature passed the California Coastal Act which requires local governments to prepare Local Coastal Programs by July 1, 1981. The Act explains in detail how coast resoures will be managed. Many of these Programs are being prepared now by the 15 counties and 52 cities in the Coastal Zone, which is 1100 miles long and extends 3 miles out to sea and 1000 yards inland or to the crest of the coastal range as in the Santa Monica mountains. The San Francisco Bay Area is excluded because its plans were under way prior to 1972.

We in Leisure Village live in one of the Coastal Counties responsible for a Local Coastal Program. Hence, on October 28, the day of wind and fire, the Current Issues Class took a bus



trip to visit the Oxnard and Port Hueneme cities' coast, the Oxnard District Harbor-Port of Hueneme, the Channel Islands Harbor, administered by the Property Administration Office of the County of Ventura, and McGrath State Park from where we looked into the Wild Life Refuge of the Santa Clara river. Janet Beymer, City Director for Camarillo of the Ventura County League of Women Voters, was our tour director and most knowledgable guide.

We saw HOUSING. The HUD Redevelopment Project on Surfside Drive opposite Port Hueneme Beach Park is a model of good planning. Every apartment has a view of the Ocean and access to the beach. The, apartments are available for both low and high income families. There is plenty of parking at the beach. The houses on Oxnard Beach, north of the Channel Islands Harbor entrance were built years ago

on 25 foot lots on a narrow street. There is access to the beach, but little or no place to park nearby. At Oxnard Shores, further north, the lots are larger, the street wider, but some of the homes are built on the Ocean side of the street and suffer damage regularly from severe storms.

The Edison Canal, which takes ocean water from the Channel Islands Harbor entrance to be used for cooling purposes at the Mandalay Generating Station, has been widened to form the Mandalay Development which allows for boat docks. North of this housing area, east to Victoria and west to the Edison Canal, Oxnard has submitted in its Local Coastal Program plans for 12 story buildings housing condominiums, apartments, a with a park and recreational area on the ocean side of the tall structure. There was a divided vote on this part of the Oxnard plan but it was approved as submitted by the South Central Coastal Commission, which includes Ventura, Santa Barbara and San Luis Obispo Counties, and sent to the State Coastal Commission in September for its approval.

Agriculture and industries are approved in the Coastal Zone if they are coastalrelated. For instance, arand lima beans tichokes require the dampness of a coastal climate. Oil companies which need pipelines for offshore loading such as the Getty Oil Company in Ventura have been approved. The Oxnard Sewage Treatment has its outfall pipeline two and onehalf miles out in the oceanhence, it is located on the coast. (It may be debatable if that is the best use of the product). Ormand Beach' Generating Station, if it needs to expand, may request the use of wetlands. Is that desirable?

We saw two potential water quality HAZARDS. The sump at Halaco, where aluminum is recycled, may contain harmful chemicals; there is some question about the oil dump of Jamar Oil Company.

One of the most interesting spots was the Port of Hueneme-Oxnard Harbor District. John Elmore came aboard the bus and told us of the increasing activity of the port. A steady flow of Mazda cars and trucks were being driven down a ramp off a freighter to a large parking lot.

The port is a money maker, not a tax burden. It now covers 50 acres, but effort is being made to regain more of 322 acres originally given by Sen. Bard when port was complete in 1940, just in time for the U.S. government to commandeer its use during World War II. If it can obtain Port of Entry status, it will then have its own customs office.

BOOK REVIEW GROUP

15 At our September meeting, Grace Back troduced us to "Book Reviewing for an Audience" by Evelyn Oppenheimer, who "wrote this book because none such had ever been written."

And here are some of the points she makes:

When you start your presentation give the title of the book, name the author and the publisher, and keep the review to under half an hour. Most audiences do not have a very long attention span. Try to be clear, concise and entertaining, and have fun doing it. Giving a book review can be a very good experience.

Of course be as well prepared as you can. Be enthusiastic about the book you are reviewing, or on the contrary dislike it thoroughly, but do not be lukewarm.

Present a pleasing appearance. This is not a style show, but you are standing in front of a group, preferably at a

lectern and with a microphone at hand.

Place the book on the lectern; acknowledge briefly the introduction given you. Make sure the microphone is at the right height, at mouth level, and as close as possible to you.

When you start speaking, keep your eyes on the audience as much as possible. This precludes reading the review which lacks spontaneity in any case, and tends to be monotonous. Stand quietly and do not fiddle with your hair, your glasses, etc. This can be very distracting.

Speak clearly and not too fast. Do not be afraid of the microphone, it is the best friend of a speaker.

Pause occasionally to let a thought sink in, but do not stop when someone coughs, sneezes, or arrives late; it would interrupt the mood you have created and embarrass the miscreant.

When you are through, wait a few seconds before taking your seat, and listen to the applause!

Now that you all know how to do it, there should be no dearth of reviewers in the





Senior Outreach

With the aid of the Ventura Senior Outreach Program, Y.N.C.G. (Your Neighbors Care Group) started a discussion group that may help solve a wide range of problems encountered in retirement Available from the V.C. Mental Health Services, this new program goes out into the field, even homes, to reach senior citizens who may be facing problems they themselves can not solve or cope with. Dr. Bob Knight, PhD in psychology and director of mental gerontology, and Mary Ann Slaughter, a social worker, are conducting the sessions.

In the weekly one and one half hour sessions conducted in L.V. several general problems of retirement have already surfaced. Having to drive the freeway can be a big problem; having one active spouse in the

family, the other very inactive; and the toughest one of course is the death of a spouse. Getting suggestions from one another and from the directors has already helped some of the participants.

The presant group of 12 to 17 consists mostly of females, even though most problems involve both sexes. The male is hesitant to come forward to discuss his problem. Too bad it is the "matcho" image he has lived with all his life that makes him feel he can solve his problems by himself. In the next eight week program it is to be hoped that more men will join. Rules are simple: any thing personal is confidential; only generalities are spoken of outside. These group sessions are free. Individual appointments for more personal problems can be made for a small fee. Senior Outreach is here for all.

Chiropractic and Herbal procedures, Acupressure and Megavitamin Therapy are being used more often today and medical doctors are sometime recommending these methods.


Accompanying Mr. De Long was James Braly M.D., founder the Optimum Health Labs in





The October Field Trip was to Old Topanga Canyon where we found fossils of clams and other types of shellfish. While we were there a young man accidentally drove his car over the bluff, and the Club members particularly Ben Smithkin and Sam Breithart, were able to get him to medical treatment, and assist the Highway Patrol and the two trucks in getting the car back up on the road. We are still cleaning the fossils we found, as the better preserved ones are encased in a mass of ancient mud that is nearly as hard as the fossil itself and must be removed very carefully. Others are actually "casts" of the animals and are very fragile.

The Past President of the California Federation of Minerological Societies spoke at our October Meeting, and the Field Trip on November 15th was to the Pasadena Gem and Mineral Show, sponsored by the Minerological Society of Southern California.

Board Highlights

The Leisure Village Association Board held its regular meeting on November 3 with all members present.

The Chairman stated that the Village had been in no danger from the recent fire, but homeowners had questioned whether or not a disaster plan exists. In answer he informed the audience that Security & Safety Comm. has attempted to work with the city to establish a plan but has had no success. The City of Camarillo does not have such a plan, either. The Village does, however, have an Emergency Plan which was put into operation during the fire. Administrator Stan Berman, Chief Reimer of Security, the Fire Dept. and Councilman Bill Esty were in control of the situation. Mr. Esty, who was in the audience, was asked to comment.

Esty congratulated Berman and staff because Stan had everything lined up as soon as there was an indication that the Village might be threatened. Esty said that the Fire Dept. did an excellent job in backfiring-if the wind had reversed we could have had some problems. However, such problems would have been minimized because our homes are of stucco and have fire resistant roofs and most homes have individual garden hoses that could have been used if necessary to protect roofs. Sprinklers were not turned on because they are too low to be effective. Esty recommended that letters of appreciation be directed to Trinity Presbyterian Church which offered to take people in if necessary, to the City Manager for making the Community Center available, and to the Red Cross for standing by. The Emergency Plan worked well.

The Architectural Comm. reported that 31 new applications had been received, 28 were approved, and 39 projects were completed. Qualified help is needed for the ad hoc Committee on Painting, (quality, maintenance, etc.) and anyone who has this background should contact Harold King, Chairman. Land-

scape Review Comm. also needs experienced help.

Finance Comm. has several sub-committees working on insurance, data processing, audits, etc. An Insurance Report will be presented to the Board in the near future.

Flood & Storm Drain Chairman commented on the speaker who took the negative portion of the debate on Prop. H at the Current Issues Forum. The speaker stated, for instance, that those who live on top of the hill have no responsibility for potential flooding, that the County has plenty of money for maintenance, and that the Flood Control District has \$2 million left over from last year. Mr. Lauten objected to the speaker's misleading statements. Lauten explained that \$1 million of the \$1,800,000 surplus is tied up for construction and the balance is a reserve such as all governmental agencies must have to operate while anticipated revenues are coming in. Lauten labeled the speaker as a rabble rouser without factual statements.

Information to Residents Twenty-five new residents were called upon during the preceeding month. Of these residences 4 were leased and 14 were resales. All of V. 39 is now occupied. Residents are urged to update emergency information with the office. It is particularly vital that renters and/or lessors inform the Association office as to who is living in the rented homes. As a further service, the Committee is furnishing maps and airport bus service schedules to new renters. The Great American Stageline schedules are also available in the office.

The Nominating Comm. is seeking qualified and willing volunteers to run as board members in the next election. Three directors will be elected for two-year terms. All applications will be carefully reviewed.

The ad hoc Comm. for Resident Services is reviewing present services, service requests, costs of current

Board Cont. from C-18 services and what services will be given in the future. The Committee consists of Helen Esty, Dick Van Horn, Bill Rasmussen, Walter Rue, Florence Johnston, Blanche Follen and Karl Joehnck, Chairman.

Marty Beckel in reporting on activities of the Educ. & Rec. Committee thanked Irwin Steinhart for his services on the Committee. Steinhart has resigned for personal reasons. Isadore Abrams is chairing a sub-committee on the matter of a full cover for the pool, whether to charge fees for movies, etc. Beckel urged that anyone having anything to say on these matters attend the next Educ. & Rec. meeting while the items are still under discussion. A recommendation for a class in gerontology has referred to Your Neighbors Care Group.

Old Business The Committee studying golf course problems has made proposals and the Board has requested Leisure Tech. to make improvements. Leisure Tech. has made counter-proposals so the matter is still under discussion.

Recommendations to the **Board by Committees:**

Sec. & Safety, that a bus schedule be posted in front of the bus stop at the Recreation

Bldg. & Grnds, that no more sycamore trees be planted because they are disease prone, messy, and expensive to maintain. Some removals in certain areas should be made where damage to foundation might occur.

Educ. & Rec., that all rooms be closed and locked at 11:00 p.m. instead of 10:00 p.m. at the Recreation Center with the exception of the Lapidary Room which should be locked at 8:00 p.m. and that the A.R. be used on week-ends for villagers only and not for private parties.

Board Actions. Negotiations with the Union regarding health and welfare plan for landscape workers are still progressing.

Because of complaints in connection with employees doing work for residents on break-time, etc., moonlighting by Village employees will be forbidden.

The seminar on estate planning scheduled for Nov. 12 is already full, 710 have signed up, so a second session is planned. Anyone interested should sign up; tickets are free. The panel will consists of an attorney, a C.P.A., an Insurance expert and a Trust officer. Anyone having tickets which will not be used are urged to turn them in so that someone else may attend.

Letters have been sent to six auditing firms for bids for the annual audit of Association books.

Bldg. & Grnds. subcommittee which is studying the in-house versus outside contract painting matter is in need of volunteers who have expertise in this area.

Report of breakdown of bus. Mrs. Weed reported that since April 1 both buses were out of commission at the same time on August 20 and 21. On Aug. 23 one bus had a flat tire and the three hours it took for repair ruined the schedule that day. The bus travels 25,000 miles a year and as a result must be out of operation at various times for maintenance.

Beckel reported that Leisure Tech has agreed to install an outside shower at the pool in the area where the drinking fountain is now.


Question to Weed: If the are in such good working order why are they not being used for shopping in Thousand Oaks and Oxnard.

Question from V. 16: Is there any provision for pedestrian traffic from the Village to the new shopping area. Villagers are concerned about safety, as well as potential "rip-offs" similar to recent incidents.

Villager in 7 has waited three months for repair of air conditioner in spite of repeated requests for service. (Answer: matter will be attended to).

Villager from 13 asked for clarification of Association's responsibility for replacements of roofs. (Answer: The Association has a reserve and is liable for full replacement of roofs when needed).

Villagers Survive Prinsendam Disaster

Ben and Pauline Cohn, Village 18, are home again after the most harrowing experience of their lives, rescue from the burning ship Prinsendam off Alaska. A whole set of miracles enabled more than three hundred passengers and two hundred crew members to escape the ship in Arctic waters without a single casualty.

Having sailed from Vancouver, the luxury ship, only seven years old, had already made a stop at Ketchikan, sailed through Glacier Bay, and was on its way to Japan and China. At 1:30 A.M. on October 4th, the ship's public address system announced to sleeping passengers that there was a small fire in the engine room. As there was a good deal of smoke, all passengers were instructed to put on warm clothing and go to the Promenade Deck. Electricity

was off in the stateroom, so from a faint emergency light in the hallway, Ben and Pauline fumbled to find something to wear. Ben pulled trousers over his pajamas, put on a coat, and managed to put his wallet in his pocket. Pauline put on slacks and a shirt, flimsy shoes, one of her rings, a watch, and a rain coat -- hardly appropriate for ordeal ahead. cumstances prevented anyone from returning to their staterooms again. elevators were not working, fire doors had been closed, so their exit was up a narrow

stairway which was so smokey that their throats felt raw when they reached topside.

The second announcement told the passengers that the ship had been in contact with the Coast Guard, and planes could occasionally be heard outside. The Aurora Borealis, that rare Arctic phenomenon, danced across the sky; stars were out; Pauline recalls how excited she might have been under different circumstances. At 4:30, they were told to abandon ship.

Lifeboat No. 3 was designed for 47 passengers, but nearly 100 crowded in, as some of the lifeboats were unusable. The crew was unfamiliar with lowering the boat manually, so it see-sawed down, bumping against the ship and breaking the rudder which left them with no steering mechanism. They were jammed together, under the open sky, with no one in command, no steering, no means of rowing, out on the cold, dark ocean, alone.

The people, many of them in their 80's, were amazingly calm

and courteous. There was no panic. Pauline was suffering from sea-sickness and was in a daze much of the time, but neighbors tried to be comforting. They sat quietly praying, making their peace, accepting reality. Most expected to perish.


But the miracles were already working in their favor. The ocean was calm, between storms, and there was no wind. There were no stores aboard the lifeboat, no bailing equipment, but someone found some flares in a locker, and they were fired.

They were fascinated by the sunrise, it seemed so close, and a mirage like a sea of icebergs kept moving ahead of them. Later in the day, the second storm approached. The wind rose, and twenty-five foot waves of green water bounced them up and down between troughs of the sea. They saw planes, and after ten hours in the water, a search helicopter spotted them. It hovered over the boat; the crew lowered a

basket, and pulled passengers one at a time into the plane. They ferried ten people in a load to the tanker Williamsburg, which had a helicopter landing pad. The prop-wash from the helicopter sprayed water into the boat, soaking everyone. The tanker, providentially close by and loaded to capacity from the oil port of Valdez, took on about two hundred people, then turned to take the refugees back to Valdez. Every nook and cranny was crowded with people, but the crew shared dry clothing, food, beverages, and every possible comfort with the people. The second storm raged around them as they made their way back to Valdez, two days' sailing away. The tanker, as long as four football fields, was manned by 28 men who were taking her to Corpus Christi. The entire town of Valdez, alerted to the situation, came to the rescue with hospitality, clothing, telephone calls to relatives, and complete news coverage. The Holland-American Lines

arranged for the survivors to buy some clothes, furnished

toilet kits and provided

medication for each person. Despite their exposure, no one caught cold, and there were no injuries recognized at the time.

Ben, cool and reserved during the adventure, called their children, and as the connection was made, he began to cry. Nor was Pauline able to talk. Only then had the trauma of their experience penetrated their emotions.

The passengers were flown to Anchorage, and after all the refugees from various spots in Alaska had been gathered together, a DC-10 took them to Seattle in one load. The Cohns were met in Seattle by their three daughters who promptly took them to their home in San Francisco to care for them for three weeks until the shock of the experience wore away.

The Cohns, veteran tourists, will travel again. Give them a few weeks, and they'll probably be on their way, in the meantime, Leisure Villae

seems very sweet.


