

- ~ **CCR 2/08-01 Changing Math and Physics Prerequisites to Require C- or Better in Previous Course**

- ~ **CCR 03/08-01 ME 220 Computer Aided Engineering – Remove ENG 120 Introduction to Engineering and Technology as a Prerequisite**  
Steve Pronchick explained that the course emphasis has changed from when the course was first created so ENG 120 is no longer needed as a prerequisite. Josh motioned for approval; Greg seconded the motion. The unanimous vote was 7-Yes/0-No.
- ~ **CCR 2/08-02 CRU 250 Sea Training II (Engine) – Eliminate the Option to Take CRU 250 on TSGB**  
Steve Kreta explained the history of the course and the reasons why the course can no longer be taught on the ship. Britt motioned for approval; Mindy seconded the motion. The unanimous vote was 7-Yes/0-No.
