Elden, in his first official act as a new member of the board, proposed that the new engineering building be named in honor of the late Dr. R. C. Dwyer, former dean of instruction. His motion passed unanimously. The building will be called Dwyer Hall.

The new chairman was appointed to the board of governors by Governor Brown in 1960. He is serving his fourth term as a member of the Solano County Democratic Central Committee. Riley also was named president of the California Maritime Academy Foundation, again succeeding Sweeney. Capt. H. E. Richter, USN (ret.), superintendent of the sea school, was named secretary.

Present at the meeting for the first time was a new member of the board of governors, Rodney M. Elden, Los Angeles, manager of Joshua Hendy Corporation who was appointed by Gov. Edmund G. Brown to succeed Sweeney as a member of the board. Sweeney had been a mem-ber for 20 years and chairman for three different terms.
