Dear Cesar:

I recently received a letter written by Donato Ventura to you which causes me some concern.

Although it is true that I have decided not to take a public position with regard to Proposition 14, it is also true that I have stated repeatedly that I would have supported full funding for the ALRB and will continue to support such funding in the future -- without any amendment or modification to either the law itself or to the rules and regulations adopted by the ALRB. In fact, I signed a petition to get Proposition 14 on the November ballot because I believed that its qualification as a ballot measure would put sufficient pressure on those legislators who were responsible for holding up the funding. I'm sure you would agree with me that such a commitment to full funding for implementation of the law will be of critical importance in the future -- even if Proposition 14 passes, as I believe it will.


My opponent, on the other hand, has taken a firm stand against Proposition 14 and has also stated that he would have supported funding for the ALRB only if its powers were delimited.

As to the question of my having "strong grower support," I am not aware of any factual basis for such an allegation. In fact, my opponent, Chuck Imbrecht has cultivated such support and is receiving significant financial assistance from aggre-business interests. (See enclosed lists of such contributions)

I very much value the endorsement which you gave my candidacy at the Cabrillo Village rally and I am confident that by working together in the future we can assure much needed legal protection for the farmworkers of California.
