# **Program Summary**


The Office of Research and Sponsored Programs (ORSP) is central to the University's mission. The office facilitates faculty development, student learning, and community outreach through assisting faculty and staff to secure external funding. ORSP is the grants and contracts point of contact for the campus. ORSP assures that requirements for submitting grants with systemwide, state and federal regulations are met and handles the administrative routing process, which is required for approval of all grants and contracts at CSUCI.

### 2005-2006 Profile


2005-2006 ORSP PROFILE

In academic year 2005-2006 a total of 46 proposals were submitted to multiple funders including federal, state and local agencies and private and corporate foundations; amounting to \$10.8 million.


- 31 of 46 proposals were awarded totaling \$2.6 million
- 10 of 46 proposals were declined totaling \$7.9 million
- 4 of 46 proposals are still pending review totaling \$290,726
- 3 of 46 proposals were governmentally-directed federal earmarks totaling \$1.5 million

# **Review Board**

INSTITUTIONAL REVIEW BOARD FOR THE RIGHTS OF HUMAN SUBJECTS

At California State University Channel Islands, the administrative authority for the protection of human subjects, in funded as well as non-funded research, has been delegated to an appointed Institutional Review Board (IRB) for the Rights of Human Subjects, which works under the sponsorship of the Office of Research and Sponsored Programs to ensure the protection of the rights of human subjects and serves as the University's Institutional Review Board for purposes of local, state, and federal requirements. The IRB's charge is to facilitate scientific inquiry while preserving the dignity of individuals and the rights of various social groups. It has the ultimate responsibility to determine risk with regard to human subject research conducted at and/or under the sponsorship of the University or its auxiliaries.

The faculty member - chaired IRB for human subjects research is supported by ORSP's existing infrastructure. In academic year 2005-2006 the IRB reviewed and approved a total of 33 research proposals.

- 15 of the 33 proposals were undergraduate student research proposals
- 11 of the 33 were faculty/staff research proposals
- 7 of the 33 were graduate student research proposals


