

- * The meeting was called to order at 3:35 PM.
- * Ryan called for approval of the agenda for November 30, 2015. Tony motioned that the agenda be approved; Tom seconded the motion. The agenda was unanimously approved, 9-Yes/0-No.
- * Ryan called for approval of the minutes of October 21, 2015. Scott motioned that the minutes be approved, as amended; Amber seconded the motion. The minutes were approved 8-Yes/0-No/1-Abstension.

Scott motioned for approval; Amber seconded the motion. The unanimous vote was 9-Yes/0-No.
- * **CCR 11/15-06 PHY 120 Physics for Future Leaders** – Decouple the lecture from the lab. Amy motioned for approval; Tom seconded the motion. The vote was 7-Yes/0-No/2-Abstensions.
- * **CCR 11/15-07 Various MT Courses** – Remove STCW designation and add course in major designation. Britt informed the Committee that Tank Vessel Operations will continue as STCW so the STCW

designation should remain. Tom motioned for approval; Britt seconded the motion. The unanimous vote was 9-Yes/0-No.

- * Scott requested that Sea-Time Equivalency – Yes or No be added to the CCR template; Britt seconded the request. The unanimous vote was 9-Yes/0-No.
- * The meeting was adjourned at 4:41 PM.
