Facts Regarding a City Square for San Luis Obispo

1. How Will a City Square be Administered?

The City Charter gives the Council power to "establish a park commission, and to appoint commissioners thereon, to serve without compensation, with such powers and duties as may be fixed by the Council." A Park Commission would be the main body to administer the Park affairs and would employ a Park Superintendent to take care of the actual work. The Park Superintendent would be sworn in as a peace officer.

The method of administering the Park would be similar to the method now employed with the Public Library. The duties of the Park Commission would compare with the duties of the Board of

Library trustees and the duties of the Park Superintendent with those of the Librarian.

2. How Will a City Square be Financed?

The Park will be financed through taxation with the provision that the Monday Club advance \$3,500.00 for the initial work such as landscaping, planting and cost of shrubs, trees, etc. For the first three years a tax levy of 9c per \$100.00 of assessed valuation would be necessary. Thereafter a tax levy of only 4c would be required to maintain the Park. The larger tax rate for the first three years would completely establish the Park and pay for all permanent improvements including the upkeep for such years, according to specifications submitted by W. C. Shepard, landscape engineer of the University of California.

3. What will this Tax Mean to Citizens in Dollars and Cents?

A tax rate of 9c means that your taxes would be increased 9c for each \$100.00 of ASSESSED valuation. The present assessed valuation averages less than 50 per cent of actual value. Therefore if you own property worth say \$6,000.00 which is assessed for \$3,000.00, your tax increase would be .09 on every hundred dollars or .0009 on every dollar: \$3,000.00X.0009 amounts to \$2.70 a year for the first three years. After that the tax would decrease to .04 a hundred or .0004 a dollar: \$3,000.00X.0004 amounts to \$1.20 per year or 10c per month after the first three years.

If you are an owner of property get your last City tax statement and ascertain the ASSESSED valuation of your property by adding the assessed valuation on real estate, improvements and per-

sonal property; then follow this example:

Taxes for first three years, which will pay for improvements and includes upkeep for said years:

If your assessed valuation is	2,435 .0009
Givnig a tax of	\$2.1915—\$2.19 per year

After first three years your taxes will decrease to .04 for up-keep of Park

\$2,435 .0004 \$. 9740—97 cents per year.

Do you believe that a property owner assessed for \$2,435 would be unwilling to pay \$2.19 a year for three years for initial investment and thereafter 97 cents per year for maintenance?

4. What We Expect of the School Board

We would like to have a statement from the School Board that they would be willing to turn over Mitchell Lot for a City Square in the event the City Council puts the question of a Park on a ballot and the voters approve of the project.

5. What We Expect of the City Council

We would like to have the City Council submit the question to the voters, eaither at a special or general election.

Paso Robles City Park is one of the city's best assets. Its attractiviness adds greatly to the physical appearance of the city and it affords to the people of our communty a wholesome and pleasant place for rest and recreation. It is constantly used and much appreciated.
