Clare:

I received NWPC History outline, thank you very much. As indicated via phone conversation - Rhea (Ruth) Mojica Hammer's (the first Latina to run for Congress, Chicago, Illinois) daughter - Linda Merchant is developing a documentary of the first Latina involved in NWPC's "Chicana Caucus" - the documentary is entitled "Las Primeras" (The First Ones).

I was part of nwpc's organizing group in 1971. At that time I was working in the Women's Action Program - designed by US Dept. of HEW, Secretary Elliott Richardson to improve the Status of Women - during the ERA debate. I was selected from the Office for Civil Rights under Stan Pottinger. The Women's Action Program became a blueprint report - recommendations to improve Health, Education and Welfare for Women in the US.

I selected and worked on Welfare Reform Policy issues. I was invited by NWPC in response

to the work I was doing to improve services to "Women Single Parents - of Low Income." I headed and organized the NWPC Chicana Caucus and also was chair of NWPC's Welfare Reform. I testified before Congress several times.

I wondered if you have any documentation or information that would help us with Linda's documentary. I have been trying to reach Gloria Steinem with whom I worked closely during this time.

I am currently helping to combat energy projects that contribute to "Globe Warming" and also have serious negative impact on our environment.
