**Reports:**

Executive Committee report by Doug Jordan: No report

Academic Senate report by Doug Jordan: The senate discussed the following topics:

- Why is SSU currently under-enrolled? Even though the same number of students was admitted as last year, fewer freshmen decided to come to SSU because they had also been admitted into a UC. SSU’s eligibility index was so high, that we competed with UC campuses for students.
- University District Development: The City of Rohnert Park asked for SSU’s feedback for plans to develop the area just north and west of campus. SSU responded that there is not enough affordable housing in the plans, the housing developments are very dense and don’t allow for enough parking.
- Periodic Review of Administrators: Who will be on the review committees? Can free responses be anonymous?
- 23 points to facilitate graduation

SAEM report by Katharyn Crabbe:

- Mom’s Boardinghouse is petitioning to extend the hours of alcohol sales. Matthew Lopez Phillips is in contact with the city on this matter.
- At the statewide VPs of Student Affairs meeting the 23 points to facilitate graduation were discussed. Part of the discussion was that the focus of the 23 points is too narrow, limited on getting students through in the shortest amount of time. It does not take into account the importance of extra curricular activities and social support.
- The University Center Planning group was recreated. It is looking into building a better student union that would be appropriated for a 10,000-student campus.

ACE report by Janet Swing:

- Janet is going to the National Academic Advising Association conference next week.
- University Standards Committee is discussing the Course Repeat Policy. Janet handed out drafts and asked to email Michelle Jolly with any concerns.
- The number of EOP students is down from 103 students in 2003 to 78 first time freshman this year. The high occurred when SSU had an outreach coordinator.
- The number of undeclared students is down compared to previous years. 7 seniors, 54 juniors, 232 sophomores and 564 freshmen have not declared a major, yet.
