

Fees and Expenses

Fees and Expenses

The following reflects applicable systemwide tuition and fees that were authorized by the Board of Trustees at the March 2017 meeting for a semester campus. These rates are subject to change.

Student Fees*

Students are required to pay tuition and other fees (as indicated in the chart on this page), course fees, and nonresident/foreign tuition. General authority governing most fees is contained in the California Education Code, Sections 89700 and 89724.

All Students

Application fee (nonrefundable), payable online at the time of application via credit card, e-check or PayPal: \$55

Student Involvement & Representation Fee

(Optional Fee)

A Student Involvement & Representation Fee of \$2.00 will be charged in addition to tuition and other fees. Students have until census date to opt out.

Course Fees

Course fees are provided in the "class notes" after each subject listing in the Class Schedule. Fees may range from \$4 to \$1,000 depending on the course.

Nonresident and Foreign Tuition Fee

Nonresident students (U.S. and foreign) are required to pay the nonresident tuition fee in addition to tuition and systemwide fees. The nonresident tuition fee is charged at **\$396 per unit**. The total nonresident tuition paid per term will be determined by the number of units taken. Mandatory systemwide fees are waived for those individuals who qualify for such exemption under the provisions of the California Education Code (see section on fee waivers). Students are charged campus fees in addition to tuition and systemwide fees.

Graduate Business Professional Fee

The graduate business professional fee of **\$270** is paid on a per unit basis in addition to basic tuition and campus fees for the following graduate business programs: Master of Business Administration (M.B.A) and a Master of Science (M.S.) in Accountancy, Business Administration, Health Care Management, Business and Technology, Information Systems, or Taxation. For exemptions, see fee waivers.

Doctorate Tuition Fees*

Education (all students) **\$5,919**

Nursing Practice (all students) **\$7,635**

Physical Therapy (all students) **\$8,598**

* Applicable term tuition applies for campuses with special terms, as determined by the campus. Total college year tuition cannot exceed the academic year plus summer term tuition. The summer term tuition for the education doctorate at quarter campuses is equal to the per semester tuition listed in the table. Total tuition for the education doctorate over the college year equals the per academic year tuition plus the per semester tuition for the summer term at all CSU campuses.
