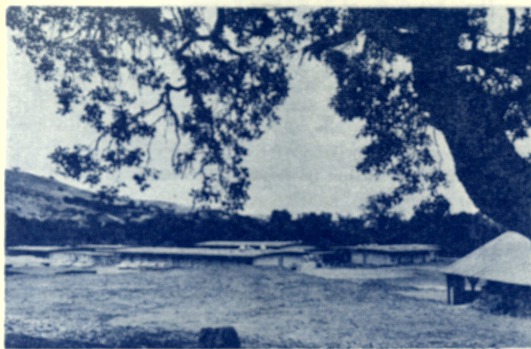

## William F. James Boys Ranch

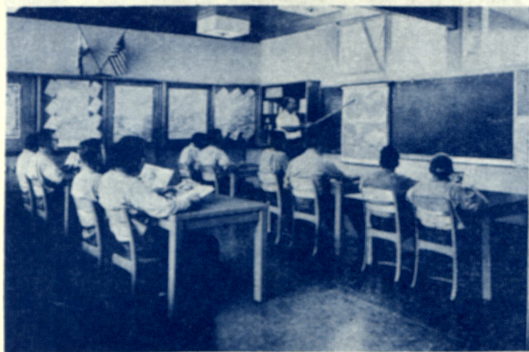
BOYS' RANCH NO. 2 BUILDINGS NESTLE  
IN OAKS AND ORCHARD



The second William F. James Boys' Ranch was dedicated, April 4th, at 2:00 P.M., in a ceremony open to the public. Tours, refreshments, and a concert by the Live Oak Union High School Band are added attractions.

Located on thirty-three acres near Morgan Hill, the new \$570,000 ranch for wards of the Santa Clara County Juvenile Court is nestled against the eastern foothills next to the original ranch. Together, the two units house 108 boys between the ages of 13 and 17.

The new ranch, under Superintendent Lee C. Jordan and Assistant Superintendent Michael T. Irving, Jr., has been in operation since February 9, 1961. Seventy-nine boys, all in the 13-15 age bracket, have received the benefits of the rehabilitation program at Ranch No. 2. Six hundred thirty-seven boys, aged 13 to 17 have gone through the two units since Boys' Ranch No. 1 opened in October 1953.

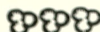

It is a shame to glorify the stagnancy of the mind when such an array of education and knowledge surrounds us.

# PUBLIC HEALTH PROBLEMS OF THE UNITED STATES MEXICO BORDER

Last month I had the pleasure of meeting with Mexican health authorities in a five day conference held in Nuevo Laredo, Tamaulipas. The purpose of our meeting was to discuss health problems along the U.S.-Mexico border and to find solutions for improving health conditions in this area.

We realize that disease does not recognize any international boundaries and that both Mexico and the United States will have to work together to improve health conditions of our borders.

## BASIC FACTS:

There are 1600 miles of border line dividing the U.S. and Mexico. There are 16 cities along the border which are particularly suitable to commercial and cultural exchange. This favorable condition is highlighted by the continuous stream of local travel between the border points of both nations. Sixteen million Americans live in the U.S. border that adjoins Mexico and five million Mexicans live in Mexico's border side.

The border resident visits the neighboring country an average of 3.2 times per year. This means an annual average of 68,000,000 crossings from one country to the other at the border points. Tijuana, recorded 17,000,000 visitors last year, most which came from San Diego and Los Angeles metropolitan area.

With all these millions of people crossing the border, disease is carried back and forth to each country. Disease such as venereal diseases, tuberculosis, enteric diseases, rabies, etc. are a constant problem of these critical areas. These problems cannot be solved overnight but great strides were made at this conference to pave the way for better health conditions along our southern border.

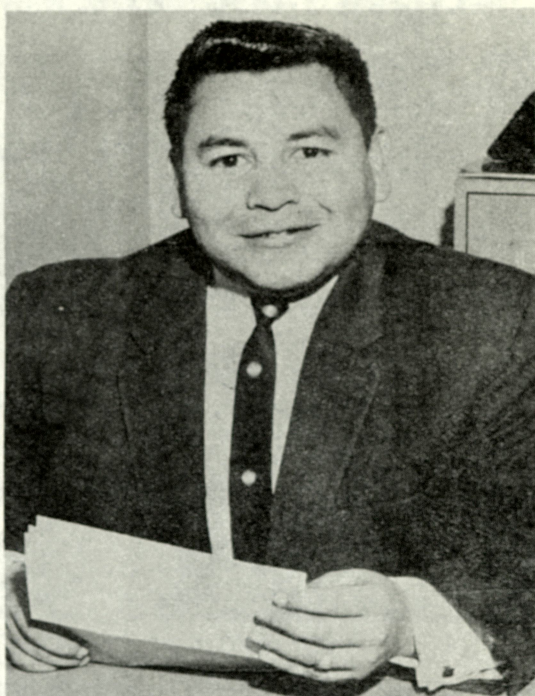

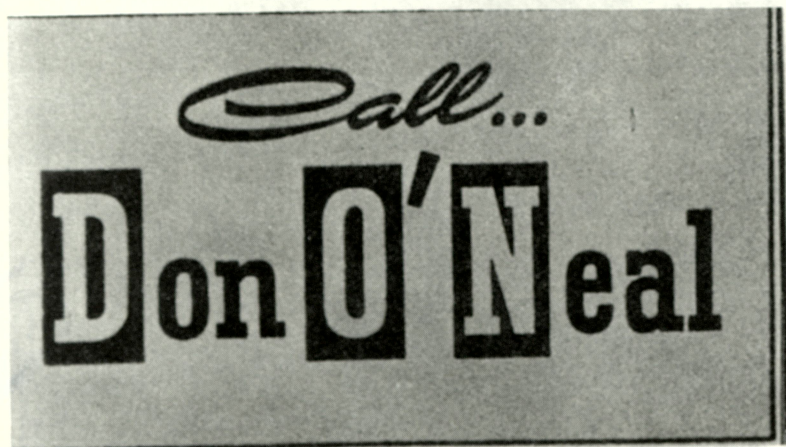
