Chair's Report (J. Mahdavi):

- Director of Diversity and Director of Undergrad Studies Memo Passed
- \$2.1 million from stimulus coming to SSU
- Plan to admit in spring, raising FTES
- Student Advocate Memo approved by SAC, going before Ex Com as an information item
- Faculty ideas for a faculty retreat? Long-range planning? Technology? Coping?
- Registration holds for mandatory advising still under consideration

SAEM Report (M. Lopez-Phillips):

- In rollover one-time funds unavailable for staff hires, ensured allocations of funds for SLICE, staff computer refresh especially in advising. Considering investment in interactive/education theater scripts and trainings for students/staff about sexual misconduct, class, and race.

Business Item #1: Laurel Holmstrom Vega on Formal Dispute Resolution revisions.

- Changes articulate exigent circumstances for deadline extension, right to written information, timeline for process, duration and format of verbal board findings and student presentations [SAC discussion: change III.D. "presentation" to "statement" consistently and "no more than 10 minutes" for verbal statement.]; right upon request for

finding explanation; [SAC discussion: change III.H. to “Compliance with Board decisions or requests for more information are due within 5 academic days of receipt.”]; name change? “Fairness Board” unclear jurisdiction, so change to Dispute Resolution Board. [SAC discussion: “Dispute Resolution *and Fairness* Board” or a clarification statement? Student concerns of “dispute resolution” as less intuitive than “fairness.” “Academic Appeal, Integrity and Grievance Board” or “Academic Integrity Board for Appeal and Grievance”?]
