E. McDonald addressed comments made at the previous second reading.

Motion to amend: Second page: Delete sentence “Resources for the assessment and program review will be provided by Academic Affairs” and replace with “**A program review requires funding from the department, school or division level.**” Second.

Vote on amendment. *Failed.*

Motion to amend: Same sentence above, change to: “**Program reviews shall be conducted only if appropriate resources are provided by the Division of Academic Affairs as determined by procedures developed by that division**”. Second. Question called. Second. Approved.

Vote on amendment. *Failed.*

Motion to refer back to EPC with instructions to work with the Division of Academic Affairs to come up with language appropriate for this document; and charge the committee to review models in within the CSU that deal with funding for this particular activity. Second. Question called. Approved.

Vote on motion to refer. *Failed.*

Motion to amend second page: Delete sentence “Resources for the assessment and program review will be provided by Academic Affairs” and replace with “**The**

Academic Senate strongly urges the administration to provide adequate resources, including workload adjustment, for program assessment." Second. Question called. Approved.

Vote on amendment. *Failed.*

Motion to delete sentence: "Resources for the assessment and program review will be provided by Academic Affairs." Second.

Motion to move the agenda (*call for orders of the day*). *Approved.*
