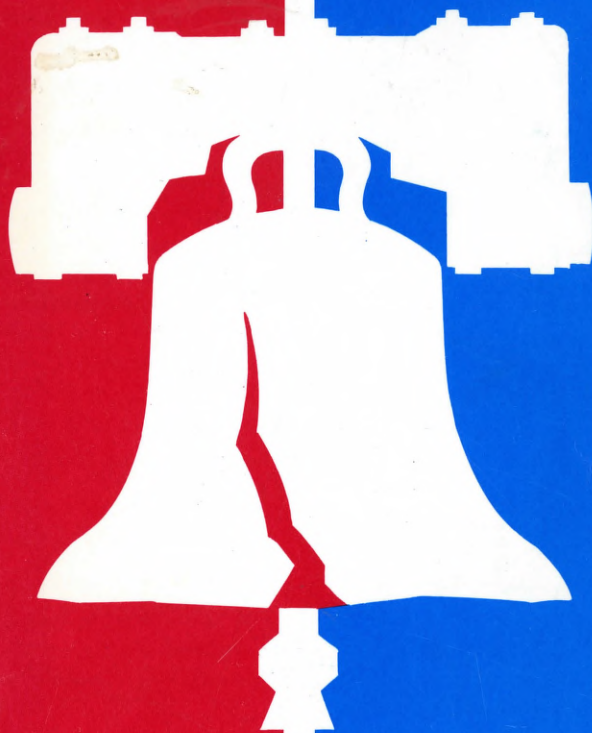

## QUALIFICATIONS

President—natural-born citizen of the United States, thirty-five (35) years of age at the time of taking office, and fourteen (14) years a resident within the United States.  
U.S. Constitution, Art. II, § 1

U.S. Senator—Thirty (30) years of age at the time of taking office, citizen of U.S. nine (9) years, and inhabitant of State when elected.  
U.S. Constitution, Art. I, § 3

Representative in Congress—Inhabitant of State when elected, citizen of U.S. seven (7) years and twenty-five (25) years of age at the time of taking office.  
U.S. Constitution, Art. I, § 2

State Senator—Citizen of U.S. and inhabitant of State three (3) years next before (general) election, and one year in district, and must be an elector.  
Constitution, Art. IV, § 2

Member of the Assembly—Same as for State Senator.

Judge, Superior Court—Citizen of U.S. and resident of State five years next preceding election; admitted to practice before California Supreme Court ten (10) years immediately preceding election, a member of the State Bar or served as a judge of a court of record in this State. He must reside within the county for which he is elected or appointed.

Judge, Municipal Court—Citizen of U.S., resident of State five years next preceding election, admitted to practice before California Supreme Court five years immediately preceding election; resident eligible to vote in judicial district or city and county in which elected or appointed for period at least 54 days preceding election or appointment.

### FILING FEES

The filing fee shall be paid at the time candidate or sponsors pick up nomination papers from the clerk with the exception of the office of State Senator, and Member of the Assembly. Filing fee payable in cash or certified check to the Clerk. Filing fee shall not be refunded in the event the candidate fails to qualify as a candidate. § 6553

### PETITIONS IN LIEU OF FILING FEE

A candidate may submit a petition containing signatures of registered voters in lieu of a filing fee as follows:



- (1) California State Assembly, 1,500 signatures.
- (2) California State Senate and U.S. House of Representatives, 3,000 signatures.
- (3) United States Senate 10,000 signatures.
- (4) Judge of Superior Court 1,812.
- (5) Judge of Municipal Court 1,667.
- (6) A candidate may submit the appropriate number of signatures to cover all or any *pro rata* portion of the filing fee. § 6555

## **DECLARATION OF INTENTION**

### ***Judicial Office***

Candidates for judicial office, whether declaration of candidacy made personally or by sponsors, must file written and signed declaration of intention to become candidate. Applicable to offices whether numerically designated or not.

Form of declaration not specified by law.

Check with Clerk to determine whether such forms are available.

Payment of filing fee not required when obtaining this form. Superior Court and Municipal Court candidates must file Declarations of Candidacy with the Clerk during period February 1 through February 11. Clerks will transmit Declarations of Intention for Judge of the Superior Court to the Secretary of State.

### ***Legislative Office***

Candidates for State Senator and Member of the Assembly are required to file Declaration of Intention to become candidate. (Not required for U.S. Senator or Congressman.)

Form to be supplied by the Clerk. No fee for this form.

This declaration must be filed with either the Secretary of State or the Clerk of the county in which the Candidate is a resident.

Since forms are supplied by the Clerks and in order that they have a record of declarations, signed declarations may be left with Clerk for transmittal to Secretary of State.

The Declarations must be filed during period February 1 through February 11. Fee paid during this filing period.

## NOMINATION PAPERS

### ***Forms***

All forms required for nomination and election to all congressional, state and county offices shall be furnished only by the Clerk. At the time of issuance of those forms the Clerk shall type in the forms the name of the candidate and the office for which he is a candidate, shall imprint a stamp which reads "Official Filing Form," and shall affix his signature. The forms shall be distributed without charge to all candidates applying for them upon the prepayment of the filing fees provided for in §§ 6552, 6553 and 6554. The filing fees shall not be returned in the event the candidate fails to qualify as a candidate. § 6551.

### ***Party Affiliation of Candidate***

No declaration of candidacy for a partisan office or for membership on a county central committee shall be filed, either by the candidate himself or by sponsors on his behalf, (1) unless at the time of presentation of the declaration and continuously for not less than three months immediately prior to that time, or for as long as he has been eligible to register to vote in the state, the candidate is shown by his affidavit of registration to be affiliated with the political party the nomination of which he seeks, and (2) the candidate has not been registered as affiliated with a political party other than that political party the nomination of which he seeks within 12 months immediately prior to the filing of the declaration.

The county clerk shall attach a certificate to the declaration of candidacy showing the date on which the candidate registered as intending to affiliate with the political party the nomination of which he seeks, and indicating that the candidate has not been affiliated with any other political party for the 12-month period immediately preceding the filing of the declaration. § 6401.

"Political party" means a party qualified for participation in the Direct Primary Election. § 39.

## CANDIDATES' FILING DATES

Feb. 1 through Feb. 11—Declaration of Intention for Legislative and Judicial offices.

Feb. 16 through Mar. 12—Nomination papers of PRIMARY ELECTION candidates.

Feb. 25 through Mar. 26—PRESIDENTIAL nomination papers.

Aug. 10 through Sept. 3—Independent candidates.

# **Filing Duties Independent of Specific Election Dates Under the Provisions of the Political Reform Act of 1974**

## **PROPONENTS OF BALLOT MEASURES**

Proponents must file a campaign statement within sixty-five (65) days after measure has qualified for the ballot. The report period will cover through the 58th day following qualification. Gov.C., § 84202 (a).

## **LATE CONTRIBUTION REPORTS**

Each contribution of \$1,000 or more received after those reported in the last pre-election campaign statements must be reported within forty-eight (48) hours of receipt to the respective filing officer(s). (Gov.C., §§ 82036, 84214).

## **STATEMENT OF ECONOMIC INTEREST**

Every candidate for specified offices must file a statement of economic interest with his declaration of candidacy. Elected officials must file a statement of economic interest within thirty (30) days of assuming office and on each anniversary of assuming office thereafter while holding office, and within thirty (30) days after leaving office. If you are appointed to office, you must file not less than ten (10) days prior to assuming office. (Gov.C., §§ 87200-87204).

## **FILING REQUIREMENTS—TITLE 9 OF GOVERNMENT CODE (POLITICAL REFORM ACT OF 1974)**

Every candidate and committee that receives contributions or makes expenditures during the periods specified in this section, and every elected officer except as provided below, shall file campaign statements as provided in this section, unless the candidate, committee or elected officer is required to file campaign statements in connection with any election or elections held within the periods specified in subsections (a) and (b):

(a) For the period January 1 through June 30, campaign statements shall be filed not later than July 31.

(b) For the period July 1 through December 31, campaign statements shall be filed not later than January 31.

If a campaign statement was filed in connection with an election held during the six-month period immediately prior to a period specified in this section, the period covered by the campaign statement filed pursuant to this section shall begin from the day after the closing date of the previous campaign statement. This section is not applicable to elected officers whose



salaries are less than one hundred dollars (\$100) a month or to judges, unless such an elected officer or judge is a candidate or committee who receives contributions or makes expenditures during the specified periods.

Reports and statements required by this title shall be filed as follows:

(a) . . .

(b) Reports and statements of candidates for and persons holding the office of superior court judge, Member of the State Legislature, and member of the Board of Equalization, and of committees supporting such candidates—one original and one copy with the Secretary of State, and two copies with the clerk of the largest county by population which in whole or in part is included in the election district which the officeholder represents or in which the candidate or any of the candidates seek nomination or election, and two copies with the clerk of the county in which the candidate or officeholder resides, or in which the committee is domiciled, provided that a committee not domiciled in California shall file two copies with the Registrar-Recorder of Los Angeles County instead of its county of domicile. For the purposes of this section, the domicile of a committee is the address of the committee listed on the campaign statement. No more than two copies of each such statement need be filed with the clerk of any one county.

(c) Reports and statements of candidates for and persons holding any elective office not mentioned above which is voted upon in more than one county, of committees supporting such candidates and committees supporting or opposing measures to be voted upon in more than one county but not statewide—one original and one copy with the clerk of the county having the largest population, and two copies with the clerk of the county in which the candidate or officeholder resides, or in which the committee is domiciled, provided that a committee not domiciled in California shall file two copies with the Registrar-Recorder of Los Angeles County instead of its county of domicile. For the purposes of this section, the domicile of a committee is the address of the committee listed on the campaign statement. No more than two copies of each such statement need be filed with the clerk of any one county.

(d) Reports and statements of candidates for and persons holding any elective office not mentioned above which is voted upon wholly within one city, of committees supporting such candidates and committees supporting or opposing measures to be voted upon wholly within one city—one original and one copy with the city clerk.

(e) Reports and statements of candidates for and persons holding any elective office not mentioned above, of committees supporting such candidates and committees supporting or opposing measures to be voted upon in not more than one county—one original and one copy with the county clerk.

(f) Reports and statements of the county central committees of political parties—one original and one copy with the Secretary of State, and two copies with the county clerk.

(g) All reports and statements required by Chapter 7 (Conflict of Interest)—one original with the agency, which shall make and retain a copy and forward the original to the code reviewing body. Gov.C., §§ 81005, 84206.

## DEFINITIONS

(See Chapter 2 of Title 9 of the Government Code—the Political Reform Act of 1974—for additional definitions)

### Campaign Statement

“Campaign statement” means an itemized report which is prepared on a form prescribed by the Commission and which provides the information required by Chapter 4 (Campaign Disclosure) of this title.

Gov.C., § 82006.

### Candidate

“Candidate” means an individual who is listed on the ballot or who has qualified to have write-in votes on his behalf counted by election officials, for nomination for or election to any elective office, or who receives a contribution or makes an expenditure or gives his consent for any other person to receive a contribution or make an expenditure with a view to bringing about his nomination or election to any elective office, whether or not the specific elective office for which he will seek nomination or election is known at the time the contribution is received or the expenditure is made and whether or not he has announced his candidacy or filed a declaration of candidacy at such time.

“Candidate” also includes any officeholder who is the subject of a recall election. “Candidate” does not include any person within the meaning of § 301(b) of the Federal Election Campaign Act of 1971. Gov.C., § 82007.

### “Legally Qualified Candidate.” Legislative Intent

No person shall be considered a legally qualified candidate for any office or party nomination for a partisan office under the laws of this State unless he has filed a declaration of candidacy or declaration of acceptance of nomination with the proper official for the particular election or primary, or is entitled to have his name placed on a general election ballot by reason of having been nominated at a primary election or having been selected to fill a vacancy on the general election ballot as provided in Elec. C. § 6655.

This section shall not be construed to prevent a voter from writing in the name of any person for an office at a primary or general election. However, a write-in candidate must declare himself as a bona fide candidate 8 days before the date of election in order to have his vote counted. He must also pay the filing fee, if any.

It is the intent of the Legislature, in enacting this section, to enable the Federal Communications Commission to determine who is a “legally qualified candidate” in this State for the purposes of administering the provisions of § 315 of the Communications Act of 1934.

## **Clerk**

"Clerk" refers to the city or county clerk unless the city council or board of supervisors has designated any other agency to perform the specified function.

Gov.C., § 82009.5.

## **Code Reviewing Body**

"Code reviewing body" means:

(a) The Commission, with respect to the Conflict of Interest Code of a state agency, a county board of supervisors, a city council or any local government agency with jurisdiction in more than one county;

(b) The Board of Supervisors, with respect to the Conflict of Interest Code of any county agency other than the Board of Supervisors, and of any local government agency, other than a city agency, with jurisdiction wholly within the county;

(c) The city council, with respect to the Conflict of Interest Code of any city agency other than the city council; and

(d) The Attorney General, with respect to the Conflict of Interest Code of the Commission.

Gov.C., § 82011.

## **Committee**

"Committee" means any person or combination of persons who directly or indirectly receives contributions or makes expenditures or contributions for the purpose of influencing or attempting to influence the action of the voters for or against the nomination or election of one or more candidates, or the passage or defeat of any measure, including any committee or subcommittee of a political party, whether national, state or local, if:

(a) Contributions received total five hundred dollars (\$500) or more in a calendar year;

(b) Expenditures and contributions made, other than contributions described in subsection (c), total five hundred dollars (\$500) or more in a calendar year; or

(c) Contributions of cash, checks and other cash equivalents paid directly to candidates and committees total five thousand dollars (\$5,000) or more in a calendar year. Persons or combinations of persons who are covered by this subsection but not by subsections (a) or (b) are deemed to be committees only for purposes of Chapter 4 (Campaign Disclosure) of this title.

Gov.C., § 82013.

## **Contribution**

"Contribution" means a payment, a forgiveness of a loan, a payment of a loan by a third party, or an enforceable promise to make a payment except to the extent that full and adequate consideration is received unless it is clear from the surrounding circumstances that it is not made for political purposes. An expenditure made at the behest of a candidate, committee or



elected officer is a contribution to the candidate, committee or elected officer unless full and adequate consideration is received for making the expenditure.

The term "contribution" includes the purchase of tickets for events such as dinners, luncheons, rallies and similar fund raising events; the candidate's own money or property used on behalf of his candidacy; the granting of discounts or rebates not extended to the public generally or the granting of discounts or rebates by television and radio stations and newspapers not extended on an equal basis to all candidates for the same office; the payment of compensation by any person for the personal services or expenses of any other person if such services are rendered or expenses incurred on behalf of a candidate or committee without payment of full and adequate consideration.

The term "contribution" further includes any transfer of anything of value received by a committee from another committee.

The term "contribution" does not include amounts received pursuant to an enforceable promise to the extent such amounts have been previously reported as a contribution. However, the fact that such amounts have been received shall be indicated in the appropriate campaign statement.

Notwithstanding the foregoing definition of "contribution," the term does not include volunteer personal services or payments made by any individual for his own travel expenses if such payments are made voluntarily without any understanding or agreement that they shall be, directly or indirectly, repaid to him.

Gov.C., § 82015.

### **Elective Office**

"Elective office" means any state, regional, county, municipal, district or judicial office which is filled at an election. "Elective office" also includes membership on a county central committee of a qualified political party.

Gov.C., § 82023.

### **Elector**

"Elector" means any person who qualifies to vote at either a state election or a federal election held in the state.

§ 20.

An elector has no rights or duties beyond those of a citizen not an elector, except the right and duty of holding office and voting. Unless otherwise specifically provided, every elector is eligible to the office for which he is an elector, and no person is eligible who is not such an elector.

Gov.C., §§ 274, 275.

An elector must be at least 18 years of age, a citizen of the United States and a resident of his precinct for at least 30 days before the election (valid through June 30, 1976).

### **Expenditure**

"Expenditure" means a payment, a forgiveness of a loan, a payment of a loan by a third party, or an enforceable promise to make a payment, unless

it is clear from the surrounding circumstances that it is not made for political purposes. An expenditure is made on the date the payment is made or on the date consideration, if any, is received, whichever is earlier.

Gov.C., § 82025.

### **Measure**

“Measure” means any constitutional amendment or other proposition which is submitted to a popular vote at an election by action of a legislative body, or which is submitted or is intended to be submitted to a popular vote at an election by initiative, referendum or recall procedure whether or not it qualifies for the ballot.

Gov.C., § 82043.

### **State Measure**

“State measure” means any measure which is submitted or is intended to be submitted to the voters of the state.

Gov.C., § 82051.
