# DESPEDIDA A DON JESUS HUESO

Don Jesús Hueso Brambila murió el día 11 de julio y fue velado en cuerpo presente en la Iglesia de Nuestra Señora de Guadalupe. Con un gran acompañamiento de parientes y amigos, la misa fúnebre fue con-celebrada por el Padre Brown, el Padre Rasura y oficiada por el Excelentísimo Sr. Obispo Chávez. El Mariachi de Frank Villaba acompañó la misa y siguió la despedida, al estilo Jalisco, en el panteón Evergreen de la Calle Imperial.

Hace nueve meses que don Jesús visitó el panteón Evergreen, buscó un sitio agradable a la sombra de un árbol frondoso y lo compró. Escogió la lápida de granito y mandó esculpir los nombres de él y su esposa con la fecha de nacimiento de ambos, 1930, dejando la fecha de defunción abierta al futuro.

Según sus hijos, su padre iba a durar cien años. Los padres de don Jesús aún viven a la edad de 95 años. El día 10 de julio cenó y se acostó a dormir como era su costumbre después de rezar el rosario. Hombre devoto, caballero chapado a la antigua, con los pies firmes en la tierra, en el trabajo y en el mundo de los negocios. Murió en el sueño sin quejarse y sin despedirse de nadie.

El poeta español Jorge Manrique del siglo XV (1440-1479), escribió las coplas más bellas de la literatura castellana por la muerte de su padre. El poema empieza

La Sra. Edna Manríquez es gerente de la oficina de Caridades Católicas, ubicada en la Calle Tercera, Número 241-A, en Chula Vista. Ella es una paralegal, especialista en asuntos de inmigración. Como es bien sabido, Caridades Católicas es una organización, sin fines de lucro, al servicio de la comunidad. Cada año atienden a miles de personas en todas sus oficinas ubicadas en todo el condado.

Edna nos contó que lleva nueve años trabajando con Caridades Católicas

desde 1987. Para darles una idea, 11,560 personas acudieron a consultas en Chula Vista en 1995.

La razón por esta entrevista con la Sra. Manríquez es para saber sobre los planes de apertura de tres centros nuevos de servicios de inmigración para ayudar a los residentes legales a hacerse ciudadanos.

Tengo entendido que abrieron ya tres centros para procesar las solicitudes de ciudadanía. ¿Por qué quieren abrir tres centros más? "Caridades Católicas quiere hacer un esfuerzo mayor y ayudar a procesar el mayor número de residentes legales posibles. Hemos abierto tres centros para cubrir las necesidades a nivel condado. Para más información, favor de llamar al (619) 287-9454 para hacer una cita.

"El primer centro está ubicado en la iglesia de Nuestra Señora de Guadalupe, Calle Anita, número 345, Chula Vista. Aquí atenderemos por la tarde el segundo y cuarto martes de cada mes. La primera sesión será exclusivamente para orientar. La segunda sesión es para que traigan toda la documentación necesaria para

procesar la solicitud, obtener las huellas digitales y tomar las fotografías.

"El Segundo centro está ubicado en Holy Trinity Catholic Church, 405 Ballard, El Cajón California. Aquí atenderemos el segundo y cuarto jueves de cada mes. Se seguirá el mismo horario de la tarde y el segundo jueves es para orientar y el cuarto jueves es para llenar la solicitud, huellas digitales y fotografías.

"El tercer centro está ubicado en La Misión San Luis Rey, Missión Road, número 7678, en Oceanside. Aquí se atenderá el primer y tercer miércoles de cada mes. Se seguirá el mismo horario, antes mencionado."

Edna, ¿cree Ud. que todos los residentes legales, después del debido tiempo legal de espera, deberían solicitar la ciudadanía?

"En términos regulares, por supuesto que sí. Para el propio bien de las personas es urgente que se hagan ciudadanos lo más pronto posible debido al clima anti-inmigrante que estamos viviendo antes de que les corten el uso de los servicios sociales y de salud. Pero hay excepciones. Solamente los residentes permanentes que tienen un historial legal limpio deberían hacerlo. Si tienen una felonía y no la declararon en la solicitud de ciudadanía, la oficina de Inmigración rastreará los archivos y al descubrir la felonía o felonías, negarán la solicitud y lo pondrán en estado de deportación."

¿Hay otras excepciones? "Si la persona mintió y declaró información falsa y la inmigración descubre la mentira, también lo pondrán en estado de deportación. Por ejemplo, si el marido entró al país y declaró ser soltero, aún siendo casado en su país de origen, y luego, después de la ciudadanía desea inmigrar a su familia, le pondrán en estado de deportación por haber mentido. Si la persona usa ó trafica con drogas y hay un archivo policíaco que muestre haber purgado una condena, ó haya sido detenido en el pasado, el Servicio de Inmigración puede abrir el caso Je nuevo y se le puede poner en estado de deportación."

¿Qué son las ventajas para hacerse ciudadano? "Pues, un ciudadano puede votar, obtener empleos donde solamente ciudadanos califican, y una vez que obtiene la ciudadanía, no se le puede deportar. Otra razón es que no tiene que renovar la residencia legal cada 10 años. No podemos predecir el ambiente de inmigración que existirá dentro de 10 años. Un ciudadano puede obtener un pasaporte de los Estados Unidos que le facilitará la salida y entrada al país."

¿Hace Ud. consultas gratis ó hay algún cobro por sus servicios?

"Todos los miércoles en la oficina de Chula Vista, de las 8:30 a.m. á las 9:30 a.m. ofrecemos una consulta gratis, en grupo, con respuestas en general. Si la persona desea un asesoramiento privado, cobramos una cuota mínima de \$10.00-\$25.00 dólares, dependiendo de la cantidad de tiempo que lleve la consulta.

"Sin embargo, si la persona desea solicitar la ciudadanía, se le ayuda a llenar la solicitud, hacer copias, tomar las huellas digitales y las fotografías. Nosotros nos aseguramos que la solicitud vaya sin errores para que no la devuelvan y haya demoras. Por este servicio se le

# Over 250 Chicanas expected at MALCS Summer Institute

Mujeres Activas en Letras y Cambio Social (MALCS) will hold its 11th annual Summer Institute Thursday through Sunday, Aug. 8-11 at SDSU.

The workshop is an effort between Chicana members of MALCS at UCSD, USD and SDSU. The conference, which will be held over four days, will be filled with workshops, entertainment and culture.

"We need to support events like MALCS that promote, expose, and highlight the contributions of Chicanas/Latinas in academia. The community needs to support these women to have a place to dialog and share their research and ideas," said Guadalupe Corona, fund-raising coordinator for MALCS. Corona is pursuing her master's degree

in leadership studies at USD.

MALCS was founded in 1983 by graduate students and professors to fight race, class and gender oppression experienced by Chicanas pursuing higher education. The organization brings together academic scholarship and community involvement.

More than 250 Chicanas are expected to attend the summer workshop from throughout the United States, as well as internationally. MALCS has always been able to attract Chicana participants, not only because it is a national organization, but because of the cooperation between the three San Diego universities.

One of MALCS' main goals is to provide a bridge and a balance between aca-

# An open letter to Hispanic leaders, organizations

The Republican Party has launched an unprecedented effort to invite Americans across the country to participate in the development of the 1996 Republican platform. This effort would not be complete without the support from our colleagues in the Hispanic-American community, and we are writing to you to encourage you to submit your ideas to help shape the Republican Party platform for the next four years

Republican National Committee (RNC) Chairman Haley Barbour said, "The Republican vision for our country is a vision based on America's values, not Washington values. We want to continue to work with Hispanic Americans to ensure their input in the national policy debate and to ensure that their wisdom and common sense are heard. It is our hope that anyone who believes in the fundamental principles of the Republican Party — lower taxes, less government power, greater individual freedom and more personal responsibility — will share their ideas with us."

In recent years, Republicans have been listening to Americans at the grassroots and working to reconnect the public with the national policy debate through scores of hearings and conferences held around the country by the National Policy Forum, a nonprofit organization devoted to the development and advancement of Republican ideas. "We have heard from literally thousands of our fellow Americans — families, young people, senior citizens — hard-working individuals who are making things better in their own communities. Our 1996 platform deliberations will build on that experience."

Like other Republican leaders, we have benefited enormously from the policy ideas gleaned from Americans at the grassroots by the National Policy Forum. Now, the platform committee is following through, adopting an open-door policy for ev-

eryone who wants to share with us their vision for a better America. The Republican platform committee now encourages Hispanic Americans at the grassroots to play an active role in shaping the Republican vision for America as it will be articulated in our 1996 Republican national platform.

The RNC has set up a Web site on the Internet for submitting ideas to the 1996 Republican platform. The Internet address is www.rnc.org. Or, you can send your ideas to Dave Gribbin, Executive Director, Republican Platform Committee, 310 First St., S.E., Washington, D.C., 20003.

Your comments will be shared with the platform committee, which is composed of delegates to the convention. Each state delegation, plus delegations from the District of Columbia, Puerto Rico, American Samoa, Guam and the Virgin Islands, chooses one man and one woman to serve on the committee. The platform committee, formally known as the Committee on Resolutions, develops the party's platform and presents it for the approval of the delegates to the convention. The platform adopted at the 1996 Republican National Convention will serve as the statement of principles that will guide the Republican Party for the next four years.

The 1996 Republican platform committee will convene on Monday, Aug. 5, in San Diego, Calif. The Republican National Convention will be held Aug. 12-15.

We urge all Hispanic Americans to take advantage of this most important and unique opportunity to help shape the platform of the party that represents America's values.

"Recuerde el alma dormida, avive el seso y despierte contemplando cómo se pasa la vida, cómo se viene la muerte tan callando..."

Don Jesús nació en Colima, Colima, México, aunque sus padres, abuelos y bisabuelos eran de la región de Tecalitlán y Pihuamo, Jalisco. Sus padres recién casados, huyeron hacia Colima para protegerse durante la Guerra de los Cristeros, de los años 30. Al concluirse la guerra civil, sus padres regresaron a la tierra natal de Tecalitlán. Al llegar a la edad escolar, don Jesús solamente cursó hasta el segundo año de primaria. Siendo el mayorcito de la familia, su padre lo necesitaba en el campo y fue toda la escuela formal que recibió.

La escuela de negocio la obtuvo con su bisabuelo materno, Concepción Brambila, alcalde de Pihuamo, que un día le dijo a su nieto, padre de don Jesús, "Dile a mi bisnieto, Chuyíto, que se venga acá a Pihuamo, y yo le doy una educación." El bisabuelo no le dio escuela, pero eso sí, le dio un curso acelerado de negocio de compra y venta de ganado, cobrador de rentas, y hazmelotodo, hasta de lavaplatos. Fue una lección que jamás olvidaría.

En 1950, a la edad de 20 años, don Jesús entró de indocumentado a San Diego, California, a reunirse con su tío Crecencio Hueso, que llevaba ya un par de años en los Estado Unidos. Inmediatamente consiguió trabajo de lavaplatos. Un día al salir del trabajo lo detuvieron los agentes de Inmigración y lo deportaron a Tijuana. Al poco tiempo

regresó y se propuso comprarse un traje y sombrero y solicitar la residencia permanente. Antes de salir de su trabajo, se cambiaba de ropa y salía por la puerta principal del restaurante. Con traje, corbata y sombrero, jamás lo volvieron a detener. Esta costumbre de andar bien vestido le caracterizó siempre hasta el día de su muerte.

En diciembre de 1954, regresó a Tecalitlán para casarse con Virginia Barrón Tejeda, amiga de infancia, con quien se carteaba con cartas amorosas. El licenciado Felipe de Jesús Hueso un día descubrió las cartas de sus padres y se admiró de la manera tan cortés que se trataban.

Don Jesús empezó su carrera de trabajador social después de muchos cursos de superación y en 1966 empezó a trabajar como aprendiz en la Neighborhood House de Barrio Logan. Pronto demostró su capacidad de mando v terminó siendo el director del centro. En 1981, con la excusa de que se terminaron los fondos, fue despedido. Demandó a Neighborhood House por discriminación y ganó el caso y le ofrecieron la dirección de nuevo. El rehusó y salió con la frente bien alta, pero dolido. Esta lucha le causó una severa depresión por la ingratitud que había sufrido, la cual duró un año para recuperarse.

Con sus ahorros y trabajando dos y tres turnos, logró comprar y rentar varias propiedades en Barrio Logan. En 1982, compró la compañía de Taxis, USA Cabs, con 20 unidades. Con el tiempo compró una tercera parte de la manzana de la calle Imperial donde se ubican los taxis. Montó un taller mecánico, un taller de carrocería y pintura, complementando la línea de carros de sitio. En 1984 formó

Según crecían, las tareas más desagradables se las pasaban al más chico. Francisco Hueso, el mayor, pasó por todas las tareas y recuerda los coscorrones que recibían si resongaban.

La herencia que les dejó a sus hijos fue la de gran emprendedor, buen hombre de negocios, cariño y cuidado de su familia, padre ejemplar y amante esposo.

Jorge Manrique, en otra copla hacia el final del largo poema, expresa el sentimiento que muchos de nosotros sentimos y admiramos en don Jesús, en vida.

# Two in support of clinics' decisions

As the president of San Diego's Coalition for Reproductive Choice, I applaud Planned Parenthood and WomanCare clinics for not being bullied by religious political extremists who wish to impose their beliefs on the rest of the world.

The National Abortion Federation reports over 1,700 acts of violence, including five murders, have been perpetrated against pro-choice organizations. Knowing this, it is an extremely courageous choice for these centers to remain open.

Often overlooked in the abortion debate is the fact that family planning clinics do a lot more than abortion. Abortion services represent 4.6% of Planned Parenthood services. The vast majority of women who go to Planned Parenthood are seeking birth control so they can prevent unplanned pregnancy.

The fact is that every day groups like Planned Parenthood and WomanCare do more to prevent the need for abortion than any so-called pro-life group could ever hope to.

The MALCS workshop sessions not only provide Chicanas with skills that will help them to succeed in the academic world, they also provide insight into the field of the arts and community service. At the workshops Chicanas are given the opportunity to explore the art of writing, el teatro, as well as to meet community activists.

Professors, artists and other guests will present throughout the conference. Included are: Dr. Norma Cantu, professor of English at Texas A&M International University, who will address "Current Trends in Chicana Literature: Theory and Approaches." She has published poetry, short fiction and critical essays. Her book, "Canicula: Snapshots of a Girlhood en la Frontera," a creative autobioethnography that chronicles her growing up in Laredo, received the Premio Aztlán in 1966.

Also, Adaljiza Sosa-Riddell, UC Davis — "Chicana Feminism: Past, Present and Future"; Josefina Lopez, playwright - "You Too Can Be a Chingona Chicana: Empowering Women through Theater, Poetry and Performance"; and Aurora Pelayo, from the Support Committee for Maquiladora Workers, who will speak on "Cross Border Solidarity between Women Organizing in the Maquilas.



"Si desea además tomar el examen de ciudadanía, se le ofrecen, además, 2-3 horas de preparación y repaso de las preguntas. Para ello, hay un cobro adicional de \$26.00 dólares. El examen se da en inglés y la persona tiene que demostrar que domina el inglés. El Servicio de Inmigración cobra \$95.00 dólares para procesar la solicitud de ciudadanía. De esa cuota casi nadie se escapa, amenos que existan circunstancias verdaderamente penosas."

¿Son estos servicios solamente para personas de bajos ingresos? "Para la ciudadanía y exámenes, todos pueden calificar y no se toma en cuenta el ingreso. individual o familiar."

¿Qué otros servicios ofrecen las Caridades Católicas? "Ofrecemos servicios completos de inmigración y representación en corte. Lo que no tramitamos son visas de trabajo para profesionales y no tomamos casos de visas de estudiantes. Contamos con el servicio de abogados de inmigración de Caridades Católicas para personas de bajos ingresos solamente y hay una cuota mínima y razonable.

En los nueve años que lleva aquí, ¿ha tenido casos de abusos y fraude donde se estafa a la gente por personas que se dicen pasar por abogados ó que perjudican a la gente dando mala información?

"Sin ir muy lejos, tenemos algunos casos de horror, de un par de señores en National City, que operan solamente por teléfono y que solamente van a la casa del cliente sin jamás llevarlos a una

"Ellos se anuncian en un periódico local haciéndose pasar por abogados, prometiendo permisos de trabajo a indocumentados, y la unificación familiar entre otros cosas. Un señor indocumentado de 45 años que lleva aquí con su familia desde 1987, acudió para solicitar un permiso de trabajo, cobrándole \$1,500 dólares por el trámite.

"En vez de tramitar el permiso de trabajo que no se da a personas indocumentadas, le solicitaron asilo político de México. El asilo político es dificilísimo de tramitar a menos de que sea un caso de amenaza de muerte si regresa a su país.

"Su caso no era nada de eso y el juez le negó el asilo político y lo puso en estado de deportación. Viéndose perdido, acudió a una señora de San Ysidro que se hace pasar por abogado y para representarlo en corte le cobró otros \$1,500 dólares. Lo citaron dos veces a corte y la señora nunca se presentó porque no era abogada y el juez la hubiera descubierto el fraude.

"El juez se compadeció de él y le dio una lista de agencias reconocidas por el Servicio de Inmigración y escogió mi oficina. Yo le asesoré y descubrí que apenas se gana la vida de jardinero y le costó mucho trabajo y desvelos juntar la enorme suma de \$3,000 dólares para pagar el engaño que le hicieron.

"Por no perjudicar a su esposa que está enferma, decidió mejor no pelear el caso y optó por una deportación voluntaria. Si hubiera venido antes conmigo, yo lo hubiera desengañado

inmediatamente. Ya me conoces, yo les digo la verdad aunque les duela y no es lo que quieren oír. Si el caso no tiene ninguna solución se los digo inmediatamente.

"El tercer caso de horror es de una señora que fue burlada por un señor de El Cajón que se hace pasar por empleado de Laguna Niguel. Este estafador le prometió apresurar su caso de ciudadanía que ya estaba en trámite por la cantidad de \$2,000 dólares. Como él decía trabajar allí, ella le creó.

"Viéndose estafada, acudió a nosotros y afortunadamente su caso se resolvió sólo sin la ayuda del mentiroso y ladrón. Ella no quiso demandar al tipo por no perjudicarse y por temor. Y como tu conoces el proceso legal, sin demanda no hay caso."

Edna, ¿Qué consejo le daría a la gente indocumentada sobre los permisos de trabajo?

"Deberían de acudir a nosotros primero y nosotros le diremos la verdad, sin engaños. Si la persona es indocumentada, el Servicio de Inmigración no otorga permisos de trabajo y es muy raro que se den. Por desesperados que estén, es mejor que no se dejen engañar, que al fin de cuentas lo que van a hacer es llamar la atención y conseguir una orden de deportación."



# CHCC's legislative conference here draws key political figures

Because of the current political campaign's increasing focus on issues which will have a direct impact on the business and Latino communities, the California Hispanic Chambers of Commerce (CHCC) is organizing a bipartisan conference on the election year agenda. "Election Year Agenda" will be held Aug. 9 at the Hyatt Regency Hotel in La Jolla.

Key figures from both political parties will participate in the event, as well as leading experts on immigration and affirmative action. The conference objective is to provide a balanced view of both party platforms and to provide information regarding various perspectives on two key issues from the political debate: immigration and affirmative action.

# Judge rules against RNC in lawsuit on protest sites

Federal Judge Rudi Brewster last week struck down plans by the Republican National Committee (RNC) to limit free speech outside the San Diego Convention Center during the week of the Republican National Convention. The ACLU of San Diego & Imperial Counties filed suit seeking to prevent the RNC and the City of San Diego from moving the San Diego Police Department's designated freespeech zone 300 yards farther away from the convention center.

After months of consideration, the SDPD designated a parking area across from the convention center as a site for free-speech activities during the Republican National Convention. The RNC objected on grounds that the site was too close and vetoed the SDPD's plans. The city designated a new site, three full city blocks farther away from the center.

"Judge Brewster ruled that the RNC's veto of the police department's designated speech venue was an unconstitutional act of censorship, and struck it down," said Jordan Budd, managing attorney of the ACLU of San Diego & Imperial Counties. "The judge strongly endorsed the First Amendment principle of 'scrupulous neutrality' in the regulation of free speech, and ruled that the City of San Diego could not give the RNC the right to relegate its critics to a more distant venue, simply to divert attention from their message. It's a great day for the First Amend-

provide neutral ground to discuss both party platforms and the issues of immigration and affirmative action in a balanced fashion," said Isabel Freeland, region vice president for the CHCC. "The debate has become too polarized; we hope to bring more reason and less emotion

# grant is highlight of recent Stand Down

The Vietnam Veterans of San Diego (VVSD) held Stand Down 1996 from July12 to 14 on the upper athletic field of San Diego High School.

Stand Down, which in the military is an order requiring combat units to be removed from the field and placed in relative safety and security for rest and recovery, was created in 1988 specifically for homeless veterans. By consolidating programs and services in one compound, Stand Down gives homeless veterans the opportunity to seek assistance from many agencies simultaneously.

From medical care to legal assistreatments, 200 veterans completed tance, from employment and housing. opportunities to substance-abuse counseling, or simply seeking the camaraderie of friends and the comfort of a shower and hot meal, all is available within the area of a baseball field.

The event is an effort of local military commands, veterans-service organizations, Veterans Administration, and social-service agencies. More than 50 groups and 2,000 volunteers make Stand Down possible.

Last year, according to VVSD records, 464 of the participants received 589 medical examinations and drug and alcohol assessments and referrals for treatment, 120 veterans received employment counseling, and 82 went directly into residential pro-

The annual event has become so popular that it has spawned approximately 90 Stand Downs across the country. This year in San Diego, 550 veterans and 60 dependents sought services, according to Gary Sheler, press liaison of Stand Down 1996.

Sheler stated that many times, due to medical reasons or lack of transportation, veterans are not able to seek the

programs and services provided by the Veterans Administration, but that here "there are no excuses.

Several veterans have reentered society following a Stand Down. Many return as volunteers. Each of the 26 tents housing the veterans during the weekend was led by such a volunteer. Numerous examples were given of previous Stand Down participants who are now back on their feet.

Marine Corps Recruit Depot Commanding General Gary Parks, who spoke to the veterans on Saturday, told of meeting a volunteer that day who now works at the Depot. Another example cited was of a veteran who is now a top engineer for a prominent hotel chain.

Still, for many veterans such as Ron Adamo, Stand Down is a first step.

"It's like the old times when we were like kids at a concert," Adamo said of the Stand Down atmosphere and camaraderie. Adamo, 48, was the first one through the gates, having camped out for four days in anticipa-

"I couldn't wait to get in here to take a shower and eat," Adamo said.

Adamo enlisted and served with the 1st Marine Corps Division in Vietnam in 1966-67, receiving three Purple Hearts. He suffers, he says, from Post Traumatic Stress Disorder (PTSD) and received 50% disability for the first five years after leaving the service. His disability was terminated, and he now has a claim to reinstate it.

"I am trying to get 30% disability back," he said.

Adamo, a Connecticut native, has been in San Diego for six months after having "drifted around the United States." He was eating in the food lines at St. Vincent de Paul when he heard about Stand Down.

Living on the streets, Adamo has seen homeless worse off than him, so he and Bruce Sosis solicit food from downtown restaurants to distribute to their fellow homeless once a week. Sosis, a dependent of a veteran, also attended Stand Down and sought as-

Judy Tadlock, a civilian volunteer who befriended Adamo and Sosis stated that what she had learned at Stand Down was that almost every one of the participants could be whoever they wanted to be; that they need to know that people care.

"Most of them don't have families left. A big portion are without mothers, dads or anyone giving them support to say, 'Hey, we can all do this together.' When I was growing up, I knew my aunts and uncles, because everybody stayed in the same town. You had moral support from the community. I remember growing up and half my fear of not getting into trouble was because I knew that if my mom didn't see me, an aunt or someone down the street knew who I was and would reprimand me or tattle on me. So that was a kind of community that kept it together. These people don't have communities anymore. The United States doesn't have communities anymore," Tadlock said.

Veteran Velma Anderson was attending her second Stand Down.

"I think it's great. I think it's wonderful. It helps you find jobs," Anderson said.

Anderson served in the Army from 1979-83. Homeless, she has used the housing services and hopes to be off the streets soon. According to Anderson, a poem she submitted to the National Library of Poetry has reached the semi-final round, and she hopes someday that the poem, "Sunshine and

Daydreams," will become part of a book of published poems.

"It's \$1,000 if I win that can help me," Anderson said.

Congressman Bob Filner, a member of the Veterans Affairs Committee, is also trying to help.

Amid the budget battles and cuts, funding was eliminated for the Homeless Veterans Reintegration Program, which provided support for Stand Down. This left VVSD short on funds for essentials such as food, water, ice, electricity, phones and sanitation. Filner, along with Assistant Secretary of Labor for Veterans and Employment Training Services General Preston Taylor, presented Dick Talbott, president/CEO of VVSD, with a \$100,000 grant.

"This is merely a down payment on what this society owes you, because it

has not done right by you," Filner said to the veterans.

Filner also stated that Stand Down was a great event, but that he and the organizers of Stand Down would like to eliminate the need for such an event, "because the whole society ought to be providing services that Stand Down provides all the time. It is our job to work out of Stand Down and make

sure that society does right by our veterans," said Filner.

"We supported the first Stand Down and will continue to support it," Taylor added.

San Diego City Councilman George Stevens and Assembly members Dede Alpert, Susan Davis, Denise Ducheny and Steve Baldwin were also in attendance.




