
With this idea then, she founded Latina Style, a magazine that targets Hispanic women who are between the ages of 18 and 50 in households with an annual income of more than \$60,000.

An Open Letter from Dr. Nestor Rodriguez Sociology Department University of Houston

Dear Mr. Yzaguirre

I read your comments in the January 12 issue of the Houston Chronicle newspaper praising the current border enforcement campaigns, which include elements of militarization. The Chronicle quotes you as referring to these border campaigns as "sound policy."

After a decade and a half of research among undocumented communities in the United States, and numerous visits to Mexico and Central America, I must strongly disagree with your endorsement of the present border enforcement policy. For decades, major U.S. urban and rural employers actively encouraged the flow of undocumented migrants to the country's economic centers. Moreover, during the 1940s to the mid 1960s the U.S. government undertook, with agribusiness, the massive Mexican labor importation policy of the bracero program, which spurred an equally large undocumented migrant stream. In many cases, apprehended undocumented workers were converted to braceros without being required to return to

Many men and women who currently must leave family and other loved ones behind to journey to the United States as undocumented migrants are victims of an economic crossfire from international and national policies that provide scarce resources for the maintenance of family and home. Others are fleeing horrifying political violence from perpetrators who operate with impunity. When apprehended, most undocumented political refugees face little chance of human redress in INS courts if they migrated from countries with U.S. supported regimes.

The many years I have spent interviewing undocumented migrants and their families in the United States and abroad lead me to the conclusion that the current "get tough" border enforcement policy is not the right response to deal with a human movement propelled by economic need and mortal fear of persecution. Placing U.S. military forces at the border only serves to recreate the image of closed societies abhorrent to cultures that value the ideals of freedom. Why not propose an immigration policy that is more attuned with the realities of the changing functions of the nation-state in the globalization process, that is, a policy that recognizes the de facto development of global regional markets of capital and labor?

Such a policy, I believe, must involve multinational collaboration with a studied program that uses not the labor cattle drives of the bracero program but the advantages of energetic, geographically diverse and fluid labor forces. When gainfully employed, these work forces generate public revenues and consumer markets affording additional opportunities for economic growth in this country and abroad. The wealth of nations, according to the Scottish philosopher Adam Smith, originates as much from human determination and drive as it does from unfettered commerce in ever expanding geographical scales.

I take no pleasure in publicly opposing your view regarding the present border enforcement policy. Indeed, I feel most uncomfortable. But I am compelled to do so by mental images of the faces of undocumented migrants who paid with their lives the highest cost of being undocumented. I am referring to Antonio who suffered an agonizing cancer death when undocumented status kept him from health care, to Pedro who walked onto a San Antonio freeway to end the emotional torment of family separation, and to a nameless young Salvadoran woman pulled down by Rio Grande currents as she attempted to reach the Texas shore

On November 7th, 1995, Bob Lanier ran for his third and final term as mayor of the City of Houston. Although he had two opponents, he still managed to pull in an impressive 104,222 votes. Because the office of mayor is generally agreed to be the most visible in the city, and because there is already ongoing speculation as to who might be stepping forward to run for mayor in 1997, we thought it would be useful to examine which voting precincts preformed the best with respect to the mayoral vote.

We have also included the votes received by the five at-large city council members and the controller's position so as to provide for several points of comparison with respect to current "voter pull."

Remembered that the precincts in the table below represent but a small part of the more than 1300 voting precincts that took part in the November '7, 1995 elections. The parentheses in the table indicate that another candidate received the greatest number of votes in that particular precinct.

O ne of the questions that one might considered as one examines the data in the table is whether there is a discernible coat-tail effect present. In other words, are there some candidates who are perceived as being close to the mayor who drew a similar number of votes because of this closeness?

Another question that one might ask is how many times did a city council candidate obtain more votes than the mayor. And given the precinct in which this occurred, what is the significance of this observation? See precinct number 259 for a case in point.)


