



# A full day's work

- 1** 8:30 AM—Assemblyman Ken MacDonald's day begins in his State Capitol office, where he goes over the day's schedule with secretary Sherri Hankins. Next comes a phone conference with his district office in Ventura about the results of a citizens' meeting which heard the pros and cons concerning a proposed four-year college for Ventura County.
- 2** 10:00 AM—The daily session of the Assembly is called to order, finding Ken MacDonald at his desk giving careful study to proposed tax reform legislation, a movement which has been a major project for Ken during his two terms in the Legislature.
- 3** 11:15 AM—Ken MacDonald addresses the Assembly on the subject of spiraling welfare costs, much of which is caused by administrative inefficiency and overlapping jurisdiction. As Vice Chairman of the Assembly Health and Welfare Committee, Ken is a respected voice on this subject.
- 4** 1:00 PM—After a quick lunch, Ken stops in Capitol park to say hello to a group of visiting youngsters from Ventura. Ken believes young people are our most treasured natural resource. Ken says: "A good leader must not only be a good talker, but also a good listener—and this is especially true when it comes to dealing with young people."
- 5** 3:00 PM—Ken's afternoon schedule is filled with Assembly committee meetings, a vital part of the legislative process. In addition to serving as Vice Chairman of Health and Welfare, Ken is also an active member of the committees on Joint Legislative Budget, Local Government, Public Employment and Retirement, and Joint Public Domain.
- 6** 6:00 PM—Assemblyman MacDonald participates in a late afternoon conference in the Highway Building concerning a new Motor Vehicle office to serve the Simi Valley and Thousand Oaks areas. Then Ken returns to the Capitol for another hour's work on correspondence and to prepare for tomorrow's legislative calendar.

# A solid record of accomplishment for Ventura County

Ken MacDonald is acknowledged by leaders of both parties to be one of the most effective and hard-working legislators in Sacramento. His major fields of interest include:

## **Drug Abuse**

Long concerned with the growing epidemic of drug abuse, particularly among our young people, Ken MacDonald has been a leading advocate of tighter and tougher laws to control the traffic of dangerous drugs and narcotics. This year MacDonald is the author of two key legislative measures to combat the drug menace: 1) a bill to establish a State Bureau of Narcotic Enforcement Office in Ventura County and 2) a measure which will provide a County-wide plan to coordinate all drug abuse prevention, treatment, rehabilitation and education programs. Passage of this legislation plus other bills Ken is supporting will mean far greater control of drug abuse in our area.

## **Environment**

Ken MacDonald is not a newcomer in the fight to protect our precious natural resources. Both as a County Supervisor and a State Legislator, Ken has fought for tougher air pollution controls, increased water quality standards, and the development of more parks and recreation areas to serve our rapidly growing county. His legislative efforts to protect one of Ventura County's greatest resources—its ocean sport-fishing industry—has received wide acclaim by sportsmen and conservationists alike.

## **Health Care**

As Vice-Chairman of the Assembly Health and Welfare Committee, Ken's expertise on health problems has helped bring about the development of new methods and programs to improve health services while at the same time lowering the high cost of medical and health care. Particularly concerned with child health programs, Ken has authored legislation to help prevent infant deformities.

## **Mental Retardation**

Through the efforts of Ken MacDonald, Ventura County now has a Regional Center for the mentally retarded which is providing a full complement of much needed services and financial help to mentally retarded children and adults in our County. Ken has also been tireless in his efforts to improve the quality of care at Camarillo State Hospital.

## **Crime**

Ken has consistently worked and supported legislative measures to increase state financial support to local law enforcement agencies. He is the author of legislation to crack down on welfare chiselers.

## **Tax Relief**

Ken MacDonald's philosophy on taxes is centered around the concept of reducing taxes by economy in government and by closing tax loopholes which have resulted in millions of dollars of lost revenues.
