

Bob:

I just completed the search for the names of the organizations on your list and here are the results. At this time, you may want to change the name associated with an organization, or add the organization name under a different address, and keep or delete the current name. For instance: I changed the name Kay Banyai to Lillian Goldstein, since you didn't have Lillian, and she is president of the League, and I happen to know that Kay's health is not good and she is very inactive in the League. You have a number of other names, with the LWV listed as the organization, but none of the names have a code that identifies them as LWV. That is not necessary, since the organization is listed under "Company or organization". I can look up names of organization in the phone book and try to get an address, if you want.

You, or the group, need to decide how best to code these names. I have been putting in a code for where they came from, but it might be good to re-code them as you do mailing. The whole purpose of having a code is to enable you to select a group for a specific mailing. Many people are on the list for more than one reason, I'm sure, because they belong to more than one group, but right now the only code is there because of WHERE I got the name— what list they came to me as part of. Maybe not now, but sometime you, or someone, should go over the whole list to see if it is better to have another code attached to someone's name. The code is simply to select, not to identify on the label.
