REPEAL THE INCOME TAX?



YES! We can repeal the income tax and return to the taxpayers over \$40 billion per year wasted on unauthorized bureaucratic activities.

This money will provide thousands of new jobs and unleash a new wave of genuine prosperity.

HOW WILL WE FINANCE THE GOVERNMENT?

Under the terms of the proposed **LIBERTY AMENDMENT** to the U.S. Constitution, there is no need for a budget deficit or to raise other taxes or add new ones. The **LIBERTY AMENDMENT** provides for cutting the current federal budget virtually in half.



CUT THE BUDGET WHERE?

Americans are aware that "foreign aid," farm subsidies, public power and other "pork barrel" projects do *not* raise our standard of living. Instead, they deprive us of hard-earned money to spend on our own wishes. And these powers have never been delegated to government by the legal, constitutional-amendment procedure.



HOW BIG IS THE PROBLEM?

Research has revealed over 700 federal agencies which—in one way or another—operate business-type activities without Constitutional authority. These range from loans for Eskimo dwellings to jungle road-building in Nicaragua, from operating sugar and coffee cartels to the manufacture of ladies' underwear.



HOW MUCH DOES THIS COST?

The losses of these unauthorized functions — plus the hidden costs of payroll, services, space, capital, and interest—amount to more than the money collected by federal personal income taxes. In 1959, these activities cost us over \$44 billion, compared with \$38 billion collected by income, estate and gift taxes during the same year.



CAN THIS BE PROVEN?

Yes! Over 19 years of research have produced an endless volume of supporting evidence. Losses have been effectively estimated by examining the government's own records—the U.S. Budgets, Government Organization Manuals, Audit Reports and Hoover Commission Reports.



WHAT DOES THIS MEAN TO ME?

Very simply, the amount of money you're currently paying in personal income tax is the amount of money unauthorized government ventures are costing you.

WHAT CAN WE DO ABOUT IT?



The proposed **LIBERTY AMENDMENT** — printed on the back of this pamphlet — will end all government economic enterprises not specified in the Constitution. After a 3-year liquidation period, the personal income and withholding taxes will be repealed.

NOT HAVE TO PAY INCOME TAX?



That's right! You can then use that money to buy the things you need or want — finance your child's education — or invest in your future — or take a trip — whatever you decide that you want to do with the money that you have earned.

WHAT MONEY WILL THE GOVERNMENT HAVE?

Excise and corporation taxes, duties, imposts and other miscellaneous taxes will provide ample revenue to finance national defense, the Post Office, and other legitimate activities specified in the Constitution.



WHAT ABOUT NATIONAL DEFENSE?

It will be strengthened. Over 19,000 totally irrelevant business-type activities — consuming half of our defense budget — will be ended. The Defense Department will then concentrate on military activities, instead of competing with private enterprise.



TOO GOOD TO BE TRUE?

Not only is it true, the **LIBERTY AMENDMENT** the most effective approach to the problem. Six states have already approved it — and it is pending in Congress as H.J. RES. 23. A campaign is on *right now* to secure approval in *every* state. In addition, over 6,000 organizations have endorsed the **AMENDMENT**.

Here is the full text of the LIBERTY AMENDMENT — pending in Congress as H.J. RES. 23 and approved by the state legislatures of Wyoming, Texas, Nevada, Louisiana, Georgia and South Carolina:

“Section 1. The Government of the United States shall not engage in any business, professional, commercial, financial or industrial enterprise except as specified in the Constitution.

“Section 2. The constitution or laws of any State, or the laws of the United States shall not be subject to the terms of any foreign or domestic agreement which would abrogate this amendment.

“Section 3. The activities of the United States Government which violate the intent and purposes of this amendment shall, within a period of three years from the date of the ratification of this amendment, be liquidated and the properties and facilities affected shall be sold.

“Section 4. Three years after the ratification of this amendment the sixteenth article of amendments to the Constitution of the United States shall stand repealed and thereafter Congress shall not levy taxes on personal incomes, estates, and/or gifts.”
