





LV Board Looks At GTE Cable TV System

The Leisure Village Association Board of Directors, at a special Working Board Meeting held in the AR on May 5, voted 3 to 1 to enter into negotiations to develop a contract with GTE Media Ventures to install a new cable television system in the Village.

The meeting was opened with presentations by Phil Shockley of Communications Services, Inc. and Rusty Cox of GTE. The merits of each suppliers' proposed systems were discussed in detail by Jim Gembala, LV General Manager, and by Elmer Eymann and Dick Travis of the Village TADS Committee. After the presentations a question and answer period followed.

The principal benefits cited by the CSI proposal were the maintenance of independence from outside TV suppliers and that programming more suitable to the demographics of the Village would be available.

The GTE concept had the advantages that by connecting to outside systems interactive TV, HD TV, digital and telephone services could be made available at a later date and their system can accommodate more channels.

In contrast, the GSI installation would be more costly since GTE is offering to put their system in at no cost to LVA. The costs for the GTE plan in the future may be higher than those of CSI but the differences cannot be defined at this time.

The meeting was held at this time to enable contract details to be completed so that construction can start this fall. Approximately 300 residents attended the meeting and it was taped by Channel 12 for a later presentation.

Further information as to how life in the Village will be affected by the installation of the new system will be published as it becomes available. Stay tuned.

Inspector Outlines Election Procedure

LV Election Inspector

It is the duty of each homeowner to vote. This election will be the first for the Village without cumulative voting.

There are three vacant seats on a five-person Board of Directors open for election. You can vote for three or less, but no more than **one vote** each. When you vote, do so by putting an X on the ballot. Be careful **not** to use numbers.

Also, if you mark the ballot "For Quorum Purposes

only," you may not then vote for any candidates. Please decide in advance which way you want to go. Disregarding these instructions may result in your ballot becoming invalid and not counted.

If someone asks you for your proxy, mark your own ballot and have him deposit it in the ballot box for you. If you do delegate your proxy, it is your responsibility to deliver that proxy to the person you name.

Ballot boxes will be available the day after the Candidates Night June 5. One ballot box will be located in the lobby of the Rec Center, and one in the lobby of the Association office.

Vote for the persons who you feel will do the most good for your Village.

Election Of Board Members

By now Village homeowners have received by first class mail a Call to Annual Meeting of the Leisure Village Association and a ballot to vote for three new Board members. This issue of *Inside Leisure Village* carries pictures and information on the five candidates running for the Board. Please read this information and be sure to attend the Candidates Night June 5 at 7:00 p.m. in the AR. Then you can make yours a truly informed vote.

This is the first election the Village has had since the elimination of cumulative voting, so the procedure will be slightly different. It is hoped that the new ballot, designed by a committee, will make the new rules clear. No longer can a voter "stack" his votes. There will be five candidates' names on the ballot and one can vote for any three of them. Choices should be made by placing an "X" after the three chosen names. No numbers should be used. If a homeowner writes in numbers on the ballot, that ballot will be declared invalid and will not be counted.

Dropping cumulative voting puts the Village in line with city, county, state and federal voting procedures, a more democratic way of selecting representatives.

Zoning

Fellow Villagers, do we want the traffic, the noise, the congestion, the crime, the glutted schools which would result if the land north and/or south of Santa Rosa Road were rezoned from commercial zoning to residential zoning? Do we want high density two story apartment buildings looking down in our back yards?

Whether the apartments are low income HUD housing or not, it would still be a lot of people.

Protecting the value of our homes and our safety is surely not NIMBY (Not in My Back Yard). It is just good sense.

The people in city government to whom I have spoken strongly advise us to inundate the Camarillo City Council with letters — the more the better. We need to tell the council members that low cost HUD housing is not compatible with a Senior housing community.

We need to tell the Camarillo City Council that they were elected to protect the quality of life in the community and hold them to it. You can also send letters to the Planning Commission of Camarillo.

Keep our eyes and ears open for the Planning Commission meeting and the Camarillo City Council meeting when rezoning will be decided and **BE THERE**. Tell them we do not want the land rezoned.

Changing the zoning on

either side of Santa Rosa Road is unnecessary. Changing the zoning to include low cost rental units is NOT a condition imposed on the city by FEDERAL regulations. The city of Camarillo now owns three properties more suitable for low cost housing than the property along Santa Rosa Road. Camarillo currently has a balanced proportion of low cost housing. An excess of low cost housing would overburden the city and bring serious problems.

When you write to the Pardee Construction Company, remind them that they have been advertising this area as a "Planned Community" for years. Make them stick to it.

Evaluate the Candidates

The upcoming June 19 election of three new Members of our Board of Directors is a most significant event in our Village. I offer these criteria for making this important choice from among the candidates. These criteria fall in four categories: intelligence, qualification, motivation, and character.

In evaluating "intelligence" I look not only for intellectual ability, general knowledge, and education, I also look for the ability to approach issues from a broad system point of view, and for common sense.

I am wary of "tunnel vision," one-issue advocates. Common sense means to me the ability to recognize what **can** be done realistically, as opposed to what one might **wish** idealistically.

What I would look for are qualifications that are relevant to the arduous tasks the Board member will face in office: tasks that will require skills in management,

finance, engineering and maintenance, and personnel relations. Knowledge of our Village is an essential part of these qualifications, as is prior involvement in Committees and Village activities.

Equally important is motivation. It seems vital to make sure that the candidate is not just running for reasons of self-promotion but is truly interested in doing what is best for the village, that he or she has no "hidden agenda". A wrongly motivated Board Member is a latent disaster waiting to occur.

Last and not least is the obvious requirement of character: honesty and integrity, ideally combined with compassion and some humility. It is not just a matter of not cheating or not lying. Board Members must be truthful in dealing with staff and homeowners. They must be willing to face and answer questions, even if the answers include "no" or "I don't know."

It is also very important to remember for whom not to vote. I am very much concerned about certain "wrong" reasons some use in deciding for whom to vote. One should not vote on the basis of friendship alone, or just because a candidate is "such a nice person." One can surely find many ways to express affection or respect or gratitude for friends, but selecting them to represent you in this most important function should not be among those ways.

I am especially wary of candidates who have a "personal agenda" for running: a specific personal cause to be promoted, or some anger or vendetta to be fulfilled.

Most important of all, let's not forget to vote on June 19.



**Free Testing For Early
Recognition Of Loss Of
Memory, Concentration,
Problem Solving And
Depression.**

A nationally known professor from U.C.L.A. has developed a software product for medical doctors that will (A) Assess thinking, feeling, and problem solving capacities among persons 55 years of age and older; (B) Evaluate the effects of medical interventions; and (C) Assist doctors and healthcare managers in improving the quality of medical care at a significantly reduced cost.

L.V. residents are asked to volunteer in the testing of this computer software to assess and improve its effectiveness and to develop normal test performance profiles for persons 55 and

older.

Y.N.C.G. is coordinating the testing, which will be done here in the Village.

Testing works in the following manner: volunteer sits in front of an advanced computer screen. (No computer experience is needed.) To answer simple questions or to solve problems, he touches the screen in a prescribed way. A practice session is given first.

After the tests are completed, a record of the volunteer's test is printed and explained. Test results will be made available to each volunteer, and to his doctor, if needed.

Confidentiality will be preserved. The tests will take 35-40 minutes and will assess only things that individuals do every day such as to remember, solve problems, feel depression, and concentrate.

Results promise to be of significant value to medicine, particularly in the care and treatment of the elderly.

A copy of the test software (value: \$4,500) will be given to Leisure Village at no cost, to be used at their discretion.

As an added incentive to volunteers a California State Lottery ticket will be purchased for every person and placed in a common pool. Winnings will be divided equally. At least 1,000 volunteers are wanted.

Testing will begin in July, and could last for three months. Details are still being worked out. To register, call Sonia Brink at 484-2387, or Sandy Okum at 482-8125.

Point Mugu Update

The Navy is considering the relocation of E-2 reconnaissance aircraft from the Miramar Naval Air Station and basing new FA-18 E/F fighter planes. Point Mugu is one of the sites under evaluation as a possible home base for these aircraft and required operating and maintenance personnel.

Although no official environmental impact statements have been released, it appears that basing E-2 aircraft at Point Mugu would probably not generate a significant noise problem locally. This is due to the fact that the E-2 is a propeller driven craft and so quiet that they have been nicknamed "Hummers" by the military.


In contrast to the E-2s, the FA-18s are jet aircraft probably capable of generating high noise levels. In addition, costly and extensive modifications of exist-

ing runways would be necessary to accommodate the FA-18s. The E-2s can use the existing runways.

According to Rep. Elton Gallegly, the Navy has indicated strong preference for a rival site (Lemoore Naval Air Station) which apparently has adequate runways and is located in an area much less populated than Ventura County. He has also indicted that Point Mugu is highly favored by high Navy personnel as a home base for the E-2 squadrons.

Tentatively, from a noise pollution standpoint, the basing of the E-2s does not appear to be objectionable. Those who object to high level noise caused by FA-18 operations can contact the Navy.

No Room Additions In Leisure Village

The use of the words "Room Addition" when describing the structure some villagers have constructed to enlarge the inside livable space in their homes can increase the Real Estate Taxes you pay to Ventura County. In fact the addition of a room to your home is **not** permitted by the City of Camarillo Building Department laws that authorized the construction of our planned Senior Citizen Community.

Don't panic! There is an explanation and you should be careful when you talk about the structure you have built over your patio slab. That is called a "Patio En-

closure." Its construction is subject to the conditions contained in LVA Architectural Specification #180 and the City of Camarillo Building Department Laws.

Originally, the City authorized the construction of fences around the patio. Later they authorized the construction of a "roof cover" over the patio. That then evolved into permission to place a "Factory Panelized Roofing System" (Spec #185) over the patio. When residents wanted to protect themselves from wind and dirt on the patio, the City allowed us to put up windows and walls that enclosed the patio. We called this a "Patio Enclosure."

The Architectural Committee recognized that this panelized system had to be improved. The enclosed patio was too cold in the

winter and too hot in the summer. This led us to the next step, which is contained in Specification #180. This specification allows the construction of an enclosed patio that your contractor can insulate and air condition. We regulate the construction of the outside of the structure that includes the foundation, the walls, the roof, the connection to the existing roof and the outside water supply. You and your contractor must comply with the City Building Department codes concerning the finish of the inside of the enclosure.

If you refer to the patio enclosure as a room addition, the County of Ventura Tax Assessor will charge you a higher rate for this improvement. *Don't* use the wrong terminology!

Tell your Real Estate agent to say you have a "Patio Enclosure."


Goals For LVA:





GUIDELINES FOR CONTRIBUTORS TO ILV

Reporters and publicity people submitting material to be used in Inside Leisure Village will help out the staff (and may enhance the reception of their material) if they will follow basic guidelines. These include:

1. Type all material, or we must take time to type it, a delay. If handwritten copy is absolutely necessary, submit it early.

2. Use full size 8" x 11" sheets of paper. Odd size sheets can get lost.

3. DO NOT TYPE IN ALL CAPS: stories in all caps must be retyped.

4. Put writer's name and phone number in upper left corner.

5. Leave 2" of space at top of page for our notations.

6. Type group's name and writer's byline.

7. Double space each line and indent each paragraph.

8. Put the name of your group into the FIRST sentence of your story. This makes it easier to match with the right logo, if you have one.

9. Be sure your copy can be easily read. Do you need a new typewriter ribbon? Do the keys need cleaning? No red ribbons, script type or Xerox copies, please. Clean copy pre-

vents misunderstandings.

10. Submit your story on time. Deadline is Monday at 5:00 p.m., usually the first Monday of the month. Deadlines for the next paper are listed on page 2 of each issue. Please check the exact deadline and meet it. All material should be placed in the ILV mailbox in the east hall of the Rec Center.

11. If your story must be late, call the coordinator and tell her when you can get it in and why it must be late. Coordinator has the OPTION to accept or refuse the copy.

12. Call the coordinator to arrange in advance for a photographer to cover your event. Do not call the photographer directly; he works on assignment from the coordinator only. Planning for each issue, including pictures, starts the first week of each month, so if you want pictures, we need notice.

13. A news story is not minutes of your meeting. Reading about events two months old is dull. What is coming up for your group? Feature future events.

14. If ILV must cut your article because of space, the cutting generally starts at the end, so put your important information at the top, and then give the details.

Once Upon A Memory: Let Down On A Ski Lift

Our family considered Mammoth Mountain the epitome in ski fun. The whole feeling of being on this tremendous mountain was one of heightened awareness and awe. Riding the chair lifts was part of the thrills: what if one stopped midway up the mountain?

Kay and our two sons were skiing together on Chair 1 at Mammoth one morning just after a snow storm. Steve, 12 years old, was by then a competent skier and rode with a companion up a chair just ahead of Kay and 8-year-old Douglas who was overweight and far from self-confident. Just before the chair reached the summit, while the slant of the lift was at its height, 20 or 30 feet above the snow, the chair stopped. Dead.

There was no simple way to rescue oneself. Wait. Soon, from the top ski patrol hut came a figure. He had a hip length cast on one leg, a coil of rope over his shoulder, and he scrambled through almost hip deep new snow toward the first of the stranded skiers. Steve and companion were on that chair.

The ski patrol rescuer instructed them to take off

one ski and let it drop to the snow below, also drop the ski poles. With a light line attached to a heavier rope, he tossed the line over the cable which carried the chairs, and allowed it to slide down hill until the riders could catch the line. There was a loop in the rope into which the skier slid his one remaining ski, he stood up, holding firmly onto the rope above his looped ski, the ski patrolman counter-balanced the skier being lowered on the rope with his own body weight. Once on the ground, the skier retrieved his other ski, his poles, his dignity, and he was free to carry on.

Steve managed the descent with no problem. Then it was time for Douglas. Kay was worried that the boy would be too frightened to carry out instruc-

tions, but with encouragement both from the ground and from his dad, Doug got down unhurt, even though he was half buried in the snow as he got to the ground and collapsed backward.

Then it was Kay's turn. He followed the pattern, and went down handily, but his weight, well over 200 pounds, over whelmed the ski patrolman who was holding on to his end of the line. The patrolman rode upward as Kay rode down. The patrolman slid back down the rope to snow level and continued the process of rescuing other skiers.

Skiing was over for that day—electrical problems kept Chair 1 and the rest of the mountain quiet. The experience of being rescued from a stalled ski lift has furnished material for many "Remember whens —?"

Perhaps it's time to pay tribute to those Channel 12 volunteers who put on the taped programs each Monday, Wednesday and Saturday.



Dr. Evans Speaks About "Your New University"

The new University will be designed to help the region's economy, according to Dr. J. Handel Evans, president of the California State University Channel Islands. Studies will include agriculture, education, business administration, high technology studies, communications, bio-medical and environmental concerns, tourism, health care, and other diverse fields which society will need in the coming years.

Dr. Evans spoke at a combined Current Issues Forum and R.V. Club meeting on April 18. Lillian Hawthorne chaired the meeting and introduced Dr. Lee Truman, new resident in L.V., who in turn introduced the featured speaker, Dr. Evans.

There was no description of a campus, nor a specific location named, but Dr. Evans stated firmly that there will be a university in Ventura County soon. The new university may not conform to a previously pictured institution, as teaching may be accomplished by electronic equipment—television, tapes, satellite

transmission from around the world, and may be in session 7 days a week, 24 hours a day. It may cater to a large segment of the population which desires a higher education: older adults 25 years of age and up, who work part or full time, who may be women, and Latinas.

The University could if necessary be housed in vacant stores, or if financing is found, a campus could be built to accommodate the young high school graduates who can attend full time. That campus would not have a football stadium—too expensive.

Dr. Evans cited statistics to indicate a genuine need for a university in this area, and although some of his ideas seemed ultra-progressive to old-time university students, his dreams represent the future. Our grandchildren will be running the country in another few years and the university in Dr. Evans' plan will meet the needs of a new generation, but will have to be accomplished within the tight financial picture of today's state economy.

Enthusiastic Response To Headliner Proposal


