Dear Sotero:

In reviewing my files recently, I noticed an item which I should have brought to your attention previously. In a letter from former Sierra N.F. Supervisor Zane G. Smith to the Regional Forester, dated March 16, 1970, Zane spelled out policy regarding establishment of Frontier Units in general, and of the North Fork and Cassidy-Junction Bluff Frontier Units in particular. The file references were 2320 Wilderness and Primitive Areas and 2130 Ranger District Plans.

In that letter Zane stated, "This management direction responds to a need the public has expressed for areas where they can experience a feeling of solitude and adventure short of classified wilderness. We have an opportunity to meet these needs in many scenic undeveloped areas within the Crest and General Forest Zones...Where we have like situations in other parts of the Forest, we plan to manage these areas under similar management direction..."

There seems to be a clear implication here that Zane had anticipated designation of additional areas within the Sierra N.F. for "similar management direction." Also, from various discussions I had with him I recall that he had been thinking of administratively designating a number of areas which would be intended to remain roadless. In fact, at one time he showed me a map on which a considerable number of such areas had been roughly outlined.

The purpose of this letter is to ask what ever became of that idea. Is it still under consideration, or was it eventually rejected?

In that vein, I might point out that neither "scenic" nor "undeveloped" qualities are necessary to achieve a "feeling of solitude and adventure." There are many areas within the Sierra N.F. which do not fit the classic stereotype of "scenic", and which are not "undeveloped", but which could offer opportunities for a "feeling of solitude and adventure" provided the Forest Service would manage them with that objective in mind. To clarify this, perhaps I should explain that there are many types of "development" which do not involve access by motor vehicle; and if motor vehicles are excluded, the opportunities for "solitude and adventure" are enormously increased.

Thoughtful management would increase those opportunities even further.
