# **Lambert** Named Outstanding Professor

Educational Leadership Professor Linda Lambert was chosen the "1999 Outstanding Professor" at California State University, Hayward by the Academic Senate.

Lambert, who has spent more than 30 years in the field of education, receives the \$1,000 George and Miriam Phillips Outstanding Professor Award and will be the featured speaker at Faculty Convocation in the fall.

Prior to joining the CSUH faculty in 1987, Lambert was a teacher, curriculum coordinator, middle school principal, and school district administrator. She helped establish the California School Leadership Academy and the state's first Principals' Center.

At CSUH she chaired the Department of Educational Leadership twice and served on the Futures Committee, the Research Committee, and the advisory board that helped develop the Contra Costa Campus.

Lambert spent two years in Egypt (1989-90) helping develop the National Curriculum Center that has created the country's current educational system. Over the past eight years, she has continued to work with the center on various projects, including one to develop schools for girls in small villages who never previously attended school.

In addition to her many presentations, papers, and workshops, Lambert has authored or coauthored several books, including Building Leadership Capacity in Schools (1998); Who Will Save Our Schools? (1997); and The Constructivist Leader (1995).

# CSU Initiates Program For Teachers Without Credentials

California has 30,000 not-yet-credentialed teachers in its classrooms, the result of enrollment increases, class-size reduction, and teacher retirements.

To help remedy this, the California State
University system developed CalStateTEACH, a program to enable uncertified elementary school teachers
to earn multiple subject credentials while continuing
to work in their classrooms.

The inaugural 18-month training cycle will begin in the Fall 1999 quarter. Teacher-interns will

receive instruction from books, videos, audio tapes, the Internet, and five Saturday seminars. In addition, they will get support from a network of university faculty, mentors, and principals at their own schools.

California State University, Hayward, has been named the lead campus for the Northern California CalStateTEACH Regional Center, and CSUH administrator Jodi Servatius is academic director for the new center.

The Bay Area Trade and Friendship Mission to Africa in April included three delegates from California State University, Hayward. Attending a meeting in Ghana were, from left, **CSUH Dean Arthurlene Towner** (School of Education and Allied Studies), Congresswoman Barbara Lee, CSUH President Norma S. Rees, Ghana's first lady H.E. Nana Konadu Agyeman Rawlings, and Oakland City Councilmember Jane Brunner. President Rees said the visit gave her the opportunity to discuss educational issues with university leaders in Ghana and South Africa.



# Alumni Make Capitol Gains

When elected officials converged on Sacramento in January, four former California State University, Hayward, students were among those holding office. During interviews from their capitol quarters, these alumni reflected on their college days and life since leaving the university.

#### **Assemblymember Scott Wildman**

Scott Wildman, a teacher-turned-legislator, is proud to call Cal State Hayward his alma mater.

"I think Cal State Hayward has the best teaching credentialing program anywhere. It certainly is the best in the state," said Wildman, who earned his credential in 1982.

The legislator, elected to the Assembly in 1996, represents the culturally diverse 43rd District (East Los Angeles). It was his experience as a classroom teacher, laboring for public school issues, that triggered his decision to enter politics.

During the early 1980s, Wildman worked with the Bay Area Bilingual Education League and while enrolled at Hayward was engaged in an innovative, urban-classroom, teacher-training program.

"The Hayward experience of working with people working in the community gave me a real practical education," Wildman said. "I learned you have to involve the whole family if the child is going to be successful (in school)."

As a teacher in Richmond in 1992, Wildman found himself in the middle of an educational financial crisis. "That was the year Richmond went bankrupt. I took an 11 percent pay cut and had 33 kids in my class. Our school had 800 students, and it was built for 400," Wildman said.

This experience gave Wildman the inspiration to go into politics as an advocate for education. He sought an Assembly seat in the East L.A. area that includes Glendale and Burbank, focusing his campaign on rebuilding schools and overhauling the education system. Outspent 12-to-one in the 1996 campaign, Wildman won the election by 192 votes. Two years later he was returned to office by a majority of more than 30,000 votes.

Education remains Wildman's number-one

issue. He counts as one of his achievements the Wildman-Kelle-Solice Teacher Training Act of 1997, which re-established and expanded a paraprofessional program similar to the one he participated in at Hayward 20 years earlier.

"I had incredible support from the faculty at Hayward. They were on the cutting edge and were very aggressive in working with school districts to keep and expand the bilingual program," Wildman noted.

Wildman is married and has five children and seven grandchildren.

#### **Assemblymember Ellen Corbett**

Education is a big component in the career of newly elected Assemblywoman Ellen Corbett, whose 18th District includes Castro Valley, Hayward, San Leandro, San Lorenzo, and sections of Pleasanton and Sunol.

She attended Cal State Hayward from 1973 to 1976, eventually getting a bachelor of science degree in political science at the University of California, Davis, and a law degree from Sacramento's McGeorge School of Law.

Corbett's interest in politics emerged when she was studying marine biology at CSUH.


Through her contacts in the campus political science club, she met individuals involved in local politics.

Her early exposure to political life came from her father, a community activist.

"I thought people in politics sat around on weekends and licked stamps and distributed flyers throughout neighborhoods," says Corbett.

What she discovered was a world she found more intriguing than marine biology.

While at CSUH, she participated in a political science internship program, supervised by James Fay, currently interim dean of the School of Arts, Letters and Social Sciences. Corbett said she learned about public advocacy while serving as an

intern for then-assemblymembers Bill Lockyer and Johan Klehs.

Corbett maintains a law practice in San Leandro, where she was mayor and a City Council member. Her public service also has included memberships on the San Leandro and San Lorenzo school liaison committees and on many regional panels in Alameda County and the East Bay. She also served on the staff of former Assemblyman Elihu Harris.

Currently she is a member of the Cal State Hayward Advisory Board.

"There was a climate at CSUH that allowed people to work and go to school as well as have a practical academic experience," Corbett said.

#### Assemblymember George House

George House is an Oklahoma native, the eldest of 14 children in a family that was transplanted to California's Central Valley when he was a teen-ager.

While he describes himself as a "small-scale farmer," in his nearly 70 years House has managed to squeeze in a 30-year law-enforcement career, a stint as a creamery worker, and a civil post as a juvenile traffic hearing officer.

In 1994 he was elected to represent the 25th Assembly District and is serving his third term in office.

After attending Modesto Junior College, House earned a bachelor's degree in psychology from Fresno State College. He enrolled at Cal State Hayward in 1967 and 1968, midway through his career with the California Highway Patrol, when he developed an interest in obtaining a teaching credential.

"I loved it and learned a lot," said House, who was impressed by the quality of instruction at Hayward. He recalled especially those instructors who encouraged free and open discussions.

"It was a good experience," House recalled.

House put his teacher training into practice, teaching law enforcement courses at Delta College in Stockton while serving as commander of the California Highway Patrol division there.

House did not remain a teacher, but his interest in education and love of learning led him to become a member of the Hughson High School Board and to a term as president of the Stanislaus County School Boards Association. He is also a strong supporter of Christian schooling.

"I think the experiences of living have really helped me in my profession," House said. "I was raised in poverty—serious poverty—but I was taught we all have to work and there is a right and a wrong. I know I can make a difference."

The assemblyman is married and has five grown children. Term limits will take him out of the legislature when his current term expires.

#### **Attorney General Bill Lockyer**

Attorney General Bill Lockyer can be seen, on occasion, jogging around the track at Cal State Hayward. After all, this is his hometown.

The university is in the district he represented first as an assemblymember, then as a state senator. It is also where Lockyer obtained his teaching credential in 1966 and where he was honored as CSUH Alum of the Year in 1997.

In addition to his Cal State Hayward roots, Lockyer has been a longtime advocate of education legislation, acknowledged in 1998 when he received the "Friend of Higher Education Award" from the California State University system.

Lockyer said Cal State Hayward gave him an opportunity to pursue theories of education that have become part of his personal learning philosophy.

"I learned a lot about human behavior and motivations," he said.

Although Lockyer completed his student teaching in Castro Valley, he chose to work for the late Assemblymember Robert Crown after obtaining his secondary teaching credential. He also was elected to a local school board.

"I still think of myself as a student and learn new things every day," Lockyer said.

The attorney general says candidly that he chose Cal State Hayward for his higher education experience because it was his hometown university. He added he highly recommends the school for people who want a teaching career.

Lockyer was particularly gratified to be chosen Cal State Hayward's 1997 Alum of the Year

"I was honored to receive the award and be able to have helped shaped education in California. It is nice when your friends at home acknowledge you," he said.

As a legislator, Lockyer fought for and won increased funding for public schools in order to reduce class-size and raise teacher salaries. He also helped defeat efforts to increase student fees at UC and CSU campuses.

Elected attorney general last November, Lockyer said he loves his job in politics.

# **Belk Honored As** 1999 Alum of the Year

Judy Belk, vice president of Global Public Affairs for Levi Strauss & Co., is the 1999 Cal State Hayward Alum of the Year.

Alumni Association President Nancy Tackett said, "Judy Belk is an extraordinary woman. She is committed to community service and dedicated to her alma mater."

Since earning her master's degree in public administration from Cal State Hayward in 1978, Belk has continued to support the university. She is a member of the Alumni Association, the Educational Foundation Board and Cal State Hayward Ambassadors. She works on behalf of the university's scholarship and fund-raising programs, and last year she and her husband, Dr. Roger Peeks, hosted an event for elected officials and community leaders in their Oakland home.

"I am very honored by the recognition the Alumni Association has bestowed upon me," Belk said, adding it was especially meaningful coming "from an institution that I care so deeply about."

Belk was vice president of Community Affairs for Levi Strauss & Co. until last year, when she was named vice president of Global Public Affairs with responsibility for the company's worldwide communications, community relations, and government affairs activities. In her current post, she also continues to oversee the company's corporate citizenship and philanthropic initiatives worldwide, including the Levi Strauss Foundation with assets over \$115 million.

University President Norma S.
Rees said, "Judy Belk is an outstanding representative of this university and an excellent choice for Alum of the Year. We are grateful for her continued support of Cal State Hayward her understanding of higher education issues, and her commitment to public service and higher education."


