Karen Starleaf, representing the Rape and Sexual Abuse Center of Ventura County reviewed the programs being severely reduced due to funding shortages.

### IX. Fiscal Report

- A. The Departmental Revenue Subsidiary Ledger for the Commission for Women, period ending September 21, 1990 was presented. Copy is on file at the Commission Office.
- B. M/S/C Flock, Thomas that the 1991 National Association of Commissions for Women (NACW) dues be paid in the amount of \$125.00. (Account #2523)
- C. M/S/C Flock, Cortes that Oxnard Rental Center be paid \$278.81 for expenses relating to the Survival Skills Day. (Account #2523)

IX. Fiscal Report, continued:

- D. M/S/C Harris, Thomas that the Commission financially support, in the amount of \$250, the Alliance for Women's Safety Conference being held October 18, 1990. This conference is an outreach to the Hispanic Community with culturally relevant materials being sponsored by the Ventura County Coalition Against Household Violence. The conference is being provided to monolingual Spanish speaking community at no cost to the participants and includes child care. The amount of \$250 is to be paid out of the CFW Trust Account.

It is to be noted that Commissioner Teresa Cortes, from the 4th Supervisorial District is the keynote speaker.

- E. M/S/C Harris, Flock that the Commission contribute \$250 toward the expenses of maintaining the 24-hour crisis telephone line and \$150 toward scholarships for counseling the victims of rape and victims of incest. The 8 week counseling sessions are run by professional therapists. The total amount of \$400 will come from the CFW Trust Account. These services are being provided by the Rape and Sexual Abuse Center of Ventura County.
- F. The matter of upgrading the existing computer system in the CFW office will be researched further and placed on the November agenda.
