



# A Statement From Death Row

by Mumia Abu Jamal, SCI-Greene, Waynesburg, PA, October 31, 1998

Once again, Pennsylvania's highest court has shown us the best justice that FOP (Fraternal Order of Police) money can buy. Ignoring right reason, their own precedent, and fundamental justice, they have returned to the stranglehold of death. In their echoes of the tortured logic of Judge Albert Sabo, they have reflected a striking fidelity to the DA's office. If it s fair to have a tribunal who are in part admittedly paid by the FOP - and at least one justice who can double as DA one day and a judge the next in the same case – then fairness is just as empty a word as "justice". To paraphrase Judge Sabo, it is "just an emotional feeling."

In recent months the Pennsylvania Supreme Court has upheld death sentences in cases where an impartial reading of transcripts or pleadings would make an honest affirmation all but impossible. They have ignored all evidence of innocence, overlooked clear instances of jury taint, and cast a dead eye on defense attorneys' ineffectiveness. What they have done in my case is par for the course. This is a political decision, paid for by the FOP on the eve of the election. It is a Mischief Night gift from a court that has a talent for the macabre.

I am sorry that this court did not rule on the right side of history. But I am not surprised. Every time our nation has come to a fork in the road with regard to race, it has chosen to take the path of compromise and betrayal. On October 29th, 1998, the Pennsylvania Supreme Court committed a collective crime: it damned due process, strangled the fair trial, and raped justice.

Even after this legal legerdemain [sleight of hand] I remain innocent. A court cannot make an innocent man guilty. Any ruling founded on injustice is not justice. The righteous fight for life, liberty, and for justice can only continue.

### A Response Regarding an Exchange of Views on the Militia Movement

Dear Michael,

I found the Volume 11 #3 (Fall 1998) issue of Turning the Tide well worth reading. I have been sharing the material with folks here in Oregon and elsewhere who are focusing on the environment and corporate accountabilty and mostly are not focusing on racism as their primary activism. In other words, I feel there is fertile ground for some cross-movement alliance building which could strengthen our respective movements.

I have worked almost full time as an activist in a wide range of environmental issues and social justice support (including for indigenous issues) since 1980. Recently, I'm focusing more and more on bringing down corporate power directly by dismantling the mechanisms of corporate control. I became part of the Program on Corporations, Law and Democracy (POCLAD) to better achieve this. I speak on these topics around the northwest, and have helped organize successful **End Corporate Domination groups** and conferences. But I also live and work in the heart of the "Wise Use Movement"/militia country in eastern Oregon, trying to stop the most destructive federal timber sales in three national forests out here. So of course the subject matter in your fall issue interested me a great deal. In particular, I wanted to comment on the exchange regarding the militia movement.

Although I largely agree with Dave Stock's perspective on militias, I think both sides had some valid points, and that both sides of the debate glorify the assumed necessity of violent revolution too much. In fact, there is a populist spirit among sectors being organized to the militias that can be tapped into, that is also 'progressive' (although the term 'progressive' has reformist connotations to me and I don't like it). For example, the Idaho Rural Council is strongly anticorporate and supportive of things like organic farming and renewable energy, while

representing small farmers and ranchers (who in my area of eastern OR are heavily dominated by the "Wise Use" agenda) in a politically 'conservative' (i.e., reactionary) state. So the situation is not so black and white as portrayed in the duality of the militia debate.

That's the problem with the debate or argument format. The two writers are trying to win over or discount each other, rather than coming to terms with points of truth on each side, and to learn from each other; this is typical of U.S. anti-culture. Anyway, I agreed with some of James Murray's critique of comfortable white 'vanguard' intellectualizing even as I wondered how representative his contacts with militias were, and rejected his easy acceptance of 'casual racism.' I agreed with some of Dave Stock's criticisms of reactionary and racist thinking in militias. I think we can create the future (or limit it) with our ideas, so why does Stock limit his perspective of the future to taking up arms as the only way out? I think this is rather outmoded and suicidal. Why does James Murray wait for someone "to give us the struggle we desire"? I'm an anarchist, too, but I'm not waiting for someone to hand me a struggle. I'm trying to set the tone of the struggle I'm in and working to change things nonviolently if at all possible.

Also, anarchism does not mean that our strategy is disorder. I prefer the vision of fostering mutual aid through the real work of grassroots organizing. If this can work, it's certainly preferable to the real-life bloodshed, terror and grief of war. Anyway, I'll continue reading and hope to open a dialogue (more so than a debate) between us. I will try to develop an article for your next issue about POCLAD and why our approach of dismantling the mechanisms of corporate rule (and dismantling the transnationals themselves) is relevant to anti-racist action. I want to talk about how this approach can help build alliances across movements and strengthen each movement's efforts. Would other chapters of ARA be interested in receiving material from POCLAD? I'm very

impressed by the number and distribution of ARA groups. How are you all structured?

I am also going to order your book, White Lies White Power, to further educate myself on racism. We work in loose alliance here with the Rural Organizing Project (which started out to defend gays and lesbians in rural areas of Oregon and has since expanded to focus on civil rights organizing in rural areas in general). I've been working a bit with Zapatista supporters. Another significant development is Aguascalientes Dialogues in Oregon, embracing the northwest Hispanic community, migrant farmworkers, tree planters, Hispanic activists resisting racist police brutality, etc. It's a positive example of cross-culture, crossmovement alliance building.

My name is Ali Khalid Abdullah. I am a New Afrikan (Black) man currently incarcerated with the Michigan Department of Corrections (MDOC) for taking strategic actions for my political/social beliefs. I am an anarchist who believes in selfautonomy, end of government or state rule and dominance over the people.

I've been incarcerated within Michigan's death-kkkamps for the past 10 years and during this time I've continued to struggle for the people by politicizing unpoliticized prisoners; exposing the abuses of prison administrators and guards; and developing a

prisoner-oriented political organization called Political Prisoners of War Coalition (PPWC). This is a non-sectarian organization dedicated to changing the existing government and its politics by and through reeducation and other meaningful acts that meet the necessary means for change.

I and PPWC are supported by and work with the following U.\$. groups: Raze the Walls!, Claustrophobia, Active Transformation, and the ARA. Our European comrades are Huddersfield ABC (Anarchist Black Cross), ABC-Ghent, and the Cruz Negra Anarquista. Our Canadian comrades include Moncton ABC. We also work with independent individuals as well as Marxist-Leninist, Maoist and other revolutionary groups by maximizing our common purposes and goals and minimizing the differences we may have in theory, philosophy, ideology or the methodological approaches we might choose to use in order to effect change.

I forward this letter in hopes of networking and developing revolutionary dialogue in ways that could strengthen our solidarity in order to move us forcefully against oppression, repression, racism, sexism, homophobia, kapitalism, imperialism, kolonialism, nazism, fascism, and other parasitic sociopolitical ills. ### Amnesty Campaign for Political Prisoners and P.O.W.'s

On the 50th anniversary of the adoption of the Universal Declaration of Human Rights, there is a grave on-going violation of human rights, right here in the U.S.A. — the continued imprisonment, often under particularly repressive conditions, of more than 100 political prisoners and P.O.W.'s. These are prisoners inside state and federal "correctional" institutions for their political beliefs and practices in the struggle for liberation — members of the Black Panther Party, such as Dr. Mutulu Shakur and Mumia Abu-Jamal; members of the MOVE organization such as Janine Phillips Africa and Charles Simmons Africa; Puerto Rican independentistas like Alicia and Ida Luz Rodriguez and Carlos Alberto Torres; American Indian Movement warriors like Leonard Peltier; white anti-imperialists like Linda Evans and David Gilbert. Not to mention political exiles like Assata Shakur, living in asylum in Cuba, who describes herself as a 20th Century fugitive slave, and who has been the target of a recent vicious campaign led by New Jersey Gov. Christie Whitman, that recently resulted in a near-unanimous Congressional resolution defying international treaties and calling on the Cuban government to return Assata to the US for incarceration.

These freedom fighters have been locked down — some for more than two decades — because of their effectiveness in mobilizing our communities for self-determination. In part because of their continued incarceration, the government has been able to carry out such measures as the destruction of social services, the transfer of funding from schools to prisons, continued police brutality, and mass incarceration. We need these brothers and sisters beside us on the streets, as we near the 21st Century, to help advance our struggles for freedom and justice. These self-sacrificing individuals continue to organize behind prison walls — their courageous and uncompromising resistance calls out for our best efforts to free them now!



# CIA and DRUGS: HIGH NOON

The San Jose Mercury News reported in November that hearings on Volume II of the CIA Inspector General's report on Contra drug trafficking will take place sometime in January in the House Permanent Select Committee on Intelligence (HPSCI). This volume offers the CIA's own admissions that it knew its operatives were involved in dealing cocaine and that the only action it took based on that knowledge was to cover it up. CIA admits it went to great lengths to exempt the Contras, and others who work for it, from requirements to report drug dealing to the Justice Department. Despite these confessions, the pending hearings, The Mercury News says, are Congress's "final look" at the issue. With those hearings, every issue raised will be laid to rest. There will be no more chances in our lifetimes. On the issue of the CIA's complicity in importing drugs into the U.S., it is high noon.

"High Noon" is the classic western film about honor and conformity, fear and courage. Gary Cooper plays a marshal who faces a murderous gang of killers by himself while a town, paralyzed by fear, does nothing to help. Cooper's character risks his life and love and does what a higher moral compass requires of him. The spineless town, which had hired him to do for them what they would not do for themselves, vacillates, cringes and waffles. Cooper, terrified and abandoned, faces the gunmen alone. At the end of the movie the killers are dead but there is no resolution. The only thing that remains is an empty street awaiting the next group of bandits. Cooper has left in disgust, happily for him, with his wife played by Grace Kelly by his side, his badge lying in the dust. There is nothing there worthy of sacrifice.

I have a modest proposal to make. I believe it is attainable. On July 4, 2000, I propose unified and simultaneous marches to decolonize and democratize America. Each could be at least one million strong, in at least five cities, let's say Washington DC or Atlanta GA; NY or Boston; Chicago or Detroit; Portland or Seattle; and San Francisco or Los Angeles. Perhaps Houston or Dallas as well. Call it a Poor People's Campaign to Change the Face of America.

These demonstrations would be designed to unify the social forces with an interest in liberation and social transformation around a program of decolonization and direct democracy. They would be designed to educate and

I propose five banners around which our forces can unify, not a laundry list but a coherence and cohesion of the claims of justice and liberation, of peace and end to empire.

Since I first began to circulate this proposal, I have received a great deal of individual input, including proposals to strengthen the component of militant action at the demonstrations themselves, the idea of holding the rallies in smaller cities where the size of the demonstrations themselves would bring business as usual to a halt, organizational involvement or and particular suggestions about how to sharpen up the program and its components.

# Humanitarian Victory over INS Brutality: Rony Vasquez Beating Case Ends in Plea-Bargain

On Wednesday, December 9, 1998, Rony Eduardo Vasquez, a victim of a beating administered by INS agents unexpectedly pleaded guilty to one of the charges against him, avoiding a trial and agreeing to a two-year sentence which, by now, has mostly been served. The federal government has now been spared the prospect of being accused of brutality and witness intimidation in open court. Members of the Los Angeles Catholic Worker Community were present for the plea-bargain hearing on Wednesday

morning. Rony Vasquez, the defendant, recognized them as supporters and smiled and waved. Jeff Dietrich, a member of the Community, later commented, "How could anyone believe that skinny little guy assaulted those four six-foot-tall officers? It's ridiculous!" Perhaps the prosecution was, in the end, happy to agree to such a lenient plea-bargain because jurors would have asked themselves the same question.

### HISTORY OF THE CASE

On October 7 of last year, about two dozen residents of an apartment building at 401 S. Kenmore in Los Angeles witnessed four INS agents — whose identity as government agents was not obvious — beating the 27-year-old Vasquez, an undocumented Honduran immigrant. Eyewitnesses said that the beating continued when he was already handcuffed and helpless.

arrested Maura Gomez and Esperanza Rodriguez, who had protested the brutal beating and dialed 911, calling police to the scene. Both women, each of them single mothers, were separated from their young children and imprisoned for a week, and were later subjected to deportation proceedings.

willing to come forward. Vasquez himself was charged with assaulting INS Officer Javier Olmos, one of his attackers, and has been held in federal detention without adequate medical treatment until the present day. Even though Vasquez agreed to plead guilty to something he hadn't done, this result represents a kind of victory on purely humanitarian grounds.

Originally, the prosecuting U.S. attorney, Dan Saunders, had vindictively sought to prosecute Vasquez on four charges, including escape, illegal re-entry into the country and another count of assault, against INS Officer Adam Green, which was added more than a year after the original arraignment. If he had been convicted of the combined total of the charges, Vasquez could have received more than ten to his formal sentencing on March 8 of next year, it is years in prison. (The illegal re-entry charge alone theoretically possible that Judge King may disregard carried a mandatory minimum sentence of at least 92 months; that's almost eight years!) When he had previously discussed a plea bargain, Saunders had only been willing to cut the total to seven or eight For that reason, we call on all people who love justice years. Understandably, Vasquez had rejected all previous plea-bargain proposals.

By pleading guilty to only one count of assault, against officer Olmos, Vasquez has managed to secure for himself a potential sentence of only 24 months, or two years. Vasquez has already been incarcerated for most of that time; therefore, if he is given credit for time served, he will be free (and immediately deported to Honduras) by July 1999 at the latest.

Rony Vasquez will be free before his thirtieth birthday. He will be able to celebrate the millennium in Honduras with his family.

The drawbacks to this plea-bargain arrangement are Hondurans expires, whichever comes later. We must that Vasquez will presumably no longer have legal standing to sue the U.S. government for the injuries he suffered. Also, there will now no longer be an opportunity to make the government squirm in court in the face of overwhelming evidence of brutality and abusive practices.

Did Vasquez agree to the plea-bargain because of At the direction of the INS agents, L.A. police officers some new strategy or evidence on the prosecutor's part, which would have put him in greater jeopardy if the case had gone to trial? Or (which is more likely) did the prosecutor Saunders cave in at the last minute on the sentencing issue, because he wanted to avoid a public spectacle that would have seriously impeached government practices?

### REMAINING DANGERS

There is still an additional danger for Vasquez. Judge King said at the December 9 hearing that the sentence wasn't guaranteed, and that he would have to "analyze" the situation. Therefore, when Vasquez goes the plea-bargain and sentence him to ten years for that single assault charge.

and fair play to write letters to the judge, telling him that Rony Vasquez and his family have already suffered enough, and asking him to stick to the 24-month sentence already agreed upon by the government and the defendant.

There is also the situation of Rony's two witnesses to consider. Maura Gomez and Esperanza Rodriguez are both living under orders to leave the country. Rodriguez is appealing the decision in her case, but Gomez will have to take her two small U.S.-citizen children back to the disaster zone of her native Honduras, either as soon as the Vasquez case formally concludes or as soon as the hold on deportations of

# Spit and Dan: Martyrs of Anti-Racist Resistance

Over the Fourth of July weekend of 1998, Lin "Spit" Newborn and Dan Shersty, two anti-racist skinheads with ARA-Las Vegas, were shot dead execution style. Spit, who was Black, and Dan, who was white, were united in death as they had been in life. Their bodies were found not far apart in the desert outside Vegas, in an area known to be used by neo-nazis and racist para-militaries for weapons practice. Anti-Racist Action (ARA) charged that they were ambushed and murdered by nazi boneheads who had been harassing and attacking anti-racists and people of color in Las Vegas for months.

These charges proved out when Las Vegas police charged nazi bonehead John Edward Butler, 26, with the killing. Ballistics reports showed that Butler's gun was the murder weapon. Butler is scheduled to go on trial early in 1999. He has apparently named several additional suspects, but no further arrests have been made yet. At least two nazibonehead suspects have fled Las Vegas.

These killings have made clear the deadly seriousness and

have identified two other members of the nazi bonehead scene who have not yet been charged. Witnesses told police they saw Butler and two others driving from the area where Shersty's body was found. The witnesses, according to press reports, wrote down a license plate number, and police traced it to a vehicle belonging to the family of Melissa Jane Hack, 22, of Las Vegas. Police believe Hack -- who was recently involved in a nazi bonehead assault on a Black family, and Joseph Justin, 19, were in the vehicle with Butler. Police have interviewed Hack and Justin.

Based on the sequence of events that led to the killing of Spit and Dan, it is evident that a wider conspiracy was involved. Two young women who had come into Spit's piercing shop on July 3, called them up and set up a double date. Spit, 25, and Dan, 21, set out on their fatal rendezvous into what was apparently a set-up and ambush by nazi boneheads. The boneheads hated Spit for the energy, love of life and humanity he had poured into the youth scene in Las Vegas, standing out as an African American skinhead who promoted the concept of the traditional skins, of racial harmony, in the face of the boneheads' hatred. Dan, a member of the US Air Force, was also targeted for espousing inter-racial solidarity. Spit and Dan, as members of the Las Vegas Unity Skins and Anti-Racist Action, were a threat to the warped teachings of the Christian-

But the struggle is far from over. Police Identity influenced boneheads and to the white supremacy of the system which generates boneheads.

> Love is stronger than hate, but to prevail, love must be organized and mobilized. What are some lessons from the tragedy of Spit and Dan's deaths, and from our efforts to deal with it? First, our strengths as an anti-racist movement cause the nazis (and often the state) to target us for repression. Antiracist activism is creating a pole of attraction among young people around the U.S. and Canada, as well as in Europe. New chapters of ARA are arising in Canada, the U.S., and internationally. ARA Las Vegas in particular has demonstrated the courage of its convictions in the wake of the killings, both in protecting certain individual members from attack with the assistance of the ARA network, and in maintaining a pro-active public presence. The ARA Network is developing and maturing in the face of violence, they will often portray antisuch deadly attacks. Many chapters have come to the assistance of ARA-LV, and people turned out in large numbers from every region to the August 29 march and rally in Las Vegas. ARA is raising funds on behalf of Spit's surviving two-year-old son, left fatherless by the racist murder. See below for how you can donate.

But we also need to recognize certain weaknesses, and use our strengths to overcome them. ARA is a very loosegreat importance of anti-racist activism, but they have not intimidated ARA Las Vegas or the international ARA network. Rather, we have redoubled our efforts, to ensure that Spit and Dan did not die in vain. We keep them alive in our hearts and minds the memory of them as individuals as they were in life, by building and intensifying the antiracist resistance in which they struggled and were martyred.

Hundreds of people in Las Vegas turned out for their funerals, in a show of solidarity, love, and fearlessness in the face of the cowardly murders by the nazis. This was a measure of the esteem in which Spit and Dan were held, because of the example of energy and unity with which they lived their lives. Hundreds more, from ARA chapters around the U.S. and Canada, marched in Las Vegas on August 29. We successfully drew international attention to the case and to the demand for justice for Spit and Dan. It was in response to ARA's campaign and to the prospect of continuing negative coverage on 48 Hours, in the New York Times and other media, that the Las Vegas police finally came up with their arrest.

We need to strengthen the unity and solidarity of the network through concrete national campaigns that can help activists overcome isolation and attract new members and allies. Security is always a concern, but in addition to physical security measures such as training and counter-surveillance awareness, as well as a knowledge of our enemies, we need greater political security.

We cannot rely on the government to protect us. In some cases, the state openly attacks anti-racists, particularly in the context of public confrontations with nazis. Our real security can only come through organizing, sinking roots and building alliances and political support. The August 29 demo in Las Vegas would have been even stronger, for example, if more anti-racists and concerned people outside the ranks of ARA had been drawn in to the rally. This cannot happen overnight in LV or elsewhere. It requires us to spend time building relationships with people organizations outside our scene. It means figuring out how, in a principled way, we can overcome differences we may have with other anti-racists who may not be as committed to direct action as ARA. Remember that we can learn from them, too.

# TOWARDS ENVIRONMENTAL AND SOCIAL JUSTICE CHALLENGING THE GREENING OF HATE

# AND THE DEMEANING OF WOMEN

In the June 1998 issue of Z Magazine, Emanuel Sferios's essay "Population, Immigration and the Environment: Eco-Fascism and the Environmental Movement," explored the recent vote on immigration issues in the country's oldest and most respectable environmental group, the Sierra Club. Ballot Initiative A was placed before the Club's membership this past spring by advocates of antiimmigration groups that argue immigrants are a major cause of environmental problems in the U.S. and that the Sierra Club should back a freeze on immigration. The Sierra Club had been officially neutral on questions of immigration policy, but if the measure had passed, the Club would have become another voice scapegoating immigrants for social and ecological problems in the U.S. A majority of those who voted among the Club's half-million plus members voted against Ballot Initiative A and reaffirmed the group's position of neutrality.

The campaign within the Sierra Club and debate over immigration and environmentalism saw the mobilization of

In his essay, Sferios wrote: "While most environmentalists agree that corporations and government policy play a critical role in the environmental crisis, many still harbor oversimplified notions that population growth ... is nevertheless the main ecological threat." Sferios argues that population control advocates debate in terms of the impact of numbers, but rarely discuss the impact of social institutions and economic classes. "[Although] the wealthy consume far greater resources than the poor, it is not consumers but producers ... which account for the vast majority of environmental degradation," he wrote. He urges us to look at overpopulation not as a cause but as a symptom of the same corporate and government policies that produce environmental degradation and social injustice. Sferios goes on to document the influence of right-wing think tanks and population-environment groups on the broader environmental groups, particularly the Sierra Club.

But this problem is not limited to more and established mainstream organizations like the Sierra Club. The debate about population control, and the popularity of slogans like "Love Your Mother — Don't Become One!" have dramatic effects in the larger social change movement. I would argue that they marginalize white radicals from communities and radicals of color. Given current demographic realities in the U.S. and Europe, debates over

anti-immigrant groups like the Federation for American Immigration Reform (FAIR) and also the building of a grass-roots alliance of environmental and social justice groups led by organizations such as the Political Ecology Group in San Francisco. It underscored the need for radical activists to look critically at the movements they are involved.

I am writing because I frequently hear white environmentalists and social change activists make arguments over alleged over-population that are nearly identical to right wing groups. Some go one step further, and have popularized the slogan "Love Your Mother — Don't Become One." I address this in the light of discussion I often hear in the radical/anarchist movement, asking why our groups and movements are predominantly white and middle class in background, counter-cultural and generally dominated by men. Looking at ideas about 'overpopulation' and the 'Love Your Mother' slogan begins to help us unravel these questions.



population control are in fact about controlling the reproduction of women of color. Advocates of population control frequently use racially-coded and gendered words, phrases, images and slogans. The image of brown bodies crossing borders, "out of control," figure prominently in the white social imagination. The image of undocumented Brown women "illegally and uncontrollably" mothering "alien" children is the backdrop used by not just theoretical, as was shown by society.

There is a long history of such views being put into practice. Through forced or coercive sterilization programs, African American, Mexicana, American Indian and Puerto Rican women have experienced the reality of population control: the invasion of one's body and selfthe physical attack on determination and reproductive freedom. In many communities of color, the struggle for reproductive freedom has centered on ending forced sterilization, which has been understood as a tactic of genocide. The ideological framework of population control has always been the white supremacist 'eugenics' theory. The births of 'undesirables' are to be restricted. People of color, poor people, and others at the bottom of a segregated, class- and race-based social structure were said to be genetically inferior. The currency of such racist arguments in popular discussions is evident in the 'new, scientific racialism' of books such as The Bell Curve.

Eugenicists ultimately believe that a prosperous society must engage in genetic 'cleansing,' and limit the population control advocates. This is population of 'inferior' segments of

I am not saying that white social change activists or most in the environmental movement consciously subscribe to such tenets of white supremacy. But I do argue that people need to challenge the underlying racist assumptions that shape population control discourses, and to check ourselves out. Angela Y. Davis's essay, "Racism, Birth Control and Reproductive Rights" provides important insights into sterilization abuse and population control that need to be taken into account in both the environmental and abortion rights movements. The slogan "Love Your Mother — Don't Become One!" is a perfect example of how and why anarchist and radical white folks have alienated people of color, poor folks, and those of us who are either mothers ourselves or comrades of mothers.

A challenge to the white nuclear family of middle class America may appeal to a youthful counter-culture, but it should not extend to motherhood generally. To begin with, families in different social groups have different histories and should be analyzed differently. Bonnie Thornton Hill's essay "Fictive Kin, Paper Sons and Compadrazgo: Women of Color and the Struggle for Family Survival" lays out a basic framework for incorporating realities of race, gender class oppression into and understandings about families. When activists uncritically universalize white middle class experience, white supremacy is reinforced, and everyone

who does not fit that supposed 'norm,' marginal and discounted. I want to highlight here a few resources that activists must read to begin to deal more backgrounds have assumed leadership successful with such issues.

Women, and mothers in particular, have been at the center of struggles for social change, and will continue to be. As Black feminist Cheryl Townsend Gilkes put it, "If it wasn't for the women, racially-oppressed communities would not have the institutions, organizations, strategies and ethics that enable the group not only to survive or maintain itself as an integral whole, but also to develop in an alien, hostile, oppressive situation and to challenge it."How alienating is a slogan that creates a contradiction between being a mother and being socially or environmentally "conscious."

In fact, feminist writers have been exploring the relationship of activism to women's lives and have found that many women come to activism through the experience of being mothers. In the book Community Activism and Feminist Politics: Organizing Across Race, Class and Gender, Celene Krauss has an essay, "Challenging Power: Toxic Waste Protests and the Politicization of White, Working Class Women," which examines this. She writes, "Toxic waste disposal has been a central rocus of women's grassroots environmental activism...Women identify the toxic

### **SOLE SURVIVOR OF MODERN-DAY SLAVE REDELLION** RUCHELL MAGEE FIGHTS ON AGAINST JUDICIAL CORRUPTION

As you read these words, another parole hearing will have by now come and gone for Ruchell Cinque Magee, sole survivor of the August 7, 1970 Marin County Courthouse Rebellion. The results are not yet available, but there is little doubt of the outcome. This is his tenth hearing since 1980. Magee himself has refused for the past 13 years to recognize the jurisdiction of the Board of Prison Terms.

"You'll just have to continue to talk to yourself," he told the board members ten minutes into the April 1985 affair, "because I'm not concerned about your hearing...Thank you very much for your hospitality and greens and cornbread. I'm ready to go."

The intentions of the State of California have never been

other than to keep Ruchell behind the walls of its most notoriously brutal prisons (presently, Pelican Bay) the rest of his life. Their hearings have been a charade, and the only apparent reason for holding them as often as they do is to continue to inflame opinion against Magee. To this end they have allowed the discredited testimony of former Judge Gary Thomas to be introduced continually despite the fact that juries in all trials involving said testimony have repudiated it. They have left unchallenged libelous newspaper articles such as "Convicted Murderer Denied Parole Again" (5/21/92), fully aware that Magee was convicted only of kidnapping (PC 209) in 1975, and that even that conviction was unconstitutionally elicited after a "mistrial" was declared in 1973 despite a unanimous jury conclusion of "not guilty of PC 209."

Magee has succinctly stated his present dispute with the BPT: "The Board do not have jurisdiction in this case to parole me, because I am 20 years overdue for release. The Board violated its own law by failure to set time before July 1, 1978...in accord with (California legislation) SB-42. Hundreds of prisoners was released under SB-42 before July 1, 1978. The Board released who it wanted and kept who it wanted."

He has now served 22 years for a crime whose parameters were set by said legislation at 13 years. He has been labeled a "public interest case" and successfully portrayed as equivalent to notorious criminals such as Charles Manson and Sirhan Sirhan

the result of criminally fraudulent trials, and that he was thus held illegally and had every right to resist his incarceration.

It is apparent that, as in numerous other miscarriages of justice, the only solution to Magee's dilemma is either money or publicity. The Ruchell Magee Defense Fund has been seeking for over two years to elicit media attention with little success. It has been even more difficult to fund competent legal assistance for Magee. Without a concerted effort involving either large numbers of people or key media

# Countering the church, the state and the racist right Fight Back Against Anti-Abortion Terror

Over fifteen years ago, the John Brown Anti-Klan Committee in Los Angeles uncovered and exposed links between organized white supremacists and anti-abortion violence. In the early '80's, JBAKC disclosed the involvement of former Florida panhandle Klan leader John Burt in anti-abortion violence, as two young couples in his 'ministry' were among the first in the country to bomb women's clinic that provided abortion services. It drew attention to an ominous murder and the abduction of two women from an L.A. feminist women's health clinic that was carried out by a recently released member of the prison-based Aryan Brotherhood, who was then killed in a shoot-out with the LAPD. JBAKC recorded and transcribed telephone hate-line messages from "Aryan" leader Tom Metzger denouncing abortion as 'white genocide' carried out by what he characterized as 'lesbian nurses and Jewish doctors.' Now, after more than a decade and a half of unrelenting violence and more and more open connections between racist groups and anti-abortion violence, even the mainstream media and law enforcement agencies are acknowledging the undeniable connection.

A recent NY Times piece on anti-abortion-militia links reported a statement by Dallas Blanchard, chairman of the University of West Florida's sociology department, who has written on the subject. "Militia types have shown more and more interest in the abortion issue, while the anti-abortionists are becoming more and more militant and allying themselves with the militia movement," he said. The Times reported that law enforcement officials and researchers see the overlap most clearly in the case of Eric Rudolph, accused of bombings at the 1996 Olympics, a gay bar and an abortion clinic near Atlanta, and of a Birmingham clinic in which an off-duty policeman acting as a guard was killed. Rudolph disappeared into the North Carolina woods, and has since evaded a large-scale manhunt, indicating that he has probably received help from a network of supporters connected to the white supremacist milieu from which he emerged to carry out his bombings. "Eric Rudolph personifies the convergence of these issues," Frederick Clarkson, author of a study for the Southern Poverty Law Center on the ties between the anti-abortion fringe and the militias, told the Times.

Before the Dr. David Gunn was killed in The Voice article lists others who embraced the Army of God name. In 1983, Joseph Grace, who burned down a Virginia clinic, told authorities that he was an Army of God member. The Army of God sent a threatening letter to Supreme Court Justice Harry Blackmun, who wrote the 1973 Roe v. Wade decision legalizing abortion, in 1984. John Brockhoeft, a 37-year-old postal worker who firebombed two Ohio clinics in 1985 and later worked closely with John Burt (the ex-Florida Klansman) and Shelley Shannon (who fired shots at George Tiller) claimed to be a colonel in the Army of God. 

Encouraging his readers to get a copy of this military manual, Bray insists that "the very presence of sniper-minded people serves to instill fear in those who take it upon themselves to slaughter babies." "Why did that [fax] have to come from NAF instead of law enforcement?" asks an official of the NAF. "That is emblematic of what our frustration is. If we were doing some other kind of work that did not have this political stigma around it, then we wouldn't even have to be doing the work of law enforcement." But this is exactly the point. Abortion providers and defenders of women's rights cannot rely on the state. Despite the formal legalization of abortion, the state has done little or nothing to protect women's real life right to choose. The women's movement must embrace the strategy of direct action, learning methods of self- and communitydefense, learning methods of selfexamination and menstrual extraction and the use of herbal and other medicinal forms of contraception and abortion. # **TEAR DOWN THE PRISON WALLS!**

California Governor Pete Wilson and President Bill Clinton have managed to accomplish something that has eluded movement organizers since the days of the Soledad Brothers in California and the Attica uprising in New York — making prison issues into the top concern of a mass movement. They did this through the simple and direct method of mass imprisonment.

Clinton rode into the presidency on the pledge of 100,000 new street cops. During his tenure, he has overseen a massive increase in federal prison populations, the scrapping of centuries-old habeus corpus protections for prisoners, the extension of "mandatory minimum" sentencing and the maintenance of a racist 100-1

In September 1998 in Berkeley, Byrd describes U.N.I.O.N. as follows:

organizers hoping for 5-800 attendees at the Critical Resistance conference, were over-joyed and a bit overwhelmed when upward of 3,000 people showed up. In L.A. on October 22<sup>nd</sup>, the protest to end police brutality, repression and the criminalization of a generation drew over 1000 marchers at its height. Close to 500 people gathered outside Corcoran State Prison on October 17th denounce the impunity of prison authorities for the killings, shootings, beatings, gladiator contests, and rape set-ups that have been taking place at the prison. On the federal level, prison rebellions shook dozens of federal lockups after Congress refused to reduce mandatory minimums or reduce the sentencing discrepancies for drugs that have filled the prisons with non-violent drug offenders. We abhor the brutality practiced in California prisons. We prefer to attack crime through economy for everyone, prevention through education, free after school activities, adult supervision of youth, support of teenrehabilitation of mothers. incarcerated criminals, medical care for the mentally-ill, restorative justice and other programs clearly proven to be more of a solution to crime than prisons. We believe this can be done through the political processes established in our democracy: by the power of the vote, by letter- writing and by demonstrating."

We did not let this happen without a fierce struggle whose epicenter was the International Hotel. There thousands rallied to stop sheriff's deputies and police intent on evicting elderly Filipino residents. After a nine-year mobilization, the hotel fell; as did Manilatown, South of Market, and the once Japanese, later Black Fillmore neighborhood. The damage done hit Blacks especially hard. However, the movements momentum propelled later victories such as rent control, and created a large non-profit housing network. A sensibility survived that San Franciscans did not have to simply bow to whims of developers, politicians and landlords.

HOPE VI claimed to offer a way forward from a public housing system that has been critiqued as little more than ugly, crime-ridden warehousing for the urban poor. Millions of dollars of federal money are pumped into local housing authorities, who in turn tout radical improvements and self-sufficiency based on 'economic uplift' opportunities they fund. Thus far, the reality has been using the program to clear prime real estate of poor people who stand in the way of maximum profits. It may also be the harbinger of the privatization of public housing.

The gigantic McCormack Baron Development Corporation, for example, was awarded the Hayes Valley contract and will reap at least \$32.7 million in tax credits alone. On top of that, the company's deal with the city housing authority (SFHA) to administer the demolition, rehabilitation and later operation of the development will net the company \$34 million. According to Bee Harper, a resident organizer at North Beach Public Housing, the funding beyond demolition is unclear. "They are worried that HUD won't give enough money to rebuild so they will have to go with outside funding. No one knows who will fund the project and what their intentions are.'

This same pattern is being played out around the country. In Atlanta, HOPE VI tore down the Techwood Homes to make room for the Olympic Village. In Chicago, demolitions of Cabrini Green housing has recently proceeded after a court battle and massive tenant protest movement. In San Francisco, public housing 'attrition' has been taking place in stages. Residents are removed, often accepting Section 8 vouchers and moving out of the city. When buildings are rebuilt, there are fewer units constructed. Eligibility requirements

severely restrict who can return. In addition, only a third of the units are offered to low income families. In the case of the Bernal Dwellings, funding difficulties have prevented any reconstruction, leaving four acres of mud.

Self-organizing tenants have received community support from the Eviction Defense Network and The Mission Agenda. Organizers from those groups have been repeatedly detained by security forces and branded 'outside agitators' by SFHA executive director Ronnie Davis. Tenant organizers Malik Rahim and Jeff Branner were arrested on trumped-up charges of breaking in to a tenant association room. One TV station ran a three-part hit piece on them, distorting Branner's part drug convictions and Rahim's conflict with the police while a member of the Black Panther Party.

Despite the repression, tenants have consistently and effectively challenged the SFHA. At North Beach Public Housing, residents unseated a Tenants' Council perceived as a rubber-stamp for demolition. SFHA was forced to make concessions to a 10-point plan which guarantees no displacement. Tenants of all nationalities at North Beach forced the agency into non-compliance with a HUD rule which requires the eviction of undocumented tenants. The tenants are seeking resident control over the 'economic uplift' funds, and cooperative ownership and management of the renewed development.

A similar struggle is developing in Valencia Gardens. In 1997, the SFHA announced plans to renovate the project in partnership with the non-profit Mission Housing and Development Corporation. An impressive list of noA generation later, the city is facing an even more acute housing crisis, though to utter the words 'urban removal' or 'gentrification' is to be branded a doom-sayer in the rainbow kingdom of Mayor Willie Brown.

With a one-percent vacancy rate, this crisis affects all renters, even with 'middle-class' incomes. But the hardest hit are again the city's poorest — public housing residents, predominantly Black. The ironically named federal housing program, HOPE VI, has come forward with a solution worse than the problem, demolishing hundreds of public housing units in San Francisco. The body count so far: three public housing projects down, two more facing an uncertain future; hundreds of tenants have been displaced and the Black population has been reduced to 9%.



displacement promises were made; yet many tenants remained worried, pointing out no concrete plans to fulfill the promises exist. Their skepticism has proven warranted. In 1998, SFHA dropped the MHCD and opted to form its own non-profit.

After Willie Brown was quoted in the SF Chronicle referring to Valencia Gardens as a demolition, rather than a renovation, resident Vernell Guthrie exclaimed, "I was shocked! I heard nothing about demolition until I read it in the paper!" Brown now claims he was misquoted, but Ms. Guthrie began a campaign to unseat the Residency Council and replace it with one running on a slate skeptical of HOPE VI.

Those who have lived through previous decades of neighborhood destruction see this HOPE VI as part of a continuing effort to remake the city to suit a corporate agenda. San Francisco is earmarked for 'multi-media gulch' in tandem with Silicon Valley to its south, attracting well-paid computer programmers from around the world to work — and live — here. We're building not one but two sports stadiums, and attracting a high tech bio-



There's no room on that agenda for poor people, especially of color, who can't compete with the new urban professional. The 'progressive' city government is complicit with this plan to allow the corporations to obliterate what's left of working class life in the city. But tenant resistance is the wild card. No attempt at removal has ever gone forward without resistance.

Crazed Arabs running amok, and blowing up every bus, schoolroom, and bank lobby in sight as they mow down America's cities.

No longer will there be a head to this vicious monster. No, this is the new terrorism alluded to by Madeleine Albright in her remarks after the U.S. bombed a pharmaceutical plant in the Sudan. Each of the cells operates on its own, no direction from the top is needed. This is a mindless monster without a head. And since the religion of these violent people teaches them to kill innocent Americans indiscriminately well, hell, there will

This movie only adds to the ongoing, one-sided portrayal of the "situation in the Middle East."
