nia Pro Life Council to all candidates in the June Primary Election, also on candidates voting records, public statements, and interviews. ONLY THE MOST SIGNIFICANT RACES ARE INCLUDED.

Minor party candidates are not listed because most are unopposed for their respective party's nomination. Almost all American Independent Party candidates support an anti-abortion amendment to the U.S. Constitution.
