Subject: 1983 Opening Fall Enrollment

Opening Fall Enrollment Reports from the CSU campuses indicate an increase of 927 full-time equivalent students, or 0.4 percent, from Fall 1982. When these data are converted to annual academic year full-time equivalent students, the CSU is 977 above budgeted FTES. The total enrollment (headcount) was 314,220, a decline of 1,594, or 0.5 percent, from Fall 1982. Conclusions based solely on the contrast between systemwide totals for FTES and headcount should be avoided since patterns vary among compuses.

The increase in full-time equivalent students is largely attributable to an increase in average student workload from 11.45 units in Fall 1982 to 11.56 units in Fall 1983. Increased workload was reported to all class levels.

Reports indicate that the campuses with demonstrated ability to grow have been inhibited by physical capacity limits, which are facility limitations. Some campuses without capacity limitations have shown a decrease in enrollment which others have noted marginal growth.

Six campuses report that they were unable to accommodate all students who applied between November 1, 1982 and May 31, 1983 because of closed programs. Five of these campuses had fewer students in Fall 1983, than Fall 1982, and all six campuses were above their budgeted full-time equivalent students. Data on applications for admission that were received between November 1, 1982 and May 31, 1983

show that at least 2,200 students could not be accommodated at campuses because of campus facility limitations or closed programs. Thus, the decline in total number of enrollments is essentially one of management. The CSU could have enrolled more students if campuses were not limited by campus capacity limitations.

Nine campuses have submitted enrollment reports in detail (ERSS). A preliminary review of these reports indicates:

1. Lower division enrollments are down, as anticipated, from Fall 1982.
2. Upper division enrollments are up slightly more than anticipated.
3. Total undergraduate enrollments are up slightly more than expected.
4. Post-baccalaureate and graduate enrollments are down more sharply.
5. Average unit load is up at 14 campuses and at all levels, lower division through graduate.
6. The continuation rate of undergraduate students has remained at about the same level as reported a year ago.
7. Enrollments by fee categories indicate: (a) less than six units, no significant change; (b) six units, a sharp decline; (c) more than six but less than twelve, some decline, and (d) twelve or more units, a sharp increase.
