1. New Senate officers for 2013-14 academic year

2. New registration process

The Chair has opened a discussion board on Moodle re: new system implemented for fall 2013 registration. Faculty are asked to post comments/feedback there.

3. Course evaluations

If you would like to see student evaluations immediately, Darian will let you view and photocopy your class report. It's not very user friendly, but student comments will be included. Over the summer, Darian will enter all the data, which will generate a more readable report.

Concerns expressed regarding a=disagree and e (last choice) = agree. Students will switch these if not paying attention.

4. The Talloires Declaration of Environmental Sustainability

The President says statement of belief is important, but full commitment to the other environmental declaration is not economically feasible due to our small size.

Comment: Signing Talloire is more than statement of belief, as it involves creating a committee and programs to integrate environmental education into curriculum. It does include action items.

Chair: A discussion board has been posted on Moodle. If you feel strongly about supporting either declaration, post comments there. The President will like to move on Talloire.

5. Cadet grooming standards update

Provost: Steve Kreta will be working with Commandant's office on redesign of Leadership program over summer. The Provost suggests we postpone discussion/action to after the summer.

\* student to class.

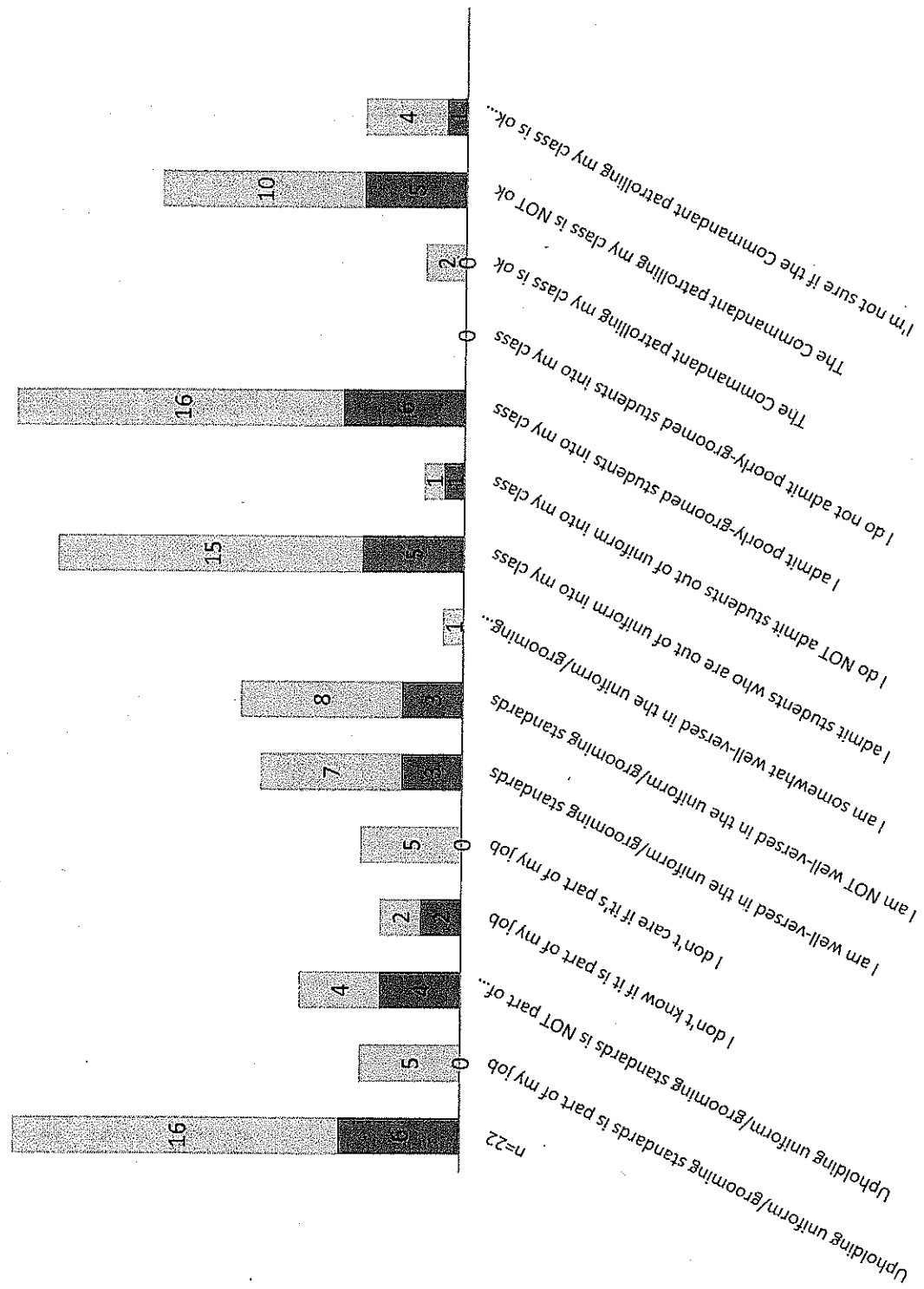
\* 20/24 faculty don't think (15) or are not sure
