Assemblyman Charles Warren of Los Angeles (D-56th District), chairman of the selection committee of the California Democratic Presidential Delegation Committee headed by Attorney General Thomas C. Lynch, today announced that his selection committee will meet this weekend in Los Angeles to select the state's membership to represent California at the 1968 Democratic National Convention.

Warren, who is also chairman of the Democratic State Central Committee of California, stated that the group will meet in closed sessions on Saturday and Sunday, February 17 and 18 at the Airport Marina Hotel, 8601 Lincoln Boulevard, Los Angeles, California 90045, to select the 172-member delegation.

Announcement of the individuals on the delegation will be made, Warren said, as soon as their participation has been confirmed.

One hundred and seventy-four delegates will be chosen for the slate, including the two ex-officio members -- national committeeman and national committeewoman. This delegation will be organized during the weekend meeting and will be selected on the broadest possible base to best represent all Californians, Warren stated.
