

Emergency drill shakes things up

The following information is very important in case an earthquake or catastrophic event occurs.

An Emergency Services Coordinator is assigned to each Village. Find out who that person is and have that person's phone number, the Safety & Security Services Department phone number, and your neighbor's phone number handy in the event you require assistance during a disaster.

After a disaster has subsided and you find that you DO NOT require assistance, DO place a "flag" on or near your garage door or carport where it can be seen from the street. This act will save time and effort that can be utilized in helping the injured.

After a disaster has subsided, and in case you know that a neighbor is not at home, DO place a white cloth/flag on

that home. This will save needless searching by Search & Rescue.

In the event you DO require assistance, DO NOT place a cloth/flag out. No flag

The City of Camarillo is making available to the residents of Leisure Village an expanded transit schedule for bus and taxi service from Leisure Village to Oxnard, Ventura, Thousand Oaks and San Fernando Valley on 14 fixed routes with inexpensive cash fares, free transfers and discounted multiple-ride tickets and monthly passes. Service is available 7 days a week on most routes. You will also be informed of the availability of taxi service 24 hours a day 7 days a week

a day, 7 days a week.

Beware phone scam

Don't ever dial area code

You might receive a message on your answering machine or your pager, which asks you to call a number beginning with area code 809. The reason you're asked to call varies. It can be to receive information about a family member who has been ill, to tell you someone has been arrested or died, to let you know you have won a wonderful prize, etc. In each case you are told to call the 809 number right away. Since there are so many new area codes these days, people unknowingly return these calls. If you call from the U.S., an exorbitant amount will appear on your bill. Or, you'll get a long recorded message. The point is, they will try to keep you on the phone as long as possible to increase the charges. Unfortunately, when you get your phone bill, you'll often be charged more than \$24,100.00.

The 809 area code is located in the British Virgin Islands (the Bahamas). The 809 area code can be used as a "payper-call" line number, similar to 900 numbers in the U.S. Since 809 is not in the U.S., it is not covered by U.S. regulations of 900 numbers, which require that you be notified and warned of charges and

Therefore, after considerable thought of the matter, I am resigning from the Architectural Committee.

Please use this letter as my Resignation, effect immediately.

My letter of resignation to the Board reads as follows:

"I am hereby resigning my offices as Director and Treasurer of Leisure Village Association, Inc., effective immediately. I find that my basic core values, goals and objectives are significantly at variance with those of the Board members and that I cannot discharge my fiduciary duties to the homeowners and the Board of Directors as I fully intended upon election to the Board.

"The split in the Board has deepened to 1-4 on practically every material issue, leaving the majority of the homeowners without an effective voice to represent them."

The "harmony" sought by the Board of Directors unfortunately meant to them "conformity" and "blind allegiance" to the majority of Board members.

My views when put into a motion were invariably turned down (one without a second).

My hopes to have a closer relationship between the Board and the advisory committees to focus on problems needing solution resulted in the termination of the chairman of the Architectural Review Committee and perhaps more members; the resignation of the chairman and at least one member of the Purchase Research Committee; resignation of one member of the Engineering Committee; and in the last fiscal year, a wholesale resignation of the Insurance Committee. What is going on?

With this turn of events and the inability to have a voice on the Board, I resolved to sever my membership on the Board.

I feel I will be more effective on behalf of the Villagers through this medium.

Yet he couldn't even get his motions seconded so that a discussion could take place on matters that he felt were significant. So, after a few short months, he resigned. It seems that a lot of volunteers are resigning or getting the ax. What happened to the harmony that Carol Sweeney, Larry Coleman and Ben Miller promised when they ran for the Board? Does harmony mean ax those who do not agree with the Board?

Remember the song "Trouble in River City?" Well, somebody could write a saga about the trouble in Leisure Village.

Where was the Association Attorney when the amendment was adopted in March defining the Architectural Committee's responsibilities and clarifying the exclusive use rights of homeowners? LVA's attorney said the amendment was to correct problems which have been ongoing for many years, in fact, as long as he has been our attorney. So why didn't he correct the problem in March 2000, or even earlier?

It's not fair for the new board to shift the blame to somebody else. We elect directors to be accountable to the homeowners.

The Architectural Committee Chair, Dan Davis, has volunteered his time and talents to enhance the appearance of Leisure Village, and he has adhered to the specifications that the board has approved throughout the years. So, let's put the blame back where it belongs: on the Association Attorney. We don't need to have more volunteer committee members blamed just for doing their jobs, or resigning because of the unfair

treatment they receive. We should instead applaud committee members for volunteering their efforts in maintaining a community that is beautiful, safe and affordable.

Is this board thinking about the interests of the Village or their own self-interest?

I just heard that Dan Davis has been relieved of his volunteer duties as Chair of the Architectural Committee. Isn't this action a little premature? What if we find that the Board is responsible for the alleged encroachments into the common area? After all, they did approve all specifications. Can we then bring Dan back and dismiss the Board?

It appears to me that the Board is acting irresponsibly in placing blame before all the facts are known to the Homeowners. So in one week's time we have no Architectural Committee Chair and no Treasurer. We need highly qualified people to lead, not yes-people who will go along to get along.

It is the association's loss to lose Dan Davis, who worked countless hours to improve our Village and maintain prop-

erty values.

It is the Association's loss to have a highly respected attorney and accountant, Ken Wechsler, resign after serving only two months on a Board where the wrath of one person rules. Things are getting worse, not better. Speak up and be counted before we lose more valuable people because of four board members who put their own self interests before the interests of the Village.

rates involved when you call a "pay-per-call" number. There is also no requirement that the company provide a time period during which you may terminate the call without being charged.

Further, whereas many U.S. phones have 900 numberblocking to avoid these kinds of charges, 900 number block-ing will not prevent calls to the 809 area code.

We recommend that no matter how you get the message, if you are asked to call a number with an 809 area code that you don't recognize, just disregard the message. It is important to prevent becoming a victim of this scam, since trying to fight the charges afterwards can become a real nightmare. That's because you did actually make the call. If you complain, both your local

Transit ride tokens will be made available to those attending the meeting, and there will be a question and answer period. Because so many of our residents no longer drive (and that number is expected to increase), we expect a good turnout of new and prospective transit users, and we will try to answer all of your questions at the workphone company and your long distance carrier will not want to get involved and will most likely tell you that they are simply providing the billing for the foreign company. You'll end up dealing with a foreign company that argues they have done nothing wrong. While these scams are perpetuated on area code 809, not all 809 calls are scams. 809 is a legitimate area code.

Things are about to get worse, because that infamous offshore area code 809 is in the process of breaking up into smaller chunks, and you'll soon have to think twice about calling any of the following area codes: 242, 246, 264, 268, 284, 345, 441, 473, 664, 758, 767, 784, 787, 868, 869, 876 as well as 809.



Trip to Nevada, **Death Valley** an eye-opener

In early February, the LV Travel Committee conducted a tour appropriately titled "Western Nevada and Death Valley," which was an eye-opening experience for many first-time visitors to the area. About half the group were newcomers.

The first night was spent in Primm, Nevada, after an easy six-hour ride. This resort near the California border caters to gamblers who have tired of Las Vegas and Laughlin. There are also good casinos, sports and a hundredshop outlet mall served by complimentary elevated rail service.

After a big afternoon and night, we headed for Pahrump on Highway 160 through Red Rock Canyon and found that this dot on the map has grown to about 40,000 and boasts of the only winery in Nevada.

Following an escorted tour of the winery, the group was feted at a superb wine-tasting luncheon before proceeding to Death Valley National Park, almost all of which is in California and covers an area as large as Sequoia and Yosemite parks combined. However, the actual Death Valley is a small, narrow portion of the park. After a stop at an overlook viewpoint, we

descended to Badwater, at 282 feet below sea level, the lowest point in the Western Hemisphere.

We tourists can always say we were there, and some even tasted the bad

Furnace Creek, the Park Headquarters, contains the major park community -- ranch, inn, golf course -- and at an elevation of 5 feet, has grass, trees, and flowers during the winter season.

We returned to Nevada for another night of food, easino play and sleep in Beatty before visiting the almost unimaginable architecture, beauty and posh comforts of Scotty's Castle. After our guided tour, Bernice Epstein, our able tour escort and entertainer, herded us onto the bus for an afternoon trip home which included climbing out of the Valley on over-5,000-foot Towne Pass, just a vertical mile higher than Badwater.

Before trying this trip on your own, do some planning. November through April is visitor time. Summer temperatures of 125 degrees are common and put a severe limit on travel and services. During the travel season, however, services are available, and the unusual terrain and scenery along with lows and highs -- make it a visit to remember.




