SCOPE

Issue

What should be the role of State Government, including the Division of Fairs and Expositions in administering and funding district and county fairs?

Background

The Division of Fairs and Expositions in the Department of Food and Approcluture is responsible for apportioning funds to California's 79 district (53), county (24) and citrus fruit (2) fairs and expositions for purposes of fair coverations and capital outlay (Dusiness and Professional Code Section 1962-19629). The 1970-76 Budget has apportioned 37,732,000 (General Fund 313,000) and Fair and Exposition 1963 (37,67),007 or this appropriations to one county fair, two district fairs and the two citrus fruit fairs. In addition to apportioning the funds, the Division provides assistance to fair managers and exhibitions, prepares the Fair Administrative Taimal, and processes approximately 1,500 fair contracts per year.

The Supplemental Report of the John Legislative Budget Countitee regarding the Budget Act of 1975 recommended that "the Department of Finance issue a comprehensive report covering both the performance and fiscal aspects of the district and county fairs, including specific recommendations where applicable regarding the current structure of adminsistration and review."

We will attempt to achieve the objectives outlined on the following pages. However, availability of data, and/or cost or time constraints may preclude achievement of all objectives.

Background

The Division of Fairs and Expositions in the Department of Food and Agriculture is responsible for apportioning funds to California's 79 district (53), county (24) and citrus fruit (2) fairs and expositions for purposes of fair operations and capital outlay (Business and Professional Code Section 19622-19629). The 1975-76 Budget has apportioned \$7,792,000 (General Fund \$113,000 and Fair and Exposition End \$7,679,000) for this use. The Budget has designated \$805,000 of the total fund as special appropriations to one county fair, two district fairs and the two citrus fruit fairs. In addition to apportioning the funds, the Division provides assistance to fair managers and exhibitions, prepares the Fair Administrative Manual, and processes approximately 1,500 fair contracts per year.

The Supplemental Report of the Joint Legislative Budget Committee regarding the Budget Act of 1975 recommended that "the Department of Finance issue a comprehensive report covering both the performance and fiscal aspects of the district and county fairs, including specific recommendations where applicable regarding the current structure of administration and review."
