# STOP THE Texecution!

Texas courts have ordered the death of an innocent man, Ricardo Aldape-Guerra, for the 1982 death of a Houston policeman. Ricardo Aldape-Guerra was just 20 at the time of his conviction and had been in the U.S. only 3 months at the time of his arrest.

Aldape-Guerra, accompanied by Roberto Carrasco-Flores, was detained for questioning by Officer James Harris on July 13, 1982. While questioning one of the 2 men, Harris was shot in the head 3 times with a 9 millimeter pistol and his service revolver taken by his killer. A civilian who stopped at the scene was also killed with the 9 millimeter.

Carrasco-Flores had a serious criminal record of arrests and convictions in both the U.S. and Mexico. Aldape-Guerra has been described by all who know him as a model person. Both men fled the scene and returned separately to the apartment they shared with 2 other men. Arriving first, Carrasco-Flores offered the slain officers' gun to the men saying he had killed Harris. When Aldape-Guerra arrived, both were asked to leave by their frightened friends.

Aldape-Guerra hid in a nearby horse trailer and Carrasco-Flores hid in a darkened garage where he later shot Officer Larry Trepagnier 5 times with the 9 millimeter pistol. Officers returned fire and killed Carrasco-Flores. The 9 millimeter was found at his side and Officer Harris' gun was found stuffed in the belt of Carrasco-Flores. Also found on the body were a 9 mm. ammo clip and numerous 9 mm. shells were found in his pockets. The man who had purchased the 9 mm. for Carrasco-Flores later testified in court that the 9 mm. weapon was that of Carrasco-Flores.

Aldape-Guerra came out of hiding and surrendered. His pistol, a .45, was found nearby. All 3 shootings were done with the 9 mm. and no one was injured or threatened with the gun of Aldape-Guerra.

All physical evidence placed the murder weapon in the hands of Carrasco-Flores yet Aldape-Guerra has been found guilty and sentenced to death for a murder he didn't commit after standing trial before a near all-white jury.

With Carrasco-Flores dead, the state of Texas has claimed that Aldape-Guerra was the gun-man but was unable in court to present any physical evidence linking Aldape-Guerra to the murder weapon. Five witnesses claimed Aldape-Guerra was the gun-man yet none claimed to have seen the actual shot fired. All five gave testimony in conflict with all others. All testimony of the 5 differed in many aspects from the statements the 5 gave police immediately after the killing.

One witness against Aldape-Guerra originally told police she could not identify the killer. Two others originally gave descriptions to police that described Carrasco-Flores as the gun-man, not Aldape-Guerra. They described the gun-man as a blond and Carrasco-Flores was a blond Mexican known as El Guero because of his light complexion.



# THEY BEAT US ALL NOT JUST RODNEY KING

The city is burning, the anger echoes through the living rooms of a nation. We watch as the fire of 500 years of repression begins to consume South Central Los Angeles and neighboring communities. The question is asked. Why? Why are they burning their own communities? Why are they destroying the little they have, Why?

The question is not simple nor is the answer. Rapper "Ice T" asks an easier question in a song called, "Straight up Nigga" he bluntly asks "Does South Central look like Amerika to you?" the Answer is simple "Hell No!" South Central and communities like it are boiling over with anger and disgust, we are tired of the repeated beatings, exhausted with the uncontested Police violence. We are enraged at a Justice system that continues to victimize people of color. We were not surprised with the Rodney King verdict, we were stunned that the justice system would slap us right in the face in front of the entire nation as to say "We know what happened, you know What happened, so what, fuck you!"

Police have done this for years and so has the justice system, everyone who has ever been a victim could only wish for the ultimate witness- a video tape of police in action. Rodney King had a tape, he had it rapped up, this time the police were caught red-handed. This time it wasn't his word against theirs, it was on tape. It was on the same tape that would have him convicted if he were a shoplifter or a bankrobber, it was also on the same tape that would prove he was guilty of provoking an attack. It was the same tape that showed Rodney King repeatedly getting up and threatening a barrage of friendly armed police officers who were only there to serve and protect. But it was not on a tape that showed us what really happened, and the jury told us we were wrong.

# THINGS THAT MAKE YOU GO, HMMM!

What do the "Weed and Seed" program and the Civilian Review Board issue have in common? Both involve the Denver Police Department. The DPD has been lobbying for the "Weed and Seed" money and against the creation of a citizens oversight committee. Let's look at both issues and see if any parallels can be drawn.

Denver was one of the sixteen cities that won a "Weed and Seed" grant from the U. S. Department of Justice. According to the manual,

Department of Justice. According to the manual, federal, state and local law enforcement agencies will coordinate their efforts to "Weed" out the bad and "Seed" in the good in Denver's barrios. The Westside's Baker and La Alma/Lincoln Park and the Eastside's Cole neighborhoods are the first to receive federal attention. Capitol Hill and the Highlands neighborhood are slated to be the next targets.

What is the first thing that comes to mind when thinking about these areas? They are heavily populated with people of color, more specifically youth of color. The first phase is set to begin in July. The program will put two officers into a neighborhood store front along with a paid parttime neighborhood organizer. The officers will each have a new car bought and equipped especially for them, complete with "Weed and Seed" logo. The store fronts will have a number of different agencies working out of them including a Neighborhood Prosecutor, covert narcotics detectives, and Sheriffs to execute immediate evictions, to name a few.

The program will operate using tactics modeled after Project Triggerlock, another Department of Justice initiative that targets offenders for prosecution in federal court to take advantage of tough federal laws. Between April and August 1991, Triggerlock resulted in more than 2,600 arrests and had a 91 percent conviction rate. Some of the enforcement, adjudication, and prosecution strategies will focus on special enforcement operations such as "street sweeps," intensified narcotics investigations, targeted prosecutions, and witness protection.

According to a statement by Attorney General William Barr, "When we throw the federal book at you, it will be a knockout blow. There will be no bail. No probation. No parole. You will be put away in Federal Penitentiary for a long time." Operation "Weed and Seed" will involve the Federal Bureau of Investigation, the Internal Revenue Service, the Immigration and Naturalization Service, the Bureau of Alcohol, Tobacco, and Firearms, the Drug Enforcement Agency, the Colorado Bureau of Investigation, and a wide array of city agencies.

The need for police oversight is not a new idea. Citizens have been trying to get a Civilian Review Board for decades. This recent attempt is the third try in 15 years. Each time the idea has been shot down. The police keep saying that they are the experts. Let them do their job. The problem is not about them doing their job, but who they are doing their job on.

The police are constantly beating or killing people from communities. Black and brown people usually end up black and blue after coming in contact with a badge. Then, if the person has enough courage to file a complaint, the investigation done by the police finds that the ass-kicking was justified. This is where the argument for citizens oversight begins.

The police are sworn into duty and become part of a fraternal brotherhood. It common knowledge that an officer will not testify against a fellow officer for fear of retribution. An officer does not want to be in need of backup and not have any because he has broken the "code of silence." Gay cops have a hard time getting backup, let alone a snitch cop.

A look back in Denver's history will show that for way too long now the police have been literally getting away with murder. Over 90 percent of all investigations of police misconduct and brutality have been found in the officer's favor. Usually the persons who have been wronged by police are Chicano or Black. Coincidence? I don't think so. By creating a board (that citizens can come to without the intimidation of going to the same people who wronged you) that has full power to discipline the cops who have no business on the force, Denver will become a city that has harmony between its citizens and its police. The community needs to come out in large numbers in support of a Civilian Review Board.

With summer bringing on the start of the "Weed and Seed" program, police terrorism is about to hit a fever pitch. The high-profile of the police in the two neighborhoods, coupled with the federal agency activity is going to make for a long hot summer. Police harassment of our youth is going to be increased. A teenager will find it difficult to make it to the recreation center and back home without being the subject of unjust police contact. Who will the community turn to with its complaints? Probably the deaf, dumb, and blind Internal Affairs unit. Does anyone know where I can get some PIG repellant?

#### **TEX-ECUTIONS FROM 1**

All witnesses who identified Aldape-Guerra in court had changed the versions of events from those they originally described in the initial statements they gave police immediately after the killing.

Upon his arrest, Aldape-Guerra gave a voluntary statement to police in which he stated that he had his hands on the car in preparation to being searched by Officer Harris when Carrasco-Flores circled around Harris and shot him, something Aldape-Guerra became aware of when he turned and saw Carrasco-Flores with the drawn weapon. Only the statement of Aldape-Guerra has remained unchanged since the day of the killing.

In the heat of vengeance, law enforcement and prosecutorial authorities pressed foreword and from the time of Aldape-Guerras' arrest to the ordering of his death, only 3 months had elapsed. The state of Texas stands ready to kill an innocent man.

Ricardo Aldape-Guerra may die, not because he killed Harris, but because he was a poor, undocumented Mexican who was poorly represented by court-appointed attorneys and convicted by shaky testimony. The only African American juror, Donna Monroe, later stated "I don't believe Aldape-Guerra was the actual killer."

The fearsome traditions of Texas as they regard the Mexican/Chicano and African American communities cannot be understated. The use of the death penalty falls heaviest on Blacks and Browns in Texas and Texas leads the nation with 51 death penalty executions. Twenty-four of the executed were people of color.

Texas has 352 prisoners awaiting execution; 184 are people of color. It is time to stop the Tex-ecutions.

Justice demands a new trial for Ricardo Aldape-Guerra but his September 24 execution date must first be halted. Write Governor Ann Richards, State Capitol, Room 200, Austin, TX 78711 to demand a stay of execution and a new trial for Ricardo Aldape-Guerra.

## **EPOC Needs You**

EPOColorado, The Equal Protection Campaign, is fighting to a discrimnatory amendment from being added to the state 's constitution. The amendment from being added to the state's Constitution. The amendment would prevent city or county governments from giving civil rights to Colorado citizens based on "sexual orientation.

A group of homophobics calling themselves Coloradans for Family Values (CFV) was successful in collecting enough signatures to put the proposed amendment on the November ballot. The group, whose leaders include Coach Bill McCartney, former Senator Bill Armstrong, and the Rev. Leon Kelly is a well-funded organization with ties to ultra Right-Wing conservatives in California. The amendment would neutralize ordinances in Denver, Boulder and Aspen.

We as oppressed people CANNOT allow the rights of another oppressed people to be taken away. By allowing predjudice and discrimination to be legal against one class, the door opens to allow other groups the opportunity to try to take away civil rights from now protected classes. This amendment would set the civil rights movement 30 years back.

Resolutions have been passed by numerous groups and organizations in support of EPOC. M.E.Ch.A. Central de ColorAztlan, CCD M.E.Ch.A., UCD M.E.Ch.A., Metro M.E.Ch.A. the Colorado Statewide Chicano Students Network, and the Student Government of CCD have all committed to opposing this amendment.



# Racism plagues DPS

A seven-year old Mexicana was called for an after school conference by a teacher at Edison Elementary School last March, causing the girl to miss her bus home. The girl's mother called the school when she realized that the girl wasn't on the bus. The school's assistant principal told her mother that it 's not his responsibility to look for her, and that his wife was picking him up, so he didn't have time to discuss this with her and hung up the phone.

A substitute teacher was accused of fondling a young Chicana at Valverde Elementary School. When the police were contacted to investigate the incident, parents believe that the principal discouraged the investigation. The principal said that a TV show had aired the day before which caused the girl to make up the incident.

Bryant-Webster school parents have alleged that the principal has complained about the bilingual education program, saying that this is America and people should learn to speak English. At Remington Elementary, parents and have accused the principal of racism. They claim that the principal fired the community liaison for conducting a meeting entirely in

Spanish.

The examples go on and on. They are bringing to the fore what many of us have known for a long time: That many Denver Public schools are run by people who do not care about the education of people of color, especially Mexicans and

There aren't any Chicanos or Mexicans on the school board. It is a fact that most school board members--except for two--live in southeast Denver. With this geographic representation, there is no Chicano and Mexican voice to advocate their concerns and needs.

When Evie Dennis was appointed to be head of the Denver Public Schools two years ago, many parents, including Latinos, were optimistic that we would finally have a sympathetic ear. Unfortunately, our hopes have not come true. Dr.. Dennis has done nothing about the complaints brought to her attention by Latino parents.

Under the leadership of Dr. Dennis people of color, including African Americans have had a great deal of difficulties. Highly gifted and talented programs are still mainly white, even where the students are overwhelmingly African American. The schools "push out" rate is almost as high for African Americans as it is for Latinos. It's sad when people of color who become administrators can't effectively deal with racism in schools.

D.P.S. must undergo a radical transformation. The school board must allow representation form grass roots community people. The new districting plan for D.P.S. gives some opportunity for this representation to be elected to the board. But as long as the white power structure threatens to corrupt well-meaning people, parents and community people must continue the pressure for quality education.

A truly radical undertaking for D.P.S. officials would be to practice what they preach: to offer a good education for all children. In the meantime, Latino parents must persevere with their claims of racism in order to bring about change in their children's schools, including the firing of the racist principals who have not only fallen on their duties as educators, but who have allowed children's well-being to be endangered. ¡Ya

As a resident of this planet Earth, I have watched people go through many changes, some negative some positive.



The runners that started in May from Argentina and Anchorage, Tok passed through Minnesota in late June and through Colorado this past week. The 15,000 mile run will stretch the entire Hemisphere.

## CHICANOS AND MEXICANOS? OR POCHOS AND WET-BACKS?

It is estimated there are 424,000 Spanish-surnamed people in this state. The over-whelming number are of Mexican descent, Chicanos or Mexicanos.

An honest commentary would be incomplete if it did not touch upon the community resentment which leads some to call others Mojados or Pochos.

The lack of unity, organization and the existence of bigoted attitudes among people of common descent, only works to the communities detriment.

Economic clout is the represented by these numbers as is potential political power. Yet of 290,000 potential Chicano/Latino voters in 1988 only 75,000 exercised their vote.

The power of American racism has been sufficient to cause Chicanos to forget their history and to develop a self-hatred leading them to call Mexicans 'wetbacks'. Chicanos, in turn, are called 'pochos'.

The ties that bind the community are of historical standing. The 'Southwest' has always has always been linked to Mexico. Mexican immigration to California is marked by large numbers from Baja California, Sinaloa and Jalisco; immigration to Texas comes from Coahuila, Nueva Leon and Tamaulipas; immigration to Arizona from Sonora and immigra-

tion to New Mexico and Colorado from the state of Chihuahua has long been noted. This pattern is true both before and after the American conquest of the 'Southwest' in 1848.

Though some believe Chicanos and Mexicanos are distinct and separate communities with no common interests, it would be well to note that when former-Governor Richard Lamm writes that 'Hispanic' culture places little value on education, he is speaking of us all.

Others, too, see us all the same and bigotry has gone beyond ignorant words written in newspaper columns. Examples are too important to forget yet have to soon been forgotten.

In September 1986, Clyde Savage, an unemployed American worker, felt that "illegal immigrants" were taking jobs away from 'Americans'. He created a disturbance in a bar upon hearing Mexicans speaking Spanish at a nearby table. After being ejected from the bar he returned home for his hunting rifle and killed Ruben Romero.

Ruben Romero was bilingual. His family spoke Spanish and his father, like Ruben, loved horsemanship. Both attended activities of local Mexican charro associations. The family was from a town named Tecolote.

Ruben was only 12 years old when he was shot from ambush while riding a skate-board on a warm September night. He was buried in Tecolate, NEW MEXICO where the family can trace its roots over 300 years.

Perhaps no greater tribute could be paid this young boy than to work for unity to see that such racist tragedy is never again repeated or goes lightly punished. A first step in this direction, though cannot be taken while 'La Raza' divides itself over illusions and divisions represented by the words 'Mojado' and 'Pocho'

## Why AIM opposes Columbus Day and Columbus Day parades

WHEN THE TAINO Indians saved Christopher Columbus from certain death on the fateful morning of October 12,1492 a glorious opportunity presented itself. The cultures of Europe and the Americas could have merged, and the beauty of both races could have flourished.

Unfortunately, what occurred was neither beautiful nor heroic. Just as Columbus could not and did not, "discover" a Hemisphere that was already inhabited by nearly 100 million people, his arrival cannot, and will not, be recignized as a heroic and celebratory event by indigenous peoples.

Unlike the Western tradition, which presumes some absolute concept of objective truth, and, consequently, one "factual" depiction of history, the indigenous view recognizes that there many truths in the world and many legitimate recollections of any given historical event, depending on one's perspective and experiences.

From an indigenous vantage point Columbus' arrival was a disaster from the beginning. Although his own diaries indicated that he was greeted by the Taino Indians with the most generous hospitality he had ever known, he immediately began the enslavement and slaughter of the Indian peoples of the Carribean islands. As the eminent Columbus biographer Samuel Eliot Morison admits in his book, Admiral of the Ocean Sea, Columbus was personally responsible fro the enslavement and murder of indigenous peoples. He was personally responsible for the the design and operation of he encomienda system that tied Indians as slaves to the lands stolen from them by the European invaders.

As detailed in the American Heritage Magazine (October 1975), Columbus personally oversaw the genocide of the Taino Indian Nation of what is now Haiti and the Dominican Republic. Consequently, this murderer, despite his historical notoriety, deserves no recognition or accolades as a hero; he deserves no respect as a visionary; and he is not worthy of a state or national holiday in his honor.

Defenders of Columbus and his holiday argue that indigenous peoples unfairly judge Columbus, a 15th actor, by the moral and legal standards of the late 20th century. Such a defense implies that no moral or legal constraints applied to individuals such as Columbus, or countries, in 1492. As Robert Williams details in his book, The American Indian in Western Legal Thought, not only were there European moral and Legal principles in 1492, but they largely favored the rights of indigenous peoples to be free from unjustified invasion and pillage by Europeans.

Unfortunately, the issue of Columbus and Columbus Day is not easily resolvable with a disposition of Columbus, the man. Columbus day as a national, and international, phenomenon reflects a much larger dynamic that promotes myriad myths and historical lies that have been used to through the ages to dehumanize Indians, justifying the theft of our lands, the attempted destruction of our nations, and the genocide against our people. Since the 15th Century, the myth of Columbus' discovery has been used in the development of laws and policies that reek of

Orwell's doublespeak: theft equals the righteous spread of civilization, genocide is gods deliverance of he wilderness from the savages, and the destruction of Indian societies implies the superiority of European values and institutions over indigenous ones.

Columbus Day is a perpetuation of racist assumptions that the Western Hemisphere was a wasteland cluttered with savages awaiting the the blessings of Western "civilization." Throughout this hemisphere, educational perpetuate these myths--suggesting that indigenous people have contributed nothing to the world, and, consequently, should be grateful for their colonization and their microwave ovens.

As Alfred Crosby, Kirkpatrick Sale, would illustrate in their books, not only was the Western Hemisphere a virtual ecological and health paradise prior to 1492, but the Indians of the Americas for such revolutionary global contributions as the model for U.S. constitutional government, agricultural advances that currently provide 60 percent of the world's daily diet, and hundreds of medical techniques still in use today.

If you find it difficult to believe that Indians had developed highly complex and sophisticated societies, then you have been victimized by an educational and social system that has given you a retarded, distorted view of history. The operation of this view has also enabled every country in this Hemisphere, including the U.S., to continue its destruction of Indian peoples. From the jungles of Brazil to the highlands of Guatemala, from Chaco of Paraguay to the Supreme Court of the United States, Indian people remain in a perpetual state of danger from the systems that Christopher Columbus began in 1492.

Throughout the Americas, Indian people remain at the bottom of every socioeconomic indicator, we are under continuing physical attack, and are afforded the least access to economic, political or legal redress. Despite these constant and unbridled assaults, we refuse to surrender any more of our homeland or to disappear into the romantic sunset.

To dignify Columbus and his legacy with parades, holidays and other celebrations is intolerable to us. As the original peoples this land, we cannot, and will not, countenance social and political festivities that celebrate our genocide. We are embarking on a two-pronged campaign in the quincentary year to confront the continuing racism against Indian people.

First, we are advocating that the divisive Columbus Day holiday should be replaced by a celebration that is much more inclusive and more accurately reflective of the cultural and racial richness of the Americans. Such a holiday will provide respect and acknowledgement to every group of their importance and value of their heritage, and will allow a more honest and accurate portrayal of the evolution of the hemisphere. It will also provide an opportunity for greater understanding and respect as our societies move ahead into the next 500 years. Opponents of this suggestion react as though this proposal is an attack on an ancient, time-honored holiday, but Columbus has been a national holiday only since 1971 -- and 1992, hopefully, we can correct the errors of the past, moving forward in an atmosphere of mutual respect and inclusiveness.

Second, and related to the first, is the advancement of an active, militant campaign to demand that the federal, state and local authorities begin the removal anti-Indian icons throughout the country beggining with Columbus, we are insisting on the removal of statues, street names, public parks, and any other public object that seeks to honor devastators of Indian peoples. We will take an active role in the removal of anti-Indian monuments and Icons, and we will take an active role in the opposition to public displays, parades an celebrations that champion Indian haters. We encourage others, in every community in the land, to educate themselves and to take responsibility for the removal of the anti-Indian vestiges among them.

For people of goodwill, there is no better time for reexamination of the past, and rectification of the historical record for future generations, than the 500th anniversary of Columbus' arrival. There is also no better place for this re-examination than in Colorado, the birth place of the Columbus Day Holiday.
