

A RESOLUTION OF THE COUNCIL OF THE CITY OF OXNARD
STATING THE RESULTS OF THE CANVASS OF ELECTION
RETURNS OF THE GENERAL MUNICIPAL ELECTION HELD ON
APRIL 14, 1970.

WHEREAS, the Council of the City of Oxnard by Resolution 5061, did duly provide for the holding of a general municipal election in the City on April 14, 1970, for the purpose of electing three City Councilmen to terms of four years each, and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner as provided by law, and said election was on the above date held at the polling places designated in said resolution, and the votes cast thereat were canvassed and the returns thereof made at the time and in the manner and form provided by law, and

WHEREAS, on this 21st day of April, 1970, the City Council has duly assembled at its usual place of meeting and pursuant to Elections Code Section 22932.5 has received the report of the City Clerk on the canvass of the returns of said election.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OXNARD DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

1. That said general municipal election was duly held on April 14, 1970, and the votes cast thereat were duly and regularly canvassed and the returns thereof made at the time and in the form and manner required by law.

2. That the absent voter ballots have been duly canvassed and counted as required by law, and the result of such count is hereinafter stated. That this City Council has duly canvassed the returns of said election and from said returns it appears, and this Council finds, that the whole number of votes cast in the City in said election, the names of the persons voted for and for what office each person was voted for, the number of votes cast at said election and for each person, and the total number of votes given in the City to each person are as follows:
